Executive Summary

The research notes in this report expand our knowledge of all the targeted families. Particularly, it provides

- A married-by date for Allen Lavender and wife Agnes/Agatha Witt (29 October 1785), for whom
 no marriage record has been found in either of their known counties of residence (Amherst and
 Bedford).
- Identification of an occupation for Allen Lavender, other than farming: waggoner.
- Proof of parentage for three sons of Richard Tankersley: Obediah, Reuben, and Sam.
- Proof of parentage for three sons of William Walton: George, Tilman, and William Jr.

A rereading of the first one hundred pages of this register for **Bias** and **Witt** entries yielded negative results, suggesting that neither family lived convenient to the Thompson & Teas store. However, the Witt in-law, Richard Luttrell (*var.* Litterall, etc.), does appear herein as a Lavender associate.

Research Notes

Ledger cover:

"Journal to Ledger C: Commencing from the 10th October 1785 By Thompson and Teas."

COMMENT:

Ledgers A and B have not been found. Ledger C records the company's dissolution, after which the holders of past-due accounts were sued by Thompson and Teas in Amherst County Court.¹

COMMENT:

"Charles Lavender Junr." was the first customer to set up an account in this new ledger. Three Charles Lavenders existed in Amherst during the 1780s:²

- Charles I, called "the elder" in court records, who apparently died between 5 April 1781 and 15 July 1783.³
- Charles II, called Charles "Sr." in this ledger whose entries began after the death of Charles "the elder"; he was brother to this ledger's William Lavender and Allen Lavender.
- Charles III, called "Charles Jr." in this ledger, son of son of William I and grandson of Charles I.

No marriage record has been found for Allen Lavender. Records generated by the probate of the 1811 will of the widowed Anne (Mills) Witt of Bedford County, identify Allen's wife as Agatha (aka Agnes) Witt, daughter of Anne by her husband Lewis Witt (a brother of John Witt Sr. of Amherst).

COMMENT:

The Charles and Stephen Watts who appear in this ledger were of no known kinship to the Edward Watts of early Amherst whose son Thomas, *c*1748, married Sarah Mills. sister of Jesse Mills and Milly (Mills) Lavender.

The brothers Stephen and Charles, beyond reasonable doubt, were sons of a William and Mary Watts whose first known appearance in Amherst was on 19–20 January 1763 when William had land surveyed on the waters of Rucker's Run and Dutch Creek at Rocky Mountain. After William's death, in that same decade, his widow Mary married Joseph Dillard above, brother of the James Dillard who also appears in this Thompson & Teas ledger.⁴

Only one Mills family existed in Amherst at this time: that of Jesse Mills and wife Lucy Tilman. By this point in the 1780s, Jesse and Lucy were impoverished and their adolescent children were being farmed out to other families. Son William was in the employ of his first cousin Tilman Walton. Daughter Susannah would be sent to live with a neighborhood family of no known kinship (John Lancaster Sr.). This John Mills who seems to be living with or employed by Allen Lavender—as proposed son of Jesse—would have been the first cousin of Allen Lavender's wife.

As an adult, John Mills of Amherst fathered two proved sons: Tilman (b. c1799) and Jesse (b. c1805).⁵

COMMENT:

Lavender's association with Adam Brown provides a clue to pursue toward the identification of a Mills in-law:

- In 1795, Susannah Mills, the daughter of Lavender's uncle Jesse Mills, married James Brown, parents or kin unidentified.¹⁴
- Adam Brown, Lavender's associate, was the brother of one James Brown, according to entries in William Cabell's diary. Adam, in 1786, contracted with Cabell to operate a blacksmith shop on Cabell land, with some equipment provided by Cabell as well as the service of one man enslaved by Cabell. Shortly after, Adam was taken into custody for the murder of his brother John, after which "James Brown his brother" returned to Cabell the enslaved man. By 1791, Adam was a free man, again setting up shop as a smithy on Cabell's premises.¹⁵
- The entries above and below establish an association between the Lavender-Mills family and the Adam and James Brown family.

Samuel Gutridge and William Mills (son of Jesse) were both tithables charged to Tilman Walton on the 1787 Amherst personal tax roll, implying that they were in his employ. Gutridge (more correctly Samuel Eliot Goodrich) married Tilman Walton's sister on 25 December 1789 with consent of her father William Walton.¹⁶

- This Thomas Watts was not the same man as the tailor Thomas Watt. This Thomas Watts was
 the brother of Caleb Watts of Clark and Harris Creeks in Amherst. His daughter Mary, by 13
 September 1786, had married Francis Waters.¹⁸
- The "luxury" nature of the item purchased by Thomas daughter, the timing of the purchase with regard to her first appearance on record as a married woman, and the fact that this Thomas and his family made no other purchases from this store, suggests the possibility that the daughter purchased this fan as an accessory for her wedding.

The 1787 personal property tax roll of Amherst County names this William Mills as a propertyless tithable charged to Tilman Walton, son of the above William Walton. The only Mills family residing in Amherst County at that time (indeed, the only one since the creation of Amherst in 1761) was the family of Jesse Mills and wife Lucy Tilman, whose sister was the wife of William Walton. COMMENT:

George Blaine appears in Amherst County court records as an associate of both Jesse Mills (Charles Lavender's uncle) and William Walton (brother-in-law of Jesse Mills). Walton in the 1760s had served as surety for a debt that Blaine incurred. In 1778 Blaine was granted a license to keep an ordinary at his house; and by 1782, Jesse Mills and Blaine were suing each other on various charges.²⁰

Richard Luttrell (var. Litterall, etc.) and his sons link the Lavender-Mills-Walton clan to the Witts of Amherst. In addition to the entry above, wherein Charles Lavender paid 15 shillings toward goods delivered to Richard Luttrell, I have thus far documented the following:

- In August 1783, Richard was sued by Abner Witt for slander.²¹
- In May and August 1788 terms court at Amherst, when Richard was sued for debt by a mercantile firm, Abner's brother John Witt served as his bail.²²
- James Luttrell, b. 1755 to Richard and wife Sarah Churchwell, married 1774 **Elizabeth Witt**, b. 1759 to Abner Witt and wife Ann Churchwell (aka Churchill).²³
- James "Litteroll" and Tilman Walton were bondmen for Bartlett Eads in 1786.²⁴
- James "Litterall" served as witness for **William Walton** in a 1788 suit against Richard Tankersley.²⁵
- In June 1794, **Abner Witt** of Knox Co., TN, gave power of attorney to James Littrell to sell his Amherst land.²⁶
- William "Litterell," brother of James and son of Richard, in June 1789 witnessed a land purchase by **George Witt** and his brother **John Witt** in June 1789.²⁷

COMMENT:

At this point, the firm of Thompson & Teas dissolved. Beginning immediately after p. 438, a series of unnumbered pages summarize the debts owed to the firm—debts for which Thompson & Teas required the debtors to sign bonds (579 of them). When debtors failed to pay the bonds as they fell due, Thompson & Teas then sued the debtors in the Amherst County court. The outcome of those cases can be tracked in the county's court order books.
