Mills & Associates, Montgomery County c1850–1870: Preliminary Survey of Resources **SUBJECT**

for Bradberry (esp. George), Fleeman, Jarrett (esp. Allen), Lawrence (esp. John B.), and

Nunley/Nunnally (esp. Richard)

BACKGROUND: William Mills and Drucilla Kemp married in Franklin County in 1815, a county that was then adjacent to Montgomery. William appears on Franklin County tax rolls from 1806 through 1819 (usually as a tithe with no property), does not appear on the 1820-29 tax lists that itemize only property owners, reappeared in 1830 when he inherited land from Drucilla's parents, and remained there for another eighteen years. In 1849, the Franklin County roll cited him as an absentee landowner residing in Floyd County. He and his sons are carried on the Floyd County rolls and court minutes from 1849 through 1851-52, then disappear. An 1853 court minute in Floyd cites a warrant issued to William's son Sparrel in Montgomery County.

> William and Drucilla were the parents of nine children, several of whom had Montgomery County spouses:1

- 1. JAMES H. MILLS, b. c1816; first appeared on Franklin Co. tax rolls, adjacent to William, in 1837. He has not been found after the Franklin roll of 1844.
- 2. SAMUEL E(DMUNDSON?) MILLS, b. 26 February 1818; died 31 July 1894, Talbot Co., GA; married (1) Mary Ann Hobson, 17 December 1841, Franklin Co., VA, with James Patterson as bondsman; (2) Rebecca Amy Collier, 19 March 1868, Upson Co., GA.
- 3. WILLIAM B(RECKENRIDGE?) MILLS, b. c1820, makes his first appearance in Franklin on the 1841 tax roll, appeared again in 1842, was dropped in 1843, was back again in 1844; and on 19 October 1847, in Franklin County, he married Mary M. Matthews. He died of gunshot wound on 30 April 1865, while returning home from war.
- 4. SPARREL MILLS, b. c1824, Franklin Co., VA; first appears on the Franklin Co. tax roll of 1845; married Martha Susan Jarrett, daughter of Allen Jarrett, 1848, in Henry Co., VA. In 1850, he and his inlaws and parents were all in Floyd Co. In 1852-54 he was taxed in Montgomery Co. The 1860 census of Montgomery cites him as a laborer, living among other laboring families, apparently on the substantial farm of Andrew J. Lucas. Postwar, he remained in Montgomery, and died after 3 May 1900, when he filed an application for a Confederate pension as a resident of Radford.
- 5. ROBERT WILLY MILLS, b. c1826; died 31 May 1862, Battle of Seven Pines near Richmond. He married 18 December 1843, Henry Co., VA, Mary Jarrett, daughter of Allen Jarrett. In 1850, as "Wiley Mills," he farmed in Floyd Co.'s militia district 15 (Beaverdam Creek, allegedly). He

- enlisted at the Floyd Co. courthouse on 14 March 1862 (age 36) in Co. A, 24^{th} VA Infantry, under Lt. G. M. Helms.
- 6. CHARLES T. MILLS, b. c1828, or 1833, Franklin Co., VA; married Sarah E. Fleeman, daughter of Elias and Patsy Fleeman," 22 December 1857, Montgomery Co., where they were enumerated in 1860. By 1870, they had moved to Claiborne County, TN, by 1870. Both died after the 1880 census of Claiborne.
- 7. SARAH "SALLIE" ANN MILLS, b. ca. 1830, m. in Floyd Co., c16 December 1850, William H. Key, (parents unidentified). The 1850 census of Floyd places William, 23, "born in Giles Co.," in the home of George Key, 36, and wife Hannah Kester, adjacent to Sparrell Mills and his Jarrett in-laws. In 1860, the Keys lived in the Mills-Jarrett family cluster in Pulaski County's Western District. On 6 April 1864, as "Sarah A. Key," age 35, daughter of "William Mills" and "Drucella Mills," she m. a widower from Lovely Mount (now Radford) in Montgomery Co., George Bradbury (var. Bradberry), son of Mark and Mary. Sarah died 1 July 1889 in Summers Co., WV.
- 8. MILLY FRANCES MILLS, b. April 1832 (variously 1830, 1832, 1833) in Franklin Co., VA; died after the 6 June 1900 census visitation and, apparently before the April 1904 death of her husband whose obituary cites children but not a wife. On 27 July 1854 (by license of 22 July) in Floyd Co., VA, Milly married John B. Lawrence, who had been born in Bedford Co., VA, as son of William and Agnes Lawrence.
- 9. THOMAS R[ICHARD?] MILLS, b. 11 March 1833, according to his death certificate; married ca. 27 August 1855, in Montgomery Co., Sarah S. Nunnally [var. Nunley], daughter of Richard and "B" Nunnally. The couple are cited on the 1860 census, Pulaski Co., VA, next door to both sets of parents. In 1880, they resided in Montgomery Co.; in 1900 they lived in Pulaski Co. where he was employed as a "river ferryman." Thomas died 5 April 1915 of "chronic Bright's disease."

POSSIBLE KIN:

William Mills, whose offspring for a half-century have failed to find evidence of his parentage,³ did not carry a Mills Y. Multiple male-line descendants from each of two separate sons of William and Drucilla carry the Y-DNA of the Virginia immigrant John Witt/Whitt. My working hypothesis is that William was the son of a Mills mother and a Witt/Whitt father who did not marry; thus William's legal surname was Mills.

Extensive research across some 30 counties of central and western Virginia has narrowed the search to two "single mothers" who appeared, without identifiable adult relatives, in Montgomery County shortly after William's birth:

Potential Mother 1:

FRANCES "FRANKEY" MILLS, b. c1770, was called a "widow" on an unexecuted Montgomery County marriage bond of November 1788. In August 1792 she married a middle-aged widower, John White Sr. Those two documents place her in the Copley neighborhood between Walker Creek (on the west side of New River) and Doe Creek

(to the east of New River), between modern Pearisburg and Radford. John's samename kinsmen, John White of Walker Creek married off a daughter to Robert Whitt⁴ nephew of the famed Little River—Meadow Creek Baptist minister, Rev. Richard Whitt. After Montgomery Co. split in 1806 to form Giles, Frankey's Walker Creek—Doe Creek neighborhood lay above the new county line, just within Giles. The Prestons of Smithfield, with whom Frankey and John maintained a curious relationship as late as 1818, remained in Montgomery County—as did Rev. Richard Whitt and his offspring.

Frankey, by White, would bear seven sons before her death between 1810 and 1820. Prior to marriage, Frankey bore two children of record:⁵

- Rachel Mills, b. c1786–87, who was bound out to the Preston family in 1790; married 1803 a local farmer's son, John Bowen (with William Preston serving as bondsman and petitioning to be her "guardian" for the purpose of giving permission for the marriage). The Bowens moved shortly thereafter to Ohio where John died in 1814; the widowed Rachel then married William Berryhill. (Meanwhile, Frankey Mills's husband John White, in 1799, moved into Northern Montgomery Co. on a small piece of land that was patented to both him and William Preston; it was taxed to Preston after 1807, with White as occupant, and then returned to Preston about 1818.)
- Samuel Mills, b. c1788–89, remained with his mother and stepfather in the part of Montgomery that became Giles; married Rachel Prince in 1807 with both Frankey and John White giving permission. As an adult, Samuel settled land that became known as Mills Valley north of East Mountain in what is now Mercer Co., WV. He died 17 February 1859 at his Mills Valley home. One male-line descendant who has Y-DNA tested carries the Y-DNA of Montgomery's Booker Mullins and Atkins families.

Rachel was not a common name in Montgomery County. In addition to Rachel Mills and Rachel (Prince) Mills, one other Rachel has crossed into this project: Rachel Whitt, the eldest daughter of Rev. Richard Whitt and sister of the **Archibald Whitt** who is a candidate for the father of William Mills-Whitt.

Potential Mother 2:

SARAH "SALLIE" MILLS, b. c1770 to Jesse and Lucinda (Tilman) Mills of Albemarle and Amherst Counties. Sallie's first known appearance on record in Montgomery occurred in April 1791 at her marriage to Elijah Sartain whose siblings and offspring extensively intermarried with Brumfields and Napiers. The Napiers were headed by a set of brothers—Thomas Hughes and Patrick Jr.—who, in the 1780s, came to Montgomery and Franklin from Fluvanna, formerly Albemarle. in Fluvanna they were associates of Sarah's grandfather Thomas Tilman and her uncles Thomas Jr. and Daniel. In Montgomery, they married Mary and Fanny Brumfield, whose brother Humphrey was married to Elijah Sartain's sister Sally.

Sartain, Brumfield, and Napier documents place Sarah Mills's first appearance in Montgomery in the same general region as Frankey, but a bit upriver: from **Walker Creek**, over and across New River onto **Stony Creek** below Pearisburg. That region also fell into Giles in 1806. In 1814, Elijah and Sarah sold their land and (after an apparent two-year stay in Kanawha County, Virginia) removed to Gallia County, Ohio, with their Napier, Brumfield, Blankenship, and Sartain kin. There in Gallia, in 1822, Elijah Sartain's niece Margaret Brumfield married Robert **Whitt** Jr. (son of Robert **Whitt** Sr. and Mary White of Montgomery) and settled with him on the parental lands that by then had fallen into Logan County, West Virginia.⁶

Also settling with Sarah and Elijah in Gallia was her premarital daughter and son-in-law:

• *Elizabeth "Betsy" Mills*, b. between March 1790 and April 1791; married 1811 in Giles, Archibald Chapman.

SUMMARY OF FINDINGS

Mills

In Franklin County in 1848, William and Drucilla—then in their sixties—turned over to their newlywed son William B. Mills the Franklin County land Drucilla had inherited from her father. (Location 2 on Map 1.) From there, they moved to Floyd County (cut 1833 from Montgomery) with their four young-adult children who were still at home and rented land in the Simpsons community on the north side of Little River, between the head waters of Big Run and Pine Creek. (Location 3.) Their reason for choosing the neighborhood remains unexplained, but surrounding lands were owned by a cluster of interrelated families rooted in Montgomery County: **Iddings, Lights, Conners,** and **Wilsons**.⁷

In 1852, William and Drucilla moved again: up Little River into Montgomery County. The new area they chose—outside Radford at the junctures of New River, Little River, and Meadow Creek (Location 4) had been settled in the 1770s by the **Rev. Richard Whitt.** At his death about the winter of 1812–13, Whitt left his land and mill to his son **Archibald Whitt,** who had married **Hannah Lowe** about 1788.⁸ At the


time that William and Drucilla arrived in 1853, at least two of Archibald's children remained: **Hezekiah** (born *c*1795–96, according to the 1850 census) and **Abijah** (born *c*1800-01).

After a single tax-roll appearance in 1853, William (then nearing 70) was dropped from the Montgomery tax rolls. Typically, a man his age and status would have asked the county court to excuse him from taxation on the basis of age and/or indigency. I have not found any such action on his part in the county court minutes where exemption requests were usually recorded. William and Drucilla's son Sparrel would continue to be taxed until 1855. Four of their children would find spouses in the neighborhood: Milly Frances married John B. Lawrence (son of William) in 1854; Thomas married Sarah S. Nunnally (daughter of Richard) in 1855; Charles married Sarah E. Fleeman (daughter of Elias) in 1857; and Sarah, after the CW-era death of her husband William Key, married in 1866 to the Radford-area widower George Bradberrry (son of Mark, who farmed with George beside the sons of Archibald Whitt (on lands of the Rev. Richard Whitt, their grandfather) at Meadow Creek of Little River. (Site 4 on Map 1.)

The Mills-Whitt World c1785–1867



Shortly before the 1860 census, the family cluster moved across New River—but still in the general area of Radford. Thomas's new father-in-law, Richard Nunnelly, took a post as overseer for General Gordon Cloyd, apparently at his principal location on Cloyd's Mountain (originally Montgomery County, then Pulaski). The rest of the Mills-Nunnelly-Key cluster were enumerated around the overseer, as tenant farmers or laborers. There William appears to have died in 1863, during the year for which Pulaski's death records have been destroyed. In 1866, when his widowed daughter Sarah married the Radford farmer George Bradberry, Drucilla apparently settled with them outside Radford—back in the same locale in which they had arrived in 1853. When Drucilla died in 1867, Bradberry reported her death. Sarah, the daughter who married Bradberry, and her siblings Thomas Mills and Milly Frances (Mills) Lawrence would live out their lives in Montgomery County.

Whitt

The following research notes provide only rudimentary information on the brothers Hezekiah and Abijah Whitt, their spouses Sally Howerton and Elizabeth Elswick, and their offspring. It offers an occasional note on their sisters Rhoda (wife of Francis Godbey), Susannah (wife of William Howerton), and Hannah (wife of John Linkous). The Whitts will be treated separately in far more detail in a research report focused on that family.

Most of the householders are farmers, but occupants include a teacher, shoemaker, blacksmith, clerk, and merchant, suggesting they were quite near a small village. Their location should be the Whitt family land on Meadow Run, on the ourskirts of the village of Lovely Mount (now Radford) that was built at the juncture of Little River and New River.

Abijah Whitt married Nancy Compton in Montgomery Co. by bond dated 18 September 1820. 11

COMMENT:

The 1860 census places William and Drucilla, with their married son Thomas and Thomas' inlaws, the Nunnellys, on the main plantation of Gordon Cloyd Jr.—across New River in Pulaski Co. along Cloyd's Mountain.

Gordon Cloyd Sr. and his father Joseph Cloyd were extensive landowners in early Montgomery County, with holdings from Cloyd's Mountain northward to **Walker's Creek** (where they owned land adjacent to Robert **Whitt's** father-in-law John White of Little Sugar Run), and further north to **East River** and **East Mountain**, where Frankey Mills and husband John White Sr. settled by 1799 on land that would be jointly patented to John and William Preston.²⁵

MARCH-APRIL 1851 MONTGOMERY COUNTY, VA

Guardianship

Account settlements filed for the guardianships of "M. Thomas Whit" and "Elizabeth Whit" by guardian Wm. P. Hayes. Both are said to be "wards" of Hayes. Accounts accepted and Hayes was relieved of duty.²⁶

COMMENT:

These two young-adult Whitts, who had apparently turned 21, are not on the 1850 census although "Miss Eliza Whitt" is included in the debts due 1850 to the estate of John Ingles.

William P. Hayes Sr. and Jr. do appear on the 1850 census, but do not have an Elizabeth or "M. Thomas" living in their household.

Elizabeth and M. Thomas should be identifiable by searching prior estates for the parent who left property. The fact that they are called "wards" suggest that their mother as well as their father has died and that Hayes, serving as a court-appointed guardian of their inheritance, also took them in.

- The 1850 census of Floyd Co. cites Robert Wiley Mills as "Wiley Mills."
- The 1851 tax roll of Floyd cites him as "Robert W. Mills."
- In 1852 and 1853, as "Robert W. Mills," he was charged with a breach of peace in Floyd Co.

Also relevant:

The Snider/Snidow family settled pre-RW on Little Stoney Creek of New River between the Sartains of Big Stoney (site where Sarah Mills emerged in 1791) and Doe Creek of New River (where Frances Mills's 1788 suitor owned land).

 Hezekiah and Abijah were sons of Archibald Whitt and wife Hannah Lowe, and grandsons of Rev. Richard Whitt, according to David F. Whitt's Tables 4 and 5. Note, however, that Table 5 places Abijah's birth at "1791" rather than c1801 as per the 1850 census.

Archibald inherited his father's land by terms of Richard's will (100 acres on Meadow Creek). The log home from this site, known as "Whitt's Mill on Meadow Creek" was allegedly built in

1775 and later moved to the grounds of Radford College to serve as a museum. In 1953 it was removed from Radford, to private ownership "near Claytor Dam." ³⁰

- A 2 May 1853 court order below appoints **Hezekiah Whitt** as an election supervisor for the district at Lovely Mount. **Lovely Mount**, now **Radford**, ³¹ was home to **three** of William and Drucilla's grown children: Millie Frances who married John B. Lawrence in 1854, Sarah, who married George Bradberry in 1864, and Thomas Mills (intermittently from *c*1865–1915).
- Others in this tax district include Bird S. Grills, John A. Guerant, several Gearharts (all consecutive in the G section), Lafayett Iddings, several Ingles, Lesters, Lucases, John & Robert Muncy, Peppers, Poffs, Prestons (William B., Robert T., James F.), and Sniders. All of these families in the 1790s lived below the Sartain residence on Stoney Creek (where Sarah Mills m. Elijah Sartain), down to Little River of New River and Meadow Creek of Little River (site of Rev. Richard Whitt).

COMMENT:

- Bradbery *et al.* returned their report on 7 March 1853, approving the alteration, saying it would also involve the land of Christopher H. Willis & Randolph Cumpton.³⁵ Abijah Whitt's wife was from the Compton/Cumpton family.
- By bond of 3 April 1806, in Montgomery Co., Francis Godbey m. Rhoda **Whitt**, ³⁶ sister of Abijah, daughter of Archibald, and granddaughter of Rev. Richard Whitt.
- This document places George Bradberry, who later married William and Drucilla's daughter, as a neighbor of Archibald Whitt's daughter. Note that the 1850 census places him four households from Archibald's son Hezekiah. (If Archibald is indeed the father of

- As seen below, "William Mills Sr." and George Bradberry fell within William Smith's district, placing them in the N-E division of the county.
- The Whitts, after the redistricting, fell into the S-W division, with Hezekiah being still at present Radford.

The village of Lafayette lies along the Montgomery-Floyd line, NW of Bent Mountain. It is also on the south bank of the Roanoke River and on the east bounds of I-81. It does not appear to be a logical place for William Mills to have gone from his Little River location in Floyd.

William Mills's position [below] seems to be the start of the new additions to the "M" section of the tax roll

Scaggs, Danl. Shelar, Naomi Thompson, Isham Dobbins, James Calfee, Wm Meredith, Harvey P. Wilson. Reed C. Hall, James Howerton, Stephen Lester & Gasper Albright, and it being represented to the court that all the land holders through which the said road will pass have consented to the same except Isam Dobbins & James Calfree. It is ordered that they be summoned to appear here on the first day of the next court to show cause if any they can as why the said road shall not be established." 54

COMMENT:

- Re Howeton/Howerton: Hezekiah Whitt and his sister Susannah (children of Archibald) both married Howertons.
- William Meredith and apparent son Hugh C. are adjacent taxpayers to "Sperrel" Mills on the 1852–55 tax lists.
- HomeTownLocator places "Easter Creek" off North side of Little River a bit ESE of "Little Montgomery" and two bends downstream from Snowville and Graysontown.
- Google Maps shows Easter Creek on E side of Little River at Hwy 787, at the point that
 highway 613 dead-ends on the W bank of river—about 20 miles W as the crow flies, from
 Simpsons in Floyd County. Today, there is a cluster of roads running between Simpsons and
 Snowville (as opposed to minimal roads through the part of the county that lies south of it.

Richard Nunally and "B" Nunnally were the parents of Sarah Nunally who married Thomas R. Mills by bond/license of 27 August 18**55** in Montgomery County. 56

Note on the 1854 tax roll below that Thomas R. Mills, who had just turned 21, is not cited as a tithable—even though the roll calls for all free males 16 and over. The only Mills on the 1854 list is his brother Charles T.

No Nunely/Nunally/etc. individuals are enumerated on the 1850 census of Montgomery, Floyd, Franklin, or Henry.

This is the new road that would be run through the neighborhood of Abijah and Hezekiah Whtt. Note that Meredith appears adjacent to "Sperrel" Mills on the tax lists of 1852 through 1855. It appears from the neighborhood clusters that Sperrel spent those years amid the Whitts as well.

branch near the Railroad Bridge and thence to three sycamores on the branch, thence leaving the branch and running on the North side of the ridge, to the corner of **Barnetts** land and thence with Barnetts line its several courses back to the beginning, including the dwelling house. Given under our hand this 1 March 1858. Samuel Barnett. James Barnett. Charles N. Winfrey."⁶³

COMMENT:

On 14 October 1814, William Mills signed a "fishing/oyster industry" petition amid a cluster of Montgomery Co. residents, including **Samuel Maddox**, Robert **Barnitt** Sr., John **Barnitt** Junr., James **Light**, John Jr. and Andrew Thrash, John Shockey, and Bird and Andrew Wilson.⁶⁴

The 1840 and 1850 censuses of Montgomery show Mary Maddox as a head of household, with no adult male. In 1850 she was within the LaFayette community on the Roanoke River in Northeastern Montgomery Co., adjacent to Roanoke Co. (created 1838 from Botetourt Co.)⁶⁵

A. Stone** due by bond bearing date the 1st? day of August 1859 & payable one day after date, the sum of [\$45] due to Musgrove C. Stone due by bond bearing date the 14th day of March 1859 & payable the 25th of Decr. 1859, the sum of [\$45] dollars due by bond executed the 14th day of March 1859 & payable the 25th of December 1860. Now should the aforementioned debt remain unpaid till "25" of November next & complaint be made by the sd. **William A. Stone** or Musgrove C. Stone, the sd. Wm. E. Stone shall sell the aforementioned property for cash giving reasonable notice of the same & pay to the sd. William A. & Musgrove C. Stone the amount of their debts and accruing interest & after paying the cost of this deed & sale, the ballance if any pay to the sd. Bradbury. Witnesseth the following signatures & seals. Mark Bradberry, Wm. E. Stone.

In the Clerk's office of Montgomery County Court the 1st day of August 1859. This deed of trust from Mark Bradberry to Wm. E. Stone, Trustee for Wm. A. Stone & al., was delivered to me & acknowledged by said Bradberry & Stone as their act & deed & admitted to records. James M. Wade, c[lerk]."68

COMMENT:

Mark Bradberry was the father of George Bradberry, husband of Sally (Mills) Key.

17 AUGUST 1859 MONTGOMERY COUNTY, VA

Whereas Thos. G. Shelor, **Milburn Whitt**, and **Jeremiah Whitt** were trustees on "a certain deed of trust made by Wilson Peterman, Jno. B. Peterman & Daniel J. Peterman" dated 14 July 1859, at the direction of the creditors, they put a portion of the property up for sale Prior to the sale "certain friends of the **[widow] Mary Peterman**, to wit **W. A. Stone**, C. H. **Coffer, Lecky Whitt**, Cephas Shelburn, H. J. Stone, B. Hawthorn, Thos. G. Shelor & **Melburn Whitt** donated money to **Jonathan Witt** to purchase the goods that Mary would need (beds, furniture, livestock, books, etc.), totaling \$190.00. As a consequence, they were not deeding those goods to the widow Mary Peterman."⁶⁹

The name is clearly written as **Cofer**. Published marriage records show that Nancy Whitt, daughter of Abijah, married **James L. Cofer ("Coffee"** var. **Calfee)** by Montgomery County bond dated 12 July 1852. I have not found the couple (under Coffee or Cofer) in 1860.

COMMENT:

On 6 April 1864 the widower George Bradbury married the widow Sarah A. (Mills) Key, daughter of William and Drucilla Mills and widow of William H. Key.⁸⁰ In 1860 the Mills-Key-Nunnelly cluster lived across New River from Radford, at Cloyd's Mountain in Pulaski.

A death record for George's first wife, who was still alive on the 1860 census, has not been found among the county's recorded deaths. George's father Mark, on the 1860 census, is sandwiched between Hezekiah Whitt and his nephew Martin L. Whitt (son of deceased Abijah by Nancy Compton). Mark, who had \$1000 in property on that census, died in 1862 (date not stated) of dropsy at the age of 67, leaving a widow Manervia⁸¹ and likely some inheritance to George, who used it (above) to spruce up his home in preparation for a new wife.
