SUBJECT Mills & Watts: Goochland and Cumberland Counties, Virginia: Initial Survey

BACKGROUND: Goochland County was created in 1728 from western and northwestern Henrico. In

1744, Albemarle County was cut from western Goochland. In 1748, Cumberland County

was cut from southern Goochland.

One or more William Mills received patents in 1732, 1736, 1746, and 1749 for land said to be in Goochland. The first tract, on Lickinghole Creek at Wild Boar branch, remains in Goochland. The 1736 and 1746 grants were on branches of Willis River, now in Cumberland County. The 1746 patentee identified himself as "son of William Mills of Aberdeen." In 1748 a yet-unlocated tract of 56 acres was surveyed in the name of William Mills in the part of Goochland that became Albemarle and then Amherst. In 1749 a patent for 300 acres on "Pedlar River, *Goochland*" was issued to that same William Mills. Pedlar River was by that time in Albemarle and would be cut away into Amherst where William of Pedlar River died in 1766.

Prior research has focused on the Southside Virginia counties cut from Goochland and Brunswick—primarily Albemarle, Bedford, and Lunenburg.<sup>1</sup> The present project will focus on Goochland itself.

### **ASSOCIATES:**

Ambrose Mills: Son of William Mills of Albemarle, he is known to history as the Loyalist Col. Ambrose Mills who was hung at King's Mountain during the American Revolution. In 1750 and 1752, Lunenburg County tithe lists identify him as overseer for lands owned by the absentee John Payne of Goochland. He subsequently appeared in Bedford records before leaving the province in 1756 for the Carolinas.

Thomas Watts and father Edward: Thomas married *c*1748–49, Sarah Mills, daughter of William of Albemarle. He also appears on the Lunenburg tithe lists of 1748–52, as does Edward and his younger sons in 1752. In 1749, Thomas and Sarah sold his newly patented land on Pedlar River adjoining her father William Mills and his father Edward—land lying near the Lunenburg—Albemarle line. Most of the Watts land would fall into Bedford after Bedford's creation in 1754.

**Witts of Albemarle and Bedford**: One Lewis Witt, alleged brother of John, married a woman named Anne who is believed to be Anne Mills, daughter of William of Albemarle. While this is a collateral line to me, I am also conducting research on another William Mills (born c1783-88; married Franklin Co., VA, 1815, Drucilla Kemp) That William's parents are unknown but his tested Y-line descendants carry a Witt Y.

**OBJECTIVE:** 

Gather sufficient evidence to sort the various William Millses who appear in Goochland records of the 1730s and 1740s or, if the case may be, to prove that they were one and the same man.

# **Executive Summary**

(MILLS)

This segment of research has yielded extensive new materials attesting the presence of at least two and likely three separate William Millses in Goochland. As with most research efforts in the British American colonies, the most useful records by which to disambiguate same-name men are those generated by (a) the acquisition of land and (b) daily actions chronicled in court minutes.<sup>2</sup>

### LAND

Four patents and a variety of deeds document the ownership of five tracts of land "in Goochland" by men named William Mills. (See Maps 1 and 2, for their locations.)

- Tract 1 was patented in April 1732, 400 acres on Lickinghole Creek, adjoining Henry Chiles, "Scott," and Francis Kirby. Parts of it were sold in March 1733/4 and January 1736, each time by William Mills with the acknowledgement of wife Mary. This land remained in Goochland.
- Tract 2 was bought in October 1732 from Henry Childs, 300 acres on Lickinghole Creek and its Wild Boar branch. Neighbors were Chiles and "Utley." Parts of it were sold in February 1735/6 and May 1744, each time by William Mills with the acknowledgement of wife Mary. This land remained in Goochland.

- Tract 3 was patented September 1736, 400 acres on the ridge between Willis River and Guinea Creek of the Appomattox, adjoining James Allen, John Marten, and William Warnack. It was sold in November 1743 by William Mills with the acknowledgement of wife Mary. This land was cut away into Cumberland County in 1749.
- Tract 4 was patented August 1746, 380 acres on Willis River's branch Pidy Rock, near its head and
  the heads of Bear Creek and Tar Wallet Creek. Neighbors were Wm. Daniel, William Easley, Ralph
  Flippins, and Anthony LeVellain. A 1739 road order cites "William Mills" in the midst of several of
  these neighbors, suggesting that he was on the land nearly a decade before the patent was finalized.
  That patent was issued to "William Mills, son of William Mills of Aberdeen." This land was cut away
  into Cumberland County in 1749.
  - Land processioning records of St. James Southam Parish place William and his land very close to the Southam church at Tar Wallet (aka Tear Wallet) Creek. (See Map 3.) William sold parts of this land in 1755 and 1759, without the participation of a wife. In 1763 he mortgaged the remainder to a creditor who sued for the land in 1765. At that point Williams disappears from Cumberland records.
- Tract 5 was patented April 1749, 400 acres "in Goochland," said to be on both sides of Pedlar River and Dancing Creek." However, a 1744 division of Goochland County carved off Pedlar River into the far west of a new county, Albemarle. The fact that the patent specifies Goochland, although the land fell into Albemarle, suggests that the applicant William Mills was a resident of Goochland at the time he petitioned for the land. This William penned his will in 1755, on the Pedlar, naming his wife Mary. When he died in 1765, Mary survived him.

### **ACTIVITIES**

The presence of the Albemarle William Mills family in *Goochland* before the 1744 split is also attested by a legal suit prosecuted against the son Ambrose in Goochland, in 1743 and 1744.

The Research Notes that make up the bulk of this report chronicle the activities of these men and their associates in considerable detail. The following overview helps to define the pattern of activities to assist in disambiguating the three William Millses.

1730	Sued by Robert Wade. No further information appears to have survived.
Apr. 1732	Received patent for 400 acres on Lickinghole Creek, adjoining Henry Chiles (formerly of
	Hanover), Samuel Coleman, Scott, Kerby. [Petition for land likely made by 1729]
Oct. 1732	Purchased from Chiles another 300 acres on Lickinghole and Wild Boar Creek.
Mar. 1733/4	Sold (with wife Mary) 100 acres of his 400-acre patent. Purchaser: neighbor Francis
	Kerby. Witnesses: Edmond Hodges (Hogges) & William Grimes.
Feb 1735/6	Sold (with wife Mary) 20 acres of the land bought from Henry Chiles. Purchaser: William
	Chambers. Witnesses: Samuel Coleman, John Clark. Chambers sold this land in
	September 1742 along with other land on nearby Treasures Run.
June 1736	Sold (with wife Mary) remaining 300 acres of his 1732 patent on Lickinghole. Purchaser:
	James Walker. Neighbors: Samuel Coleman, Chiles, Scott, Kerby. Witnesses: John Pryor,
	Peter Patrick, Henry Chiles. Walker in 1739 sold this land to Edmund Hodges.
Sept. 1736	Received patent for 400 acres in a more-western region of Goochland (present
	Cumberland County), on the ridge between Willis River and Guinea Creek, adjacent to
	James Allen, John Martin, and William Warnock.
Mar. 1737	Sued William Webb for an "action of trespass" (likely debt).
May 1738	Witnessed deed of John Winn and wife Mary of Henrico to Humphry Parrish of

Goochland, land on James River adj. Robert Addams, Welcom William Hodges, Parrish,

and Hanover line. Landholdings of the associates strongly suggest he is William of Lickinghole.

- William Welcome Hodges had grants 1727–1734/5 on Deep Creek of Licking Hole and Treasures Run. Edmund Hodges (see Feb 1735/6 above) got a 1739 grant on Treasurers Run.<sup>3</sup>
- Parrish had grants 1746–47 on Little Byrd and Fork creeks in present Goochland, just northwest of Lickinghole Creek.<sup>4</sup>
- Robert Adams is identified as an adjacent landowner in the 1730–34 patents issued to Henry Atkinson on "main br of Licking hole Ck," Humphrey Parish on "N side of James River & branches of Treasurers Run," and Welcome William Hodges on "N branches of Treasurers run."
- Aug. 1739 Assigned to road crew together with James Allen, William "Wamack" and William Easley and others with land on Great Guinea Creek of Willis River and its TearWallet branch.<sup>6</sup>
  - The assignment of Mills personally (not "Mills' hands" or "Mills' Quarter") suggests that (a) he actually lived there rather than being an absentee landowner; and (b) he was a yeoman farmer rather than being of the "gentleman" class.
  - William Easley owned land adjacent to the Pidy Rock tract patented August 1746 by William Mills "son of William Mills of Aberdeen."
  - William Wamack and Ralph Flippen (another landowner adjacent to the Pidy Rock William) are grouped with William on a small list of returns dated 16 May 1752 in Southam Parish, Cumberland County.
- Sept. 1740 Owned land adjacent to John *Parrish* on South branch of Owens Creek. Other neighbors of Parrish: Henry Adkins and Stephen Lacy. Also
  - The Parrish association links him to the William of May 1738.
  - Stephen Lacy received two 1731 grants—one on "Owens Ck adj Gooch-Hanover Co line" and the other in Hanover on branches of Owens Creek.<sup>7</sup>
- Ju-Jly 1741 Sued by William Webb. Dismissed in July.
- Sept. 1741 Named as adjacent neighbor to Lickinghole land sold by George Hilton. Other neighbors: Thomas Biby, Christian, Hilton. Witnesses: William Bayley, George Brock, Nicholas Owen.
- Sp '42-Nv '44 Sued by Benjamin Harris. Jury trial and forced settlement by judge in November 1744.
  - May 1752, Benjamin Harris and William Mills appeared on a short list of returns to Southam vestry made by William Womack, William Daniel, Alexander Trent & others.
- My-Sep 1742 Named in sale of Lickinghole Creek land sold by neighbor Henry Chiles (then residing in Amelia). Adjoining Chiles land were Mills, Edmund Hodges, John Coleman, and Michael Holland, gent. In September, Chiles sold his Appomattox River land adj. William Chambers, John Payne, Josias Payne.

Note that Nowel Burton, who sued Ambrose Mills (son of William of Albemarle) in 1743 also had land on Little Byrd Creek. - Oct-Nv 1742 Sued by John Yuille (who also sued Peter Booker, John Bryan, James Masters, and William Tabor).
  - William Tabor, 1737–44, received 4 grants on Deep Creek, present Cumberland.8
- 14 Nov 1743 Sold (with wife Mary) 400a between Willis River and Great Guinea Creek of Appomattox. Purchaser: Josias Payne. Neighbors: James Allen, John Martin, William Wamack. Witnesses: John Payne, Robert Woodson, John Roberts.
  - Ambiguity exists with this action. Wm. Wamack (Warnack) was a neighbor of William Mills of Pidy Rock. However, the Woodson and Payne association suggests this is the William of the Ridge who sold his Lickinghole plantation in May 1744. This John Payne is the man who engaged Ambrose Mills, son of William of Lickinghole and Pedlar, to oversee his Lunenburg lands in 1750–52.
- Nov 1743 Ambrose Mills was in Goochland by this time, being sued by Nowel (Noel) Burton for an unpaid debt.
- May 1744 Sold (with wife Mary) remaining 280 acres on Lickinghole, "a plantation called William Millses." Buyer: John "Robards." (See John Roberts in entry above.) Adj. Grainger, John Payne, Benjamin Woodson. Witnesses: John & Josias Payne, Rob. Woodson.
- Nov 1744 Ordered to pay Joseph Bingley, Peter David, and Peter Louis Soblet for their days as witness to Mills's suit against Harris. (*Cf.* Apr 1742 suit of Bingley against "estate of William Mills.")
- Appears on Alexander Trent's tax list adj to *William Easley* and 14 tithables from George Brock who in 1741 witnessed Chambers' sale of Lickinghole/Wild Boar land purchased from William Mills. On that list, Mills is two names from Nowel Burton, a Willis River planter who launched a suit in 1744 against Ambrose Mills, son of William Mills of later Albemarle.
  - William Easley in 1746–59 was adjacent landowner to Pidy River land sold by William Mills who patented the land as "son of William Mills of Aberdeen."
- Not found on surviving tithable lists of St. James Northam or St. James Southam.
- Aug. 1746 Received patent for 380 acres on Pidy Rock Run of Willis River adjacent to Anthony LeVillaine, a document that identifies him as "William Mills, son of William Mills of Aberdeen."
- 1747/8 Survey made of 54 acres for William Mills of Pedlar River, formerly Goochland, then Albemarle.
- Apr 1749 Patent issued to William Mills for 400 acres in "Goochland" (Albemarle) on both sides of Pedlar River and Dancing Creek.
- 1750–52 (Ambrose-of-William Mills is taxed in Lunenburg as overseer of lands held in absentia by John Payne of Goochland.)
- May 1752 Named on a short list of vestry returns in Southam Parish, Cumberland—together with Wm. Womack, Alex<sup>r</sup> Trent, and Benjamin Harris.
- Feb 1759 Sold part of his Pidy Rock land, adjacent to William Easley.
- Feb 1759 Taxed for three tithes in John Watt's district, Cumberland County. The published abstracts do not indicate whether the tithes were slaves or white males.
- Ag '55–Ap'65 Appears regularly in parish records of Southam, Cumberland County, frequently performing land processioning. He is repeatedly coupled with neighbors of both Willis River grants: William Daniels, William Easley, William Womack, Ralph Flippen, and Anthony LeVillaine. The period in which he is dropped from vestry duties (and Southam

records) coincides with the death of William Mills of Pedlar River, whose estate was opened April 1766 in Amherst, but all known evidence suggests that is coincidence.

30 Jan 1783

Samuel Woodson and wife *Sarah Mills* of Henry County had twins baptized by Rev. William Douglas of Southam Parish, Goochland: one named Joseph *LeVillaine* and the other named William *Fontaine* Woodson. The LeVillaine connection suggests that this Sarah may stem from the William Mills of Pidy Rock who patented land adjacent to Anthony LeVillaine in 1746; however, no children are yet known for that William.

The evidence laid out in this set of research notes speak to one conclusion: Two different Williams were in Goochland and two different men owned land along the waters of the 60-mile-long Willis River:

- One William, with wife Mary, had been in the county since 1730. He owned land on Lickinghole Creek and Wild Boar, before branching out to the ridge between Willis River and Guinea Creek—on the western end of the Willis. After selling both locations in November 1743 and May 1744, with wife Mary in each instance, he moved over to Pedlar River, along with the Burkses who had been his Lickinghole neighbor.
- A second William settled by August 1739 at the head of Pidy Rock, near the heads of Bear Branch and Tar Wallet—also waters of the Willis, but near its eastern end. From Aberdeen, Scotland, he was likely a bachelor at his arrival. Hence, his statement of parentage and origin in his petition for the Pidy Rock land: in the event that something happened to him, his heirs would be known. He remained on Pidy Rock and was an active processioner for the established church at Tar Wallet through the 1765. In that year, a creditor petitioned the court, alleging that William in 1763 had mortgaged to him his land and slaves. The debt had not been paid and the creditor requested William be "discovered" and required to testify whether he still owed the debt. Summonses were issued to William in Cumberland County; the case record does not show that he responded. The fact that he dropped from the records at this point, with no hint of a death and probate, suggests that the Aberdeen William had left.

### (WATTS)

Prior research in Southside Virginia suggested the presence of one Thomas Watts in the 1740s and 1750s, son of Edward of Lunenburg and Albemarle. That Thomas married, c1748, Sarah Mills, daughter of William and Mary of Pedlar River. Research reported in this paper introduces another Thomas Watts:

Thomas Watts of Goochland first appears on record when he was appointed to appraise an estate. This Thomas would have been born at least by 1714. To be appointed to that task, he was likely some years past the minimum age of twenty-one. In either event he was at least ten years older than the age that has been approximated for Thomas who began a family in 1749 with Sarah Mills.<sup>10</sup> Nearly a decade passes before the name has been found again in the Goochland records.


- The name Thomas Watts again appears in Goochland—as does one Edward Watts. The pair of names, taken together, suggests they might be from the family of Edward Watts and son Thomas Watts who subsequently resided along the county line between Albemarle and Lunenburg and appear in records of both counties. However, no geographic or associational links have yet been found to link the two Goochland men. Nor does Goochland seem to offer direct evidence of an association between the Thomas and Edward Watts who were briefly there in the middle of the 1740s.
- Thomas Watts of Goochland purchased 400 acres on the Little Muddy, a creek that now crosses the county line between Cumberland and Powhatan (cut from the eastern half of Cumberland, formerly Goochland). The location was some 100 miles east of Thomas Watts's 1748 grant on Pedlar River in Albemarle, reducing the likelihood that the two Thomases are the same.
- Jly 1747 Thomas Watts of Southam Parish, Goochland, was assigned to a road crew on Muddy Creek—past Mr. Scott, Barnet's Road, and Pruet's Path, and Ham Chapel—together with John Merriman and William Bond. These individuals are not known associates of Thomas Watts of Albemarle and Lunenburg.
- 1747–8 (January and March) Thomas sold his 400 acres in two separate deeds. A wife "Mary" participated in the March sale. Thomas also signed his name in full to the sale, while the Thomas Watts of Pedlar River, son of Edward and son-in-law of William Mills, made his "WT" mark on his 1748 land sale of Pedlar River land (recorded in both Goochland and Albemarle).
- 1747— Thomas and wife Mary drop from Goochland deeds at this point.
- Two different Thomas Wattses appear on the Lunenburg tax rolls in these years. One, Thomas of Hailes precinct in 1750, could be a candidate for the Thomas of Goochland. The Thomas Watts who married Sarah Mills is concurrently in a different precinct and consistently there from 1748 through 1752. 11)
- **Conclusion:** The Thomas Watts (or multiple Thomas Wattses) of Goochland and Muddy River were not the same man as Thomas Watts of Albemarle's Pedlar River and Lewis Deloney's tax district of Lunenburg.

# **Research Notes**

# 1728— GOOCHLAND COUNTY, VA

Historical context

"Goochland County was formed in 1728 from Henrico County, from that portion west of Tuckahoe Creek on the north of the James River, and that portion west of Lower Manakin Creek, south of the James River. ...

"In 1744 the County of Albemarle was formed from the western portion of Goochland. [Goochland] in turn was further divided in 1749 when that part south of the James River became Cumberland County. Cumberland was itself further divided in 1777, when its eastern portion became Powhatan Co. Albemarle County in turn, was mother county to Amherst in 1761, Nelson in 1808 (from Amherst), Buckingham in 1761, Appomattox in 1845 (from Buckingham), and Fluvanna in 1777.

"In colonial times, Goochland County was divided into parishes of the Church of England. **St. James Parish** was created in 1720 from Henrico Parish, and remained St. James until 1744, when it was further divided into St. James Northam, north of the James River, and St. James Southam, south of the river. It was originally formed from that part of Henrico Parish west of Westham Creek on the north side of the river, and the upper line of the lands of the French refugees south of the river. **King William Parish** was

formed in 1700 from Henrico Parish, with no set boundaries, but was to encompass the lands near Manakin Town granted to the French Huguenot refugees."<sup>12</sup>

### 1730

### **GOOCHLAND COUNTY, VA**

Court order

"The action of Debt between **William Mills,** Plaintiff and Robert Wade Defendant is dismissed neither party appearing." <sup>13</sup>

### **COMMENT:**

The fact that this William Mills was suing in the county this year does not necessarily mean that he was living in Goochland. Debt suits, in this time and place, were commonly lodged in the place where the *debtor* lived. This suit might also have begun while Goochland was part of Henrico. That possibility needs to be pursued.

One Robert Wade farmed on Goochland's Lickinghole Creek, suggesting that his creditor may well be the William of Lickinghole whose first grant was dated 11 April 1732. (Wade's own grant was dated 20 June 1733.)<sup>14</sup> In this era, it was not uncommon for a settler to occupy a tract for several years before the patent was granted. First-time landowners in a region (speculators excluded) would frequently test the land by clearing a small portion and planting crops for one or two seasons before deciding to go through the patent application. Then there were fees for surveying and often a payment to the colony before the patent would eventually be issued.

### 31 OCTOBER 1732

### **GOOCHLAND & HANOVER COUNTIES, VA**

Land purchase

"Henry Chiles and Anne his wife, of Hanover Co., to William Mills of Goochland Co., for £25, 300 acres on east side of Licking Hole Creek, including plantation called 'Bobs', bounded by Utley's line. Witnesses: Richard Kearby, Patrick (L) Cash, Edman (E) Hogges." [Hodges] Recorded 16 Jan. 1732[/3]. 16

### COMMENT:

Two Mills-Chiles relationships have been documented in this generation:

• This William Mills of Goochland who bought Chiles land, adjacent to Chiles, and interacted with him for another decade or so.

• Matthew<sup>3</sup> Mills, son of Henry<sup>2</sup> Mills of Caroline and grandson of the immigrant Nicholas<sup>1</sup> Mills made a will 1753/4 in Albemarle leaving 1650 acres to sons William, Mathew, Charles, and Menan. He also named daughters Mary and Betty. Probate records identify his wife as Mary, the widow of Micajah Chiles whose will was dated 1735–36. Charles and Menan were then underage. William and Charles, both said to be of Hanover, were named as executors. Matthew also claimed land in Louisa Co.<sup>17</sup> Hiden's genealogy of the Nicholas Mills family tells us that Mary was probably née Terrell, daughter of Wm. and Susannah Terrell, because Matthew and Mary named a son William Terrell Mills.<sup>18</sup>

The Chiles connection to both Matthew and William suggests that this William of 1732 Goochland might be part of the family of Nicholas > Henry > Matthew. Hiden does not present a William who was brother to Matthew. However, she does discuss a William who was first cousin to Matthew and son of Henry²'s brother Charles—telling us that Nicholas² (husband of Ann Clopton) left a will dated 6 April 1741 (in Goochland?) in which "he gave 200 acres of land in Goochland Co., VA [to his namesake Nicholas³ Mills, son of Charles² Mills]; then the remainder of his Goochland land was to be sold and the money equally divided among **Wm. Mills, son to Robert**, and Nicholas Rice, son to Jane Rice, Frances Jackson, dau. to Ann, and Wm. Anderson son to Elizabeth."<sup>19</sup> However, the evidence gathered for both William Millses of Goochland do not support a connection to the Nicholas Mills family.

# 16 JANUARY 1732/3 GOOCHLAND

Court order

"Chiles's deed to Mills. Richard Kearby Patrick Cash, and Edmund Hodges prove a deed with the Livery of Seizin endorsed from **Henry Chiles & Anne his wife** to **William Mills** to be the act and deed of the said Henry & Anne and it si [sic] thereupon admitted to record."<sup>20</sup>

### **COMMENT:**

Henry Chiles, born about 1698, is said to have married Anne Harrelson, daughter of Paul Harrelson. Prior to Goochland he is found in records of Hanover County, also owned land in Amelia and Brunswick, and died in Amelia in 1746.

The most extensive reconstruction of the Chiles family (well documented) concludes that Henry is the son of Henry Chiles I and wife Mary. However, Henry I also had a brother John Chiles who married (1) Mary [Boucher?] and (2) Eleanor [commonly but erroneously identified as Webber]. John died prior to 16 May 1723, when his widow petitioned the provincial county regarding his estate. He also left sons named John and Henry. Henry of John is said to have settled in Spotsylvania County, as did the widowed Eleanor and new husband Edward Hickman.<sup>21</sup>

Mary [Boucher?], wife of John Chiles, was likely from the family of William Boucher/Bouncher who drafted a will in Hanover County in 1733 bequeathing his real estate and part of his personal property to "Mary Chiles, daughter of John Chiles dec'd." (See below) This Mary, daughter of John, seems not to have been tracked into adulthood by prior researchers.

This John appears to be the parent of Thomas Learwood who married Elizabeth Mills, daughter of William Mills of Albemarle.<sup>24</sup>

Wit: Anne (+) Gibson, Zebulon Shelton.

appeared and voluntarily relinquished his Executorship and expressly refused to take upon him the burden of the Execution of the sd. Will whereupon at the motion of *Thomas Prosser* greatest Creditor of the sd. Dec'd. taking the oath appointed by law was granted him for obtaining letters of administration during the minority of **Mary Chiles** the other executor.

"Admin. Bond We *Thomas Prosser* and *Peter Garland*, Gent. Are firmly bound unto *Nicholas Meriwether*, Gent. Commr. of the Peace for Hanover Co. in the sum of £500 sterling. 1 Feb. 1733. Condition if above bound Thomas Prosser Admin, with the will annexed shall make or cause to be made a true and perfect inventory of all goods, chattels and credits of the sd. Dec'd. and pay all legacies specified in sd. Will this obligation to be void. [Signed] Thomas Prosser, Peter Garland. 1 Feb. 1733 ack. By Thomas Prosser and Peter Garland, Gent."<sup>26</sup>

### COMMENT:

The wording of this will is that of an unmarried man without "forced heirs." It is more likely that Mary Chiles would have been a niece, rather than a granddaughter. The naming of a minor female as coexecutor suggests a likelihood that the testator did not have adult male relatives.

Mary, though a minor, should have been past her fourteenth birthday—the age at which she could choose a guardian or make other legal decisions. In short, she was of marriageable age.

This Order Book 3 has a long-running case, William Bouncher vs. Richard Ward that was launched by Bouncher in 1731 and continued by his administrator (and largest creditor) Thomas Prosser through September 1735, at which time it was still unsettled. (Blomquist covers this case at her pp. 127, 155, 190, 203, 227, 245, 278, 311, 334, 355, 392, 432, 448, 479.)

Although Prosser was to serve in that role only until the appointed executrix Mary Chiles came of age, there is no mention of Mary acting with him during these four years.

"Stephens's adminn, Anne Stephens comes into Court & makes oath that John Stephens deced. died without any will so far as she knows or believes & on her motion & giving security for her just & faithfull administration of the said decedents estate certificate is granted for her obtaining letters of Administration in due form James Nevills security. Ordered that Michaell Thomas, Thomas Watts, Richard Churchhill, & Stephen Johnson or any three of them they being first sworn before some Justice of the Peace do appraise the estate of John Stephens deced. & that Anne Stephens the Admx. Do return an inventory thereof to the next court."<sup>34</sup>

### COMMENT:

This Thomas Watts should be at least 21—and likely some years past that age, for him to be appointed an appraiser of property. This suggests that he is not the Thomas Watts, son of Edward, who married the daughter of William Mills of Albemarle.

Edward's father, Thomas of Orange County, made a will in 1746 and died c1749 in Culpeper (cut from Orange). In that will, he names four sons: John, William, Edward, and Jacob. He does not name a son Thomas. Whether the Goochland Thomas might have been the Culpeper man is yet unknown.

### COMMENT:

This Micajah left a widow Mary, subsequent wife of Matthew Mills of Albemarle.

Davis's Virginia Tidewater Families identifies Micajah Chiles as the son of Henry Chiles I by

Henry's second wife Mary<sup>37</sup>—that is, a brother of the Hanover Henry Chiles who owned land adjacent to William Mills on Lickinghole Creek. This fact suggests that William Mills of Lickinghole may have belonged to the same family as Matthew Mills of Albemarle.

Beginning at a red Oak in *Almes [James?] Allen's* Line, running Thence New Lines North fifty Degrees West one hundred and twenty six Poles to a white Oak, North twenty five Degrees East one hundred and seventy Poles to a Pine, Thence on *John Marten* North sixty Degrees East seventy Poles to a white Oak and Hiccory, Thence New Lines North twenty five Degrees East one hundred and forty two Poles to Pointers, South sixty five Degrees East one hundred and forty seven Poles to a white Oak, South twenty five Degrees West thirty five Poles to a white Oak, Thence on *William Warnack* the same Course continued two hundred and ninety three Poles to a Spanish Oak, Thence on *James Allen* North seventy five Degrees West fifty two Poles to a white Oak South thirty seven Degrees West sixty seven Poles to the first station.<sup>43</sup>

# COMMENT:

"Willis River is a 61.8-mile-long branch of the James River. It "rises in southern Buckingham County and initially flows eastwardly into Cumberland County, where it turns north-northeastwardly for the remainder of its course. It flows into the James River in northern Cumberland County, about 6 miles ... southeast of Columbia." 44

### **COMMENT:**

No William Mills probate record has been found in Goochland. The above reference does not say "estate of William Mills, deceased," as would be common if this William Mills had died. The term "estate" is apparently used here in the sense of "property belonging to," as when a judgment is issued against a defendant and an attachment is issued to seize sufficient property to cover the debt. William Mills with wife Mary did own land that could be seized. William Mills "of Aberdeen" did not own land at this point; he had almost certainly settled on his Pidy Rock tract, but he did not complete the titling process until 1746. That said, "estate" also included personal property when the defendant did not have land.

- The Woodson and Payne association suggests that this 1743 seller is the same William of Willis River who sold his plantation on Lickinghole in May 1744 in presence of Benjamin Woodson and John & Josias Payne.
- Benjamin, William, and Robert Woodson Jr. received extensive grants on Jinnetoe/Genito Creek of current Goochland, 1714–25. John Woodson was on both Genito and Lickinghole Creeks, and numerous others.<sup>94</sup>

- the 1745 deed records suggesting that Thomas of Goochland was several years older; and
- the October 1742 court suit of Irwin vs. Hugh Dennum and Thos. Watts, which suggests Thomas was born by 1720.

Edward Booker Junr. acknowledged the deed at court, whereupon it was ordered to be recorded. 120

### COMMENT:

- This William Mills of 1745 is clearly living on Willis River, in the same neighborhood where he would remain through at least February 1765. The processioning lists of Southam Parish (abstracted later in these research notes), places him in the immediate neighborhood of William Easley, the Daniels, and the Trents.
- Note also that the August 1739 road order, abstracted above, places him on the same stretch of road as William Easley, Alexander Trent, and the Terrys.

### However,

 Two names after William appears the name "Nowel Burton." The court minutes of 1743 and 1744 chronicle the debt suit of Nowel Burton vs. Ambrose Mills, the young adult son of the William Mills (wife Mary) who received Pedlar River grants after Albemarle was cut from Goochland.

• Mills's location here was cited in 24 August 1761, when his neighbor Daniels sold part of his land:

"William Daniel of Cumberland to John Seay 4 Aug 1761, recd 24 Aug 1761, £8, 25a in Cumberland on the Heads of **Pidy Rock** and **Bear Cr**, bd John Seays, **William Mills**, John Taylor, Warham Easleys Church Road. No wit." <sup>128</sup>

- Pidy Rock is said by one area researcher to be "north of Cairo" [Ca ira]. 129
- William Daniel is said to have acquired a tract of 400 acres in Cumberland on a "br of TearWallet Ck" adjoining William Mills, 26 Sep 1760.<sup>130</sup> USGS topographical maps show Tear Wallet, in Cumberland County, as a branch of Guinea Creek, headed north then northwest; its juncture with Guinea is slightly northwest of Stony Point Mills.<sup>131</sup> "Tar Wallet Church" is

**George Carrington**, 1743–49, received 3 grants totaling some 10,000 acres on "both sides of Bear Garden Creek," Randolph Creek & Bear" and Willis River. 135

**Thomas Tabb** received one grant 10 June 1837 in Goochland "btw Angola & Green Cks of Appomatt." <sup>136</sup>

#### COMMENT:

In using the original (filmed) records of Goochland, I skimmed all pre-1755 deed & will books, page-by-page. That period represents eight years past the date that Thomas Watts & wife Sarah Mills sold their land. I found no further references to Watts (or to a Mills) who bought or sold property or witnessed the documents of others.

Post-1755, I had time only to read the original indexes.

Regarding the other individuals in this deed who help us identify this William Watts:

William Daniel was a resident of Tear Wallet Creek and adjacent landowner to William Mills of Pidy Run ("son of William Mills of Aberdeen") in Cumberland County. See 28 August 1746 above.

**Ambrose Hudgens** received a grant on "branches of Willis River," 12 January 1757. The other individuals cited in this document are not included in the Direct Line database. 138

Immediately following the Watts deed is the 25 May 1747 will of **William Walton Sr.** of Goochland who leaves land in Albemarle County to the following:

eldest son **William** (N side of James River just below mouth of Hareway River), youngest son **Jesse** (400 acres in Albemarle on S side of James, including fork of Slate River), eldest daughter **Susannah** (N fork of Slate River joining Patterson), daughter **Mary**, 125 acres in Albemarle on S side of James joining land given above to Jesse), daughter **Anne** (400 acres in Albemarle on S side of James on N fork of Slate, joining land given to Jesse), daughter **Louisa** (400 a in Albemarle on S side of James on N fork of Slate, adjoining Ann), daughter **Frances**, after her Mother's decease (400 acres in Goochland on N side of James River, it being the place where I now live." Executors: Wife (not named), John Cobb and George Walton. Witnesses: Geo. Walton, James (E his mark) Prophet. Proved in Goochland 16 March 1747, the day after Thomas Watts's deed. (pp. 379-81)

The son William, later known as William Walton Sr. of Albemarle, in late-life married Mildred "Millie" (Mills), daughter of William and Mary Mills of Albemarle and widow of William Lavender. His brother Jesse was the Revolutionary War captain (Patriot side) who hanging of William Mills Jr. of Albemarle, Millie's brother. 139

At the time assigned for the processioning, no one was on William Mills's land to point out the boundaries.

This land was patented in August 1746. He was taxed in this neighborhood, adjacent to Easley, in 1745. Clearly, he had already settled on the land by 1745.

Signed: Thomas (WT his mark) Watts. Witnesses: Edmond Harrison, Richard Powell, Thomas Smith. August Court, 1749: Thomas Watts acknowledged the deed. 146

#### COMMENT:

- Pedlar River was a short branch of the Fluvanna/James, lying in the western "butt" of Albemarle. To the south of the Fluvanna was Lunenburg. In 1754, Prince Edward County (where the Learwoods lived) would be created from Amelia, as well as the part of Lunenburg that lay south of the Fluvanna.
- Sarah did not sign or make her mark. The evidence does not show she was actually present. In most other deeds in this record set, the wife *did* sign or acknowledge the sale.
- Skimming this "Will & Deed" book, reveals that most men who appear in these records (i.e., yeoman class and above) could sign their names. Most women could not.

## **COMMENT:**

This is the Thomas Watts who married Sarah Mills, daughter of William Mills of Pedlar River. Note that he signed the document with his mark "WT," while the Thomas Watts of Goochland, with wife Mary, signed his full name to the sale.

#### COMMENT:

The 1750–52 tax rolls of Lunenburg show Ambrose Mills acting as overseer for the absentee landowner John Payne. Payne was a large-scale landholder for whom purchases and sales can be found across numerous Piedmont and Southside Virginia counties.

- William Johnson and **Elizabeth Mills,** m. Feb. 4, 1755 had two children born or baptized in St. James: Jeremiah June 15, 1757 and Judith June 2, 1758.
- Philip Ryan and **Elizabeth Mills** had a daughter Elizabeth born or baptized 26 May 1773 and a son Thomas on 10 December 1775.
- Samuel Woodson and Sarah Mills had twins Wm. Fontaine and Jos. LeVillaine born or baptized 30 January 1783.
- William Mills & Eliz. Fontaine had a son George born or baptized 11 April 1782.

The last three couples by 1770 or so had all settled the region that would become Henry Co. See my Henry Co. report, cited herein.

## **COMMENT:**

Given that the lands seem to be listed in the order in which they were visited, it would appear that William Mills's lands were just six tracts removed from the parish church.



To have and to hold the said tract or parcel of land with all the appurtenances thereunto belonging together with the said negro slaves and their future increase unto your orator his heirs & assigns to the only proper use and behoof of your orator /his heirs and assigns for ever, subject nevertheless to a proviso or condition in the said indenture, contained that if the said William Mills should well & truly pay to your orator the aforesaid Sum of one hundred & thirteen pounds ten shillings and five pence with lawful interest as aforesaid within the space of six months after the date of the said indenture (now long since past) and also any other Sum or Sums of money that the said William Mills might become indebted to your orator & likewise all costs accruing to your oror. on account of the said indenture, and the said William Mills did in and by the said indenture covenant and agree with your oror. that the said William Mills at the time of sealing & delivery of the said indenture was seised of a good and indefeazible estate in Fee simple or and in the aforesaid tract or parcel of land & premises, & was also possessed of the four negro Slaves aforementioned as of his own proper slaves, & further if default should be made in the proviso or condition before mentioned that your orator his heirs or assigns should & might enter in and upon the premises & every part thereof & possess themselves of the said slaves & their future increase, & to sell & dispose thereof in Such manner as he or they should think fit, as in & by the said indenture duly executed by the said William Mills and remaining of record in this worshipful court & to which your orator for greater certainty refers himself, may more fully appear, and your orator charges that the said Sum of one hundred & thirteen pounds ten shillings & five pence or any part thereof was not paid to your orator or to any other person on his account, according to the proviso in the said indenture contained at the time therein mentioned or at any other time, but the said Sum of one hundred and thirteen pounds ten shillings & five pence is now due to your orator. ## **COMMENT:**

Hiden's well-documented and reasoned genealogy of the Nicholas Mills family presents Ann Mills (wife of Henry Tandy) and William Mills (husband of Peggie Swift) as children of Charles<sup>4</sup> (Charles<sup>3</sup>, Nicholas<sup>2</sup>, Nicholas<sup>1</sup>) and his wife Ann (probably Jackson). Ann Tandy is said to have d. 1809 in Orange Co., VA, leaving descendants who are said to be traced in "Tyler's Mag. Oct. 1932." William and Peggie are said to have moved to Spotsylvania by 1771, where William served in the Revolution as captain of the Spotsylvania militia and wrote his will in 1820 (probated 1821) naming wife Peggy.

Siblings of William and Ann are said to be **Mary**, who married *c*1758 *William Quarles* of Caroline County, with whom she moved to Spotsylvania; **Charles**<sup>5</sup> of Reedy Creek in Hanover who married Sarah [–?–]; **Frances** who married William Thompson 29 January 1771 and baptized 9 children in St. Mark's Parish, Hanover; and **Elizabeth** (1747–1853) who married Joseph Terrell in 1767.

Hiden also proposes a brother for Charles<sup>3</sup>: **Thompson Mills** of St. Margaret's Parish, Caroline County, who bought land from Chiles Terrell in 1772. Charles's will dated and recorded 1808 in the "Caroline Miscellaneous Papers" name wife Elizabeth, daughters Susannah Mills, Ann Patterson, Elizabeth Mills and Frances Mills, along with sons Robert M., Thomas, and Thompson. Executors were his son-in-law Samuel Patterson and friend Samuel Terrell.<sup>173</sup>

#### COMMENT:

The edited version of the Douglas Register clearly extrapolated marriage dates (as a "married by ..." date) from the baptismal dates of children.

William and Elizabeth Mills of Matrimony Creek, Henry Co., named a son William F. Mills. He is said to be named William *Fountain* because he was the son of the Mills-Fountain marriage above. According to the 1850 census, that William was born about 1775—seven years before the year given for the Mills-Fountain "marriage" by Jones's edition of the Douglas Register.

Hiden proposes that William of Henry Co. was the son of Robert<sup>3</sup> Mills of Hanover County, VA, and grandson of the well-known Nicholas<sup>2</sup> Mills who married Ann Clopton.<sup>176</sup> Deeds executed by William of Henry to Millses of Hanover in 1787 do suggest the viability of that kinship.<sup>177</sup>

The fact that the twins were said to be born on the date that Samuel and Sarah are said to be married supports the conclusion that the marriage "list" provided in this volume may include "extrapolated" marriages—i.e., indications of marriage drawn from other sources—rather than an actual recording of marriages, as they occurred and on the dates they occurred.

This Samuel Woodson in 1786 sought out land in Henry County adjacent to William Mills and wife Elizabeth Fontaine. The patent was granted 31 July 1788, for 440 acres on the N fork of Matrimony Creek. The survey, dated 11 November 1786 described the land as "Beginning at Mills' corner hickory ... crossing a branch of Marrowbone Creek [back to] Mills corner Black Oak, thence with that line N 66 degrees W 132 poles to a red Oak W 70 poles crossing the Creek to the beginning." <sup>181</sup>

Samuel Woodson sold this land in 1797 to that neighbor: **William Mills** who, with his wife Elizabeth Fontaine, also had a child baptized (ten months earlier) by the pastor of St. James Northam parish, apparently while riding circuit.
