SUBJECT Mills & Associates: Montgomery & Fincastle Counties, Virginia: Preliminary Survey¹

BACKGROUND: William Mills (b. c1784–88), first emerged in 1806 as a young, propertyless tithable in adjacent Franklin County. His earliest associates were other young men with Montgomery connections. In the 1840s and 1850s, several of his children married in and/or lived in Montgomery County. In his declining years, impoverished, he left Franklin and lived variously in Floyd and Pulaski Counties (both cut from Montgomery). His widow died in Montgomery in 1867, at which time the son-in-law who reported her death stated her birthplace as Montgomery. That statement is provably false but does raise a question whether the informant confused the birthplace of his wife's father with that of his wife's mother.

> William's birth family is unproved. Tested Y-line descendants carry a Witt/Whitt Y. (I-M253 and its terminal branch I-S24090.)² To distinguish him from other William Millses under study, I am referencing him as William Mills-Witt.

> William married 1815, in Franklin Co., Drucilla Kemp, daughter of Robert Kemp and Millie Edmundson (daughter of Richard) who wed 1786 in Franklin. Drucilla's stepmother was Sarah Mattox (daughter of Nathan, formerly of Bedford County, VA, who married Robert Kemp in 1802 Franklin. Bondsman for William's marriage to Drucilla was Stephen Standifer, an Edmundson neighbor whose family migrated from Bedford to Henry before being cut away into Franklin. William and Drucilla disappear from Franklin County records in the 1820s but reappear in 1829 when she inherited paternal land. My survey of some twenty-six surrounding counties has not yet located him during that decade.

ASSOCIATES: Franklin County associates of William, with Montgomery ties, include

- John Ferguson Jr. of Bedford and Franklin, who died 1789 in Franklin leaving land in Montgomery Co.⁴
- Samuel McCarrell, grandson and heir of John Ferguson, who first appears as an adult in Franklin Co. on the 1800 tax roll. In 1801, he bought land in Montgomery Co., from his aunt Sarah Weaks (wife of William Weacks, Weeks). In 1803, Franklin Co., he bought land from Richard Stanley (in-law and cousin of Booker Mullins). At the first appearance of William Mills-Witt on the Franklin Co. tax roll of 1806, William was added between Samuel McCarrell and Booker Mullins and his list was turned in the same day as McCarrell's. Through the next four tax rolls, Mills's list and McCarrell's list would continue to be turned in on the same day. The 1830 census of Franklin (semi-alphabetized by first letter of surname) lists William Mills-Witt consecutively with Joseph Mullins, son of one of the Booker Mullinses.⁵
- Jacob Prillaman, in-law of the Mullins family, who owned land on Little River of Montgomery County, in 1796.⁶

EXECUTIVE SUMMARY

Within this summary, information from prior reports is footnoted to that particular report. *The new findings, documentation and fuller details are found in the research notes section of this report—chronologically arranged—and can be located easily by using the date referenced in this summary.*

This county offers promising evidence for the possible origin of William Mills-Witt of Franklin (b. c1784–88). His Witt Y suggests that we need to seek a Mills mother and a Witt-Whitt father in close proximity at the time of his conception. **That combination does exist here in Montgomery.** Mills females and a Whitt family can be placed in the same tax district (representing roughly one-third of the county) from 1787 through the early 1800s, with associates in common.

Mills

Seven "Mills" individuals have been identified in Montgomery County from 1777 through 1803. Five can be dropped from futher consideration:

- John Mills Sr. and Jr. This father-son pair originated in Augusta, resided and owned property c1749–66 in the part of Lunenburg that became Bedford, but returned to Augusta land that fell in Botetourt after 1770. The son served as a militia captain during the Revolution, the father died in Botetourt in 1781, and both appear briefly in Fincastle-Montgomery records as part of an ongoing legal process that originated before Fincastle was created.⁷
- John Miles/Mills, private in Osborn's Militia Company c1777–83. Published transcriptions and abstracts of these rosters variously cite him as *Miles* and *Mills*. On Montgomery's tax roll of 1782, he is clearly Miles, grouped within a family of other Miles males who continue as Miles through the 1780s.
- Thomas Mills, who is cited on the 1787 tax roll as having moved to NC. He is likely the 1790 head-of-household in Stokes County, across the state line from Patrick County (formerly Henry), who had a family of seven that year. (One branch of the Whitts, below, also lived in Stokes.) Thomas appears to be a second-generation offspring of a Thomas-Henry-Richard Mills family that settled Surry > Stokes before 1768. Stokes County records suggest that his wife was a daughter of Daniel Huff of Montgomery County who also moved to Surry.⁸
- Rachel Mills. On 3 August 1803, one John Bowen posted a bond to marry Rachel Mills, with William Preston as his surety. On that same day, Preston was appointed Rachel's guardian.

TO BE PURSUED:

Between 1788–92, two Mills females surfaced in Montgomery as young women without known family. Both were married in the same rural church—Rev. Alexander Ross's Baptist church at Walker Creek in what is now Giles County—suggesting that the two women were likely related. The families into which they intermarried were neighbors and associates, not only with each other but also with Whitts.

One of the women is widely proposed, with credible evidence, to be the daughter of Jesse Mills and wife Lucy Tilman of Amherst County—a couple who underwent extreme financial hardship in the 1780s. At least two of their teenaged children (William and Susanna) are known to have been placed in other homes. These two young women in Montgomery were

• Sarah "Sallie" Mills. On 7 April 1791, Elijah Sartain (var. Certain, Sartin), took out a marriage bond to marry Sarah, with Joel "Certain" as his surety. The marriage return, citing 26 April 1791 as the date of marriage, was filed by the same Rev. Alexander Ross who would wed the widow Frankey Mills to John White Sr. in 1792. In 1806, Sarah and Elijah were cut away into Giles, as were John and Frankey (Mills) White.

In 1815, Elijah and Sallie sold the Montgomery > Giles land that Elijah inherited from his father Joel and moved to Gallia County, Ohio. In 1816, their daughter married in Gallia before a justice of the peace who wrote the bride's name as "Lucy Tilman Sartain" in the recorded marriage return. Most descendants believe, though direct evidence has not been found, that Lucy's mother Sarah was the daughter of Jesse Mills of Amherst County whose proved wife was Lucy Tilman. This Jesse Mills had a sister Sarah "Sallie" who married Thomas Watts (my ancestors) and another sister Anne who married Lewis Witt, cousin of Rev. Richard Whitt of Montgomery.¹⁰

Jesse Mills, the probable father of Sarah (Mills) Sartain, drops from Amherst tax rolls after 1784 but lived at least to 1811. Research is not yet complete for him in Amherst or Montgomery.¹¹

- Frances "Frankey" Mills, widow, for whom three events (four records) have been found thus far:
 - 9 Nov. 1788, John Abram Glymp posted bond to marry "Frankey Mills, widow," with a landowning neighbor, Milliton Atkins, as surety. The marriage appears not to have taken place. No return has been found. Glymph, a Revolutionary War soldier, left Montgomery the next year and by 1800 headed a household in Newberry County, SC, where numerous offspring remained through the 1800s. UPDATE: Y-line descendants of Frankey's proved son Samuel, who have not

- yet published their DNA results, report that closest matches trace their Y-line to the Atkinses of Montgomery and their offspring, Booker Mullins of Franklin County.
- o 19 August 1792, John White Senr. took out a bond to marry "Frances Mills," with Thomas Copley Jr. as bondman. A marriage return for "John White and Frankey Mills" was filed (without a specific date of marriage) by Rev. Ross. After the 1806 creation of Giles Co., the Atkins, Copley, Glymph, and White lands—like the church—all fell into Giles.
- o 6 May 1807. **Samuel Mills** [b. *c*1787] took out a Giles Co. bond to marry Rachel Prince; the record includes the permission of his parents: "**John & Frankey White.**" ¹²

Other associates of Frankey and John White, to be included in further research, were:

- o John White [no Sr. or Jr.] m. *Thomas Copley's* daughter Nancy, on 8 January 1793.
- John White [no Sr. or Jr.] m. Susannah Marcum, 29 July 1796. (Marcums lived near the Mills of Franklin.)

Mary White, dau. of "John White," married Robert Whitt, 22 Oct. 1792 (Robert was putative nephew of Montgomery's Rev. Richard Whitt of Meadow Creek of Little River of New River.)

Other key points:

- No male Mills has been found in Montgomery who might have been married to the "widow" Frankey Mills.
- Frankey Mills may not have been a widow in 1788 but presented herself as such when she moved into the county. The age of her son Samuel suggests that she had just borne him or was pregnant with him at the time John Abraham Glymph posted a bond to marry her. Some unknown circumstance caused that planned marriage to fall through.
- Sarah Mills, who was married by the same minister as the widow Frankey, is likely part of Frankey's family.
- William Mills-Witt of Franklin Co., born c1784–88, named his first daughter Sarah and his second daughter Millie A. (variously, Millie Frances). The fact that their known maternal grandmother was Millie raises the question whether the names "Frances" and "Sarah" came from William's own mother.
- Autosomal tests match descendants of William Mills-Witt to at least sixteen proved descendants of Sarah (Mills) Sartain.

Whitt/Witt:

In 1774, while Montgomery was part of Fincastle, **Rev. Richard Whitt** (aka Richard Jr.) of Halifax Co., VA, received a patent in the Meadow Creek area of Montgomery within the Loyal Company Grant. He performed marriages in Montgomery from 1780 through 1812. His will was probated in 1813. This will names five living children, for whom this report documents the following:

- 1. Archibald Whitt, b. bef. 1766; taxed as over 21 in 1787; named in father's 1813 will.
- 2. Ruth Whitt, who married her cousin Jesse Whitt, son of Hezekiah, 1787; still alive in 1813.
- 3. Richard Whitt III, b. about 1770, who allegedly settled in Tazewell Co.; still living in 1813.
- 4. Elizabeth Casiday, as named in the 1813 will.
- 5. Susanna Crisswell, as named in the 1813 will.

Additionally, the Montgomery County tax rolls (covered separately in this project¹³) show four other Whitts living in the same district with Richard, individuals who were not named among the living children in 1813.

- Hezekiah Whitt, b. before 1761 (extrapolating from his 1779 land purchase) or before 1766 (according to tax rolls), appeared with Richard on 1778–79 militia rolls. Most genealogies present him as Richard's brother and father of Jesse, above.¹⁴
- **Abijah Whitt,** of Capt. Ingles' tax district. He signed petitions in 1786 and 1787 but was also fined in 1787 for nonattendance at muster and dropped from tax rolls—i.e., likely moved from the county. He reappears again on rolls of 1796 forward and petitions of 1800–4.
- **Edmund Whitt** of Capt. Ingles' district, 1787, was fined for nonattendance at muster and dropped from tax rolls—i.e., likely moved from the county.
- Robert Whitt, b. before 1766, was taxed as over 21 in 1787. He was not on county rolls 1788–90. He reappeared on Montgomery's roll in 1791, married 1792 Mary White (daughter of "John"). Other than the notes presented in this paper, I have found two additional records that cluster him with the Mills females of the Walker Creek area:
 - 16 December 1797, Robert Whitt signed a petition for division of the counties of Montgomery, Franklin, and Patrick—in close proximity with Milliton Atkins who served as surety for Glymph-Mills marriage bond.¹⁵
 - 7 December 1804, Robert Whitt signed a petition to create a new county from parts of Montgomery, Tazewell & Monroe—in a sequence of eight names as follows: Randle Adkins, Wm. White, John White, Samuel Drake, Robert Whit, Wm. White, Patrick Napier Senior, and John Adkins.¹⁶

Whitt studies present Robert as a "consensus son" of Richard's brother Edmund (wife Ann), but do not weigh the possibility that he might be a son of Hezekiah of Montgomery. Edmund's widow is said to have settled in adjacent Surry > Stokes Co., NC.

Of the Whitt males found in Montgomery, if one of them fathered William Mills-Witt by a Mills female c1784-88, the evidence to date points to Robert as the prime candidate. ¹⁷

Cloyds:

In 1860, William Mills-Whitt and wife, their son Thomas Mills and his family, and Thomas's father-in-law all lived and farmed on the plantation of the wealthy **Gordon Cloyd Jr.** which seemingly lay along the Giles-Pulaski County line. ¹⁸ Both Giles and Pulaski were cut out of old Montgomery.

This preliminary survey of Montgomery County Millses places Gordon Cloyd Sr. (i.e., General Gordon Cloyd) and his father Col. Joseph Cloyd as landowners adjacent to the John White of Walker Creek's Sugar Run.

The Cloyds appear in Fincastle from March 1773. A court minute of May 1773 places **Joseph Cloyd** on Walker's Creek near the foot of an unnamed mountain. He had Loyal Company land surveyed along **Back Creek** of Montgomery as early as **1782**.

Atkins:

Two seemingly separate groups of Atkinses settled Fincastle in the mid-1700s. **Joseph Atkins** settled lands that now straddle Wythe and Smyth Counties, between Crooked Creek and the Holston River. No associations have been made between him and the Atkins who associated with Millses.

Parker and Milliton Atkins (aka Atkinson, variously misread as Atheson in published abstracts) first appear in 1774 as residents of Fincastle, where their militia unit was called up for Lord Dunmore's War. In 1775 Parker had land surveyed "on the waters of Sinking Creek, and in 1780 obtained a grant between Doe and Sinking Creek. His locale lies just across New River from Walker Creek. Undocumented online accounts disagree as to whether Militon Atkins (the Glymph-Mills bondsman) and his father Parker Atkins came to Montgomery from Amherst or Halifax County.¹⁹

Copley:

Thomas Copley Sr., whose son would serve as bondsman for the White-Mills marriage in 1792, had 160 acres surveyed in Fincastle "on the **west** side of New River" in pursuant to an order of 16 December **1773**, being part of the Loyal Company Grant, as well as land described as lying on **Meadow Creek** of New River. (Same locale as Rev. Richard Whitt.) Copley also appears on the 1774 militia roster for Lord Dunmore's War. In 1780 he was among a group of fifty or so Montgomery County men accused of treason. He appears to have escaped those charges. As shown in my report of preliminary research in Giles County, the Copleys were cut away into Giles, along with the White and Atkins families at the time Giles was created. There, he would become a substantial planter and ferry owner.²⁰

Glymph:

John Abram Glymph enlisted in the great recruitment of 1780, with Chesterfield being his first identified station. Post-war, he appears first on Montgomery's 1787 tax roll (the first tax roll since 1782) and in January 1788 he took out land on Doe Creek amid the Parker-Milliton Atkins clan. Milliton Atkins would then serve as surety for Glymph when he posted bond to marry Frankey White in November 1788. After that marriage fell through, Glymph last appears in Montgomery Co. on the 1789 tax roll.

Mullins, Booker:

An individual of this name (b. c1767) was also taxed in Montgomery from 1787 through 1792. At his first

appearance, the 1788 roll identified him as age 16–21 with 4 horses, enumerated near one "Ambrows" Mullins, a male over 21 with two horses. By 1789, Booker had turned 21, he owned no taxable property, and Ambrose was no longer in the county. On the 1791 roll (certified 2 March 1792) Booker was one of 15 names carrying the unexplained notation "to County & parish Levy." He does not appear thereafter.

The age of this Booker is comparable to that of Booker of Franklin Co. The Franklin Co. man is widely said to be the son of William Mullins and Nancy Standley (no evidence presented),²¹ and he married Judith Standley in 1803.²² His Montgomery County tax district also included a Moses Standley.

Sartain

Joel Sartain (aka Cartin, Certain, Sartin, Sertain), whose son Elijah married Sarah Mills in 1791, appears with the Atkins on the **1774** militia roster for Lord Dunmore's War. In January 1775, Joel had land surveyed on Stony Creek, a two-pronged stream that flanks Walker's Creek on the opposite of the river.

White:

The block of research presented in this segment clearly document the identity of at least three John Whites

- John White who married Frances "Frankey" Mills on 19 August 1792
- John White who married Nancy Copley in January 1793
- John White who married Susannah Marcum in 1796

Chronologically, one **John White Sr.** first appears in Montgomery Co. on a tax roll questionably dated at **1782**, but possibly was created in 1786; it places him in the same community with Thomas Copley, Joel Sartain, and Edmund and Richard Whitt. In **1787**, a John White Sr. and Jr. signed a petition with Copley, the Sartains, and John Cloyd—all residents of what became lower Giles County—asking that upper parts of Botetourt, Washington and Russell Counties be annexed to Montgomery.²³ In **1793**, the John White who eventually married Susannah Marcum patented land on Sugar Run of Walker Creek—land he would have occupied at least two years before the land patent was issued. By **1800**, "John White, John White Jr., Benjⁿ White, James White, and Arthur White" were living above Wolf Creek Mountain where they signed a petition to create a new county.

Thorough use of surviving records for Montgomery and Giles should make it possible to disambiguate between these men.





Research Notes

COMMENT:

For pre-1773 records that relate to the Montgomery County area, see my earlier reports on Augusta and Botetourt, previously cited.

1 DECEMBER 1772–1775 FINCASTLE COUNTY, VA

Historical context

"Fincastle ... was created out of Botetourt County, VA on December 1, 1772. This county only lasted for four years until December 31, 1776 at which time Kentucky County was created as were Washington and Montgomery Counties. At the time of the creation, Fincastle contained all of the State of Virginia from the Piedmont to the Mississippi River. The few records for Fincastle County that have survived are found in the Montgomery County Court House in Christiansburg, Virginia. ...

"In the year 1749, the **Loyal Company** was organized and secured a grant for 800,000 acres beginning on the North Carolina line and running westward and northward for quantity. The petition for the grant was made by Peter Jefferson, Joshua Fry, Thomas Walker, the Reverend James Maury and Thomas Meriwether. The grant contained a provision that required settlement of the land within four years. Dr. Thomas Walker was commissioned as a surveyor by the court of Augusta County in 1752 to survey all the lands in the Loyal Company Grant. ... In June 1753, the Council granted this company four years further time in which to complete its work. ... One contemporary writer, Peter Fontaine, gave a report that there were about thirty families who settled the area under this first set of surveys. Following the French and Indian War, Dr. Walker reported in 1773 [10 years after the war ended*] that he had sold about two hundred and fifty tracts of land. In Legislative Petitions for the State, even as late as 1781, Dr. Walker is asking for these tracts to be made legal beginning with the tracts he surveyed as early as 1753. The activities of this company continued until 1842." ²⁸

COMMENT:

*The French and Indian War ended in 1763. The compiler of these abstracts (at various points throughout) extends the conflict through 1774 to include Lord Dunsmore's War, which was a shortlived conflict between the colony of Virginia and the Shawnee and Mingo tribes.

A somewhat different account of the Loyal Company grant tells us the following:

The Loyal Company was chartered by Virginia in 1748 to a group of prominent Virginia investors, including Lewises, Meriwethers, Dr. Thomas Walker, Joshua Fry, and Peter Jefferson. The 800,000 acres awarded them conflicted with claims of James Patton's New River Company. By 1754, about 200 families had settled under the Loyal Company charter. During the French and Indian War, Indian raids on New River drove most of them out and severely hampered the surveying of the land. The company's charter expired in 1757 and was not renewed.²⁹

3 MARCH 1773 FINCASTLE COUNTY, VA

Court order

"Gavin Lawson assignee of Alex⁴ Stewart Plaintif against **Samuel Cloyd** Defendant. In debt. This day came the Plaintif by his attorney and the defendant not appearing the Solomnly Called It is Ordered Judgment be entered for the Plaintif against the said defendant and **John Cloyd** his Security for the debt in the declaration Mentioned and Cost unless the said Defendant appear at the next Court and Plead." ³⁰

COMMENT:

I am not extracting all Cloyd data—only incidences that date their first appearance on record in the county, or document their locations, origin, or kin.

4 MAY 1773 FINCASTLE COUNTY, VA

Court order

"On the petition of a number of Inhabitants It is Ordered that **Wiliam Thompson** Absalom Mounts and William Lockart who being first sworn do view the nighest and best way from the foot of the Mountain by **Joseph Cloyds** to William lockarts on **Walkers Creek** and make a report of the Conveniances and Inconveniances thereof at the next Court." ³¹

21 FEBRUARY 1774 FINCASTLE COUNTY, VA

Land grant

"William Edmiston, 108 acres, part of the Loyal Company Grant, on the waters of the South Fork of the Holston River, beginning on a ridge. March 15, 1774.

"Samuel Edmiston, 200 acres, on the north side of the Middle Fork of Holston River, adjoining the land of T. Edmiston. March 14, 1774."³²

COMMENT:

William Mills-Witt's wife, Drucilla Kemp, was the granddaughter of Richard Edmundson, who lived in the upper portion of Henry County that became Franklin in 1785. One William Edmiston also appears in the 1772 estate proceedings of James McMurtree in Bedford County.³³ I am not sufficiently familiar with the Edmondsons/Edmistons to determine whether this man is part of the Edmundson family I have just begun to study in Bedford, Franklin, and Henry Counties. At this point, I am not attempting to gather all Edmondson or Edminston materials from Montgomery. I'm taking very brief notes just to pinpoint who was there and when.

27 APRIL 1774 FINCASTLE COUNTY, VA

Land grant

"Richard Whitt, 205 acres, part of the Loyal Company Grant, on the branches of Meadow Creek, waters

of New River, adjoining the {Thomas ?} Mastin survey.34

COMMENT:

The Library of Virginia's online database, "Land Office Grants," does not yield a Thomas Mastin grant or a Richard Whitt grant. Montgomery County's Deed Book A shows that

- Thomas Mastin in 1773 purchased 78 acres patented to James Skaggs on 10 January 1754 "on both sides of Meadow Creek a branch of new River."
- Richard Whitt in 1779 purchased 68 acres from James Scaggs "on Meadow Creek a branch of New River."

Schreiner-Yantis' 1789 tax map of Montgomery County shows two Meadow Creeks in old Montgomery:³⁶

- Meadow Creek of New River, just above the NC line, in present Grayson County (created 1793): 1789's Tax District A.
- Meadow Creek of Little River of New River, in the SE area that remained in Montgomery County until Floyd was created in 1831: 1789's Tax District C. This is the region where Richard Whitt was last enumerated on the 1810 census of Montgomery County.³⁷ It lies several miles down New River from the Atkins-Copley-Glymph-White community, but obviously commerce and social visits existed between the two communities given that Robert Whitt married John White's daughter a few months after John married Frances Mills.

5 MAY 1774 FINCASTLE COUNTY, VA

Court order

"John Mills Senior Executor of the Estate of Irvin Patterson deced plt against {In Case} James and Samuel Robinson Executors of George Robinson deceased and Joseph McDonald Defendants. The defendants by his his [sic] Attorney says that he did Not Assume in Manner and form as the Plaintif against him Complains and of this he puts himself upon the County and the plaintif Likewise." 38

COMMENT:

This John Mills Sr. is the John who emerged in Augusta in the 1740s, then intermittently in Lunenburg > Bedford c1749-66, then returned Augusta > Botetourt 1767-81. See my previously cited Augusta report.

"Put[ting] himself upon the county" was a request for a jury trial.

Wm. Edmiston, Senior, Pattent line, William Brownlee, Samuel Buchanan, Junior. Signed: William Edmiston, Margaret [her mark of a E lying prone, prongs down]. Witnesses: George Buchanan, William Edmiston, John Beatey. Recorded: Aug. 6, 1775 This lease of land from William Edmiston to Andrew Buchanan [sic] was probed [sic] by the oath of the witnesses there to said orderd to be recorded. (Note various spellings – as written)."

[Release] "William Edminston of Fincastle Co for one part and Andrew Edmiston of the same county for the other part. For 37.1.0 current money of Virginia from Andrew to William paid for a tract of land containing 247 acres lying in Fincastle County between the **Middle and South forks of the Holston River** being part of a 1000 acres grant to the said William Edmiston by Patent bering date of July 5, 1774 under the Kings Proclamation of 1763, adj. Wm. Brownlee." Same witnesses: Recorded 7 August 1775.⁴⁰

COMMENT:

William Edmiston executed several lease-and-release sales in July 1775—all from his 1000-acre grant. The same witnesses are used in all (although Beatey's name is sometimes transcribed as Bealey and Baley). Margaret participated in every document. Those lease-and-releases were made to

- Samuel Buchanan, Junior
- Robert Edmondson
- Moses Buchanan
- Robert Buchanan
- Andrew Buchanan
- William Edmondson Senior⁴¹

14 JULY 1774 FINCASTLE COUNTY, VA

Land survey

"Surveyed for **Andrew Boyd**, heir of Alexander Boyd, dec'd by virtue of the Governor's Warrant 2000 acres on the branch of **Elkhorn Creek**, a **north branch of Kentucky River** about one hundred & five miles from the Ohio River & on the south side of the same, adj. John Carter's land & in a line of Wm. Philipp's land. 14th July 1774. John Floyd, asst. Wm. Preston, S.F.C."

"Surveyed for {unknown – no listing in index – might be Samuel Meredith?} by virtue of the Governor's Warrant 3000 acres on the waters of Kentucky River about three miles east of the head branch of Elk Horn Creek a north branch of said River & about one hundred & ten miles from the Ohio & on the south side adj. **And'w Boyd** and John Carter's land. July 14th 1774. John Floyd, asst. Wm. Preston, S.F.C. {on plat – 'Recorded for Meredith and refused & surveyed in other warrants. J. Floyd.'}"⁴²

COMMENT:

Elkhorn Creek, according to Schreiner-Yantis's 1789 map of Montgomery County tax districts lay in the northwest corner of Montgomery, now McDowell County.

29 NOVEMBER 1774 FINCASTLE COUNTY, VA

Survey

"Sherod Atkinson, 44 acres, part of the Loyal Company Grant, on the west side of Big Reed Island Creek in a bed opposite to the mouth of Reed Creek, waters of New River." 43

COMMENT:

This land record does not place Sherod Atkinson/Atkins in the community of the Milliton-Parker Atkins family. Reed Creek of the New River lies in present Wythe County.

31 JANUARY 1775 FINCASTLE COUNTY, VA

Land purchase

"Parker Atheson [Atkinson, Atkins] 144 acres, part of the Loyal Company Grant, on the waters of Sinking Creek, a branch of New River, beginning at a stony knott at the foot of Knobb Mountain corner to John Mann [Marr?]."

COMMENT:

See Map 2. Knob Mountain is about a mile east of the point where Sinking Creek flows into New River. For the one named neighbor, Douthat's abstracts (p. 28, citing Plott Book A:176) present the following:

31 January 1775

"John Mann, 252 acres, part of the Loyal Company Grant, on **both sides** of **Sinking Creek**, a branch of **New River**."

"Thomas Coply, 160 acres, part of the Loyal Company Grant, on the west side of the New River." 45

COMMENT:

Copley appears to have owned two tracts:

- 5 March 1787: he's said to be an adjacent landowner to Jacob Straighley [Straley] on Meadow Creek (the neighborhood of Rev. Richard Whitt).
- 2 March 1790: he's said to be in a tax community bounded by "Back & Neck Creeks, Sinking run, head of Bear Spring, Walkers Creek, White Glade [and] New River."⁴⁶

Copley's 1790 tract lies West of New River. The 1787 location lies East of New River.

6 FEBRUARY 1775 FINCASTLE COUNTY, VA

Land survey

"Joel Sartain, 114 acres, part of the Loyal Company Grant, on the east side of New River and on both sides of Stony Creek." 47

COMMENT:

Big and Little Stony bracket Salt Pond Mountain, across New River from mouth of Walkers Creek. Stony and Salt Pond lie on the east side of New River, Walker on the left. See Map 2.

3–4 APRIL 1775 FINCASTLE COUNTY, VA

Land survey

"Surveyed for **Uriah Stone** 127 acres on **Bluestone Creek,** a branch of **New River**, part of the **Loyal Company's Grant.** Beginning at John Compton's corner. April 3rd 1775. Dan'l Smith, Asst. Wm. Preston, S.F.C. [Surveyor, Fincastle County]"

"Surveyed for **Uriah Stone** 237 acres in **Wright's Valley** on the waters of **Bluestone Creek**, a branch of **New River**, part of the Loyal Company's Grant, beginning at the foot of the **Stony Ridge** crossing the **Spring Run**. April 4th 1775. Dan'l Smith, Asst. Wm. Preston, S.F.C." ⁴⁸

COMMENT:

Undated militia rolls of 1777–83 place this Uriah Stone in the same militia district as Samuel Ferguson, Low Brown, William Watts, and Shered Atkins.

Schreiner-Yantis's 1789 map of Montgomery County shows Bluestone running west from New River through the upper reaches of Tax District C (later Summers and Mercer Counties) into Tax District B (later Tazewell County). It is considerably removed from the Atkins-Glymph-Mills-Sartain neighborhood.

"Ordered that John Taylor, James Burnes, **William McMullen** and Samuel Pepper, or any three of them who being first sworn, do appraise the personal Estate and Slaves if any and make return thereof.

"The report of **William McMullen,** James Bane & Robert McGee the persons appointed to view the way from Michael Prices field to where Grishams path goes into the Catawbo road being returned on Consideration whereof it is the opinion of the Court that the new road be opened as marked by the Viewers, & that Philip Barriger with Robert Greyson, William McMullen, Robert McGee, Robert Ritche, John Crinor, Michl Larke, George Feilder, John Ramy, Harman Cook, Joseph McDonald, Jacob Seiler, James Bane, Wm Preston, Michael Price & Jacob Smith, and their Tithables or any others who may settle within his Bounds do open and keep the same in Repair According to Law."

COMMENT:

The road order, which was recorded consecutively with the two orders for the Beard estate, is a different matter from the estate. However, because William McMullen (and James Burnes/Bane) are involved in both, I am noting the road order to help place the location of **Mills** and Beard.

19 JUNE 1775 FINCASTLE COUNTY, VA

Neighbor

"Robert Hunter, 180 acres, part of the Loyal Company Grant, on both sides of Sinking Creek, a branch of New River, beginning corner to {Sherrod} Atkins [Parker Atkins] and {George or Christian} Martin's survey." ⁵⁰

COMMENT:

The document itself does not identify Atkins or Martin. The compiler of these abstracts adds in brackets what he thinks the identities should be. He errs. Sherrod Atkins' land lay on Reed Creek in what is now Wythe County. Sinking Creek lies many miles to the southeast, running through present Giles and Craig Counties. The Atkins whose land lay adjacent to Robert Hunter should be Parker Atkins, whose land was surveyed in January 1775. The 1774 roll (above) of Burk's Company during Lord Dunsmore's War shows Robert Hunter serving in the same unit with Militon and Parker Atkins, Joel and John Sartain, and Thomas Copley.

Robert Hunter had two daughters whose marriages relate to this study

- 1790, Nancy married Elijah Atkins, with Milliton Atkins as surety.
- 1800, Susannah married William McCoy, with Rev. Alexander Ross of Walkers Creek Baptist Church officiating. ⁵¹

COMMENT:

- On the 1777–83 lists, these individuals appear in the militia company of Capt. James Moore.
- Samuel "Ferguson" and Uriah Stone in 1787 owned land at the head of Bluestone and "in Wrights Valley on Bluestone." 53 Wrights Valley is now in Tazewell, two counties to the west of Pulaski and Giles.
- Mars/Marrs/Mairs/Mares individuals also crop up in association with the families of (a) Elijah and Sarah (Mills) Sartain and John and Frankey (Mills) White of Giles County; (b) William Mills-Witt of Franklin County; and (c) William and Elizabeth (Fontaine) Mills of Henry County. The latter is a known descendant of the immigrant Nicholas Mills of New Kent County whose daughter Jane Mills married George Marr there on 23 March 1698/9.⁵⁴

COMMENT:

This **Private John "Mills"** [or **Miles** in other versions of this list] of Enoch Osborn's company of 1783 would *not* be the same man as the Capt. John Mills of Botetourt. Miles appears to be the correct name for the private. The tax rolls of the 1780s group him with a family whose surname is clearly Miles.

Three of the men on the above list lived long enough to file pensions. Their files at *Fold3* should be studied:

- Ephraim Osburn, R7822, living in Harlan Co., KY, 1834, brother of Capt. Enoch; Jeremiah Smith's affidavit of 15 December 1834 says "my brother Joshua Pennington" participated in the expedition with Ephraim.⁵⁹
- Jonathan Osborn, S8912, living in Ash Co., NC in 1832, brother of Capt. Enoch.
- John Osborn, S32423, living in Fountain Co., IN, 1832, nephew of Capt. Enoch.

One **Robert Davis/Davies** of Albemarle > Amherst was an adjacent landowner to the land that William and Mary Mills of Pedlar River left their son Jesse. That Robert Davis also witnessed William's will in 1755.⁶⁰ At Davis's death, the settlement of his estate referenced land in Montgomery County:

"8 Oct 1787. Thos. Davis, Lincoln Co. – power of attorney to Thos. Jopling, AC to receive of Thos. Upton, Albemarle, 1400 acres in Montgomery County – S side of the great Canaway which my father Robt. Davis, bought of Jas. Mooney ... my seven sisters: Nannah (Hannah?), Abigale, Jane, Martha, Lucy, Ann & Polly Davis and ... my two brothers, Robt. & Olander Davis. Wit: Rich. Farrar, Michl. Thomas, Thos. Jopling, Sherrod Griffin. Orig. del. to Jopling, Sept. 1788."61

However, the research notes that follow for Robert Davis of Montgomery suggest, from two perspectives, that he was not Robert Davis Sr. or Jr. of the Pedlar:

• The Robert of Montgomery's court-order books, whose Montgomery Co. land lay in what is now Wythe County, interacted with a Samuel and William Davis in ways that suggest he was their sibling. No Samuel and William has been placed into the Albemarle family.

• The Robert of Montgomery was a close neighbor to Joseph Atkins of Crooked Creek in what became Wythe County. Joseph Atkins has not been placed into the Atkins family of Doe and Sinking Creeks in Montgomery > Giles who were associates of Montgomery's Frankey and Sarah Mills who appear to be granddaughters of William and Mary Mills of Albemarle.

6 SEPTEMBER 1777–1 APRIL 1778 MONTGOMERY COUNTY, VA

"Stephen Trigg took a list of those who swore allegiance in several companies including McCorkle's Cloyd's, Taylor's, Draper's, and Daniel Trigg's, beginning on September 6, 1777 and ending on April 1, 1778."

COMMENT:

"Col." Joseph Cloyd is said to be the father of Gen. Gordon Cloyd⁶³ (who owned land adjacent to John White of Sugar Run of Walker's Creek) and grandfather of Gordon Cloyd Jr. (on whose land William Mills-Whitt lived in 1860). Deed Book A offers the following for Joseph:

- 1 September 1779, witnessed land sale from Thomas and Sarah Pickens to William Preston, land on Thorn Spring, waters of New River.⁶⁴
- 1781, one of three bondsman for the sheriff Walter Crockett to secure his performance as tax collector. 65
- 1783, adjacent neighbor to land Skidmore Munsey purchased on Back Creek.⁶⁶
- 1785, owner of 35 acres on Back Creek adjoining Peter Dingess. 67
- 1789, owner of 150 acres on Back Creek adjoining Devor and William Thompson.⁶⁸

No Atkins/Adkins appear on this militia roll. By June 1787 an unidentified Atkins was named on a Joseph Cloyd plat with bounds on **Back Creek** and **Walker Creek.**⁶⁹ The Adkins males taxed that year, in that region, were

- Milliton Adkins who served as surety for the Glymph-Mills marriage bond
- Parker Adkins, the putative father of Milliton, who bought Loyal Company land on Sinking Creek at the foot of Knobb Mountain in 1775.
- Champ, Hezekiah, Jacob, John, Joseph, Moses, and Noah Adkins.

Alexander Mares. Signed: Wm. Thompson."⁷²

COMMENT

Back Creek is in present Pulaski County, closely paralleling Walker Creek in Giles County. near Walker's juncture with Sugar Run. (See Map 3) This cluster of waterways (near the point where Pulaski, Montgomery, and Giles Counties adjoin) is the locus of

- "John White Sr." who married Frances "Frankey" Mills (1792)
- John White whose daughter married Robert Whitt (1792).
- Joel Sartain/Certain, whose son Elijah married Sarah Mills (1791), the daughter of Jesse and Lucy (Tilman) Mills of Amherst.
- Thomas Copley Jr., who served as surety on the White-Mills marriage bond owned land, 1787, on Meadow Creek, the watercourse on which Richard Whitt settled.⁷³
- The Gordon Cloyd land—both Gordon Sr. whose land adjoined John and Frankey in the 1790s and Gordon Jr., on whose land William Mills-Whitt lived and farmed in 1860.

Re the Marrs:

 Hundreds of online trees assert that Hugh Marrs came to Montgomery County from King William County, Virginia, where he was the son of an immigrant "John Erskine of Marr." They

cite no evidence of kinship or origin for either man.

On 27 September 1699 one George Marr married Jane Mills (apparent daughter of the well-studied immigrant Nicholas Mills) in New Kent County. George and Jane named their first son Nicholas (baptized 21 July 1700) and a second son George (bapt. 18 March 1701/2) but the St. Peter's Parish register carry nothing more on the Marrs after this point. About the time of the Marr-Mills marriage, a procession list for the parish places Geo. Marr just eight farms from Nic. Mills, on a list of 240 parish landowners.⁷⁴

In this initial survey, I am not taking all notes on all of them—only those that place them socially or physically into the community or any that might identify kinships between them or place of origin.

Jarrett: Richard (land in Fincastle, 1774)

Re *Jarrett*, two sons of William Mills-Witt subsequently married daughters of Allen Jarrett, a resident of both Franklin and Henry Cos.⁷⁷ In 1850, Jarrett lived adjacent to his son-in-law Sparrell Mills in Floyd County (cut from Montgomery).⁷⁸

Transcriber David F. Whitt, in presenting the above research note, does not date it. I am placing it at c1780 because that is the year of the first recorded marriage performed by him within the Worrell abstracts.⁸⁸ Also see the 1782 and 1785 licenses, below.

COMMENT:

Gardner, Joseph, Milliton, and Parker Adkins all saw service in pre-RW wars. Parker and Milliton's 1774 service from Fincastle in Lord Dunmore's War has already been noted. Gardner Atkins saw service some two decades earlier from Augusta:

French and Indian War—Augusta County: Capt. Samuel Norwood ... Lt. Charles Wilson ... Ens. Cunningham ... Robert Willey ... Gardner Adkins [Act of 1758]. 92

Bounty Land Warrants:

"Eight months after the Treaty of Paris closed the French and Indian War [1763], King George III issued a proclamation whereby men who had served in military units from 1754 until such units disbanded were entitled to bounty land. The acreage was based on the rank held ... a private 50 acres. Excluded from coverage were those who served in county militia units. This Royal Proclamation of 1763 closed the territory inhabited by the Indians so that the colonists could not select land in the back country. The same proclamation became the basis for soldiers seeking bounty land after Lord Dunmore's War.

"In May 1779 the Virginia Legislature placed a time limit of twelve months on receiving such land. The claimant, or his representative(s) had to produce a certificate from Lord Dunmore while he was the Royal Governor or from the county court before which proof of military service had been made. Thereupon the Land Office issued the appropriate warrant. Between 1779 and 1783 the Commonwealth of Virginia issued more than 1,400 bounty grants. Most of the land was in the western section of Virginia, i.e. present day Kentucky.

Henry Stafford. Acquitted.

Abraham Morgan. "Charge is supported, but it appearing that he is an Ignorant Poor Man with a small Family, do order him to be acquited after getting 39 Lashes."

Swain Polson. "The charge is proven ... sent to Augusta Goal [Gaol] for further Tryal."

Robert McGee, "The Court are of opinion that he be sent to Goal for further Tryal.

Jeremiah Stover. "The charge is so far proven, as finding him with his Gun Hid in a Barn with Several Tories, & has been known frequently and allways since in this part of the Country to live among them, therefore do order him 39 Lashes."

Thomas Copeley "is charged as the rest & witnesses being sworn & exam^d, The Court are of Opinion that the Charge is" [no futher words].

Henry Lawer. "Acknowledged He was an enlisted Soldier under Howard Haven for the British service. But it appearing to the Court that he was a Youth & advis'd to do so by Haven, & on his agreeing now to enlist into the Continental Service for 18 Months, after his arrival in the G^d Camp The Court are of Opinion that he be admitted to do so & he took the Oath."

Andrew Lawer. Ditto. Refers to "Grand Camp."

George Walter. "He having been enlisted as a Soldier for the British Service But he appearing to be a poor & ignorant Man They agree to excuse him on his Volunt offering to enlist into the Continental Army for 18 Months from the time of his arrival in Gen¹ Washingt Camp. & he took the Oath accordingly."

John Harrison. Acquitted.

John Henderson. "Acknowledges himself sworn by Tho^s Heaven, not to lift arms against the British Army & to adhere to the King of England The Court are of Opinion that he" [no further words].

William Grant. Agreed to enlist in Continental Army "for 18 months from the time of his arival in the Grand Camp."

Walter Stewart. "Charge is not fully supported & that he be acquited on entering into Bond with sufficient Security in the sum of £20,000 for his Good Behaviour."

COMMENT:

This record continues on for another 34 men. I am not noting the rest of the charges and findings. Only Thomas "Copeley" is known at this point to be connected to this Mills research problem. I have included abstracts for the others to better understand the political environment and the manner in which punishment and retribution was administered. The other 34 men were

and occupation as being a tailor. He was described as being 5 feet 3 ½ inches tall, black hair and fair complexioned. He served 18 months and was paid 37 pounds, 14 shillings and 6 pence.

"By early Dec. there were five to six hundred conscripts at the training center. It was under the command of Major-General Frederick William Van Steuben, a German. Workmen hastily built rows of log huts to house the scantily clad men. Many were literally naked and suffered from the intense cold. Supt. Col. William Daview managed to establish a tailor shop to help alleviate the clothing shortage. What a place for a tailor!!

"His name appears on a list of the Virginia Line on Continental Establishment who received certificates for the balance of their full pay agreeable to an act of Assembly passed in the November session 1781, Revolutionary War." 96

COMMENT:

This record does not say where Glymph lived at the time of enlistment. He is likely the man whose name appears on two petitions from "inhabitants of Augusta, Rockbridge & Botetourt":

- 1779, no month or day, in a sequence with "Daniel Stour, Abraham Carlock, Isaac Carlock, Wm. Jackson, Robt. McGraw, Thos. Harvey, James Bently, Michel Francisco, John Francisco, John McCable, **John Gllimph**, Hugh Hicklin, and High Hicklin Junr." The petition was contemporaneously recopied and does not present actual signatures. 97
- 1785, 23 November, in a sequence with "James Bently, John McCabe, **Johan Glimph**, John Byrns, Rhd. Hicklin Junr., Hunchrist Carlock, John Galaspey, Hugh Hicklin Junr., John Clendinan, Robt. Baty, Andw. Beaty." ⁹⁸

Anthony Pate has been found in Mills neighborhoods in Lunenburg, Bedford, and Franklin, including a 1777 Bedford co-association (with **John Mills Jr.** of Augusta and Botetourt) in estate of Irwin ("Irvine") Patterson; and 1780–89 ownership of land on Franklin Co.'s Gills Creek (where William Mills-Witt moved immediately after his marriage; the 1789 purchase was witnessed by James Mills, formerly of Bedford Co.). ¹⁰³

If the persons to be married dwell in different parishes, the Banns are to be published in each Parish & the minister of the one Parish shall not solemnize the marriage until he hath a certificate from the minister of the other Parish that the Banns have been thrice published, and no objection made against the parties Joining together.

"In all your Conduct herein you are to pay the strictest regard to the Laws of this State as you shall answer to the contrary at your Peril: Given under my hand and seal this 16th Day of Dec^r 1782. [Signed] Wm. Preston."¹¹⁴

COMMENT:

The compiler identifies the source of this license in an introduction to her "Part 4, Additional Documents":

"Here are Court records from other sources, and examples of documents that illustrate the activity of the Court. In the earlier parts of this book I corrected the capitalization of all personal names, but I have left this section as it was. The bulk of this assortment comes from Accession numbers (Barcode numbers) 1048924 and 1048926, Montgomery County (Va.) Circuit Court, Montgomery County (Va.) Miscellaneous Court Records, 1750–1861. ... Library of Virginia."

With regard to the Whitt license, she adds:

"See page 90 and 236. Page 87 mentions that John George Schroeder is licensed to solemnize the rites of matrimony and all are to take note, particularly Richard _____. The original is torn at this point, and all I can say is that the fragment of a letter remaining is compatible with a W. In the light of whatever problem prompted the entry on page 236, Mr Whitt may have been a difficult person."

The references the compiler makes to Schroeder and three page numbers appear off-kilter. The "John George Schroeder" reference appears on her p. 92, where the entry is credited to original register p. 339.

While the abstractor proposes that Whitt may have been a "difficult person," the marriage records of the county show that he celebrated a far-greater number of marriages than any minister in the county. The text of the warning to him above suggests that, as a Baptist minister, he may have been marrying couples without the requisite banns being published in the Anglican church in lieu of a license.

In January 1800 Shannon expanded his holdings, as assignee of Henry Farley, with a grant of 60 acres on "the **south side** of **Little Sugar Run**, waters of Walkers Creek, waters of New River **adjoining Joseph Cloyd** and **John White**." ¹¹⁶

Regarding the possibility that the Robert Davis/Davies family *might* have migrated there from Pedlar River of Amherst, one further record suggests that this Robert Davis settled quite distant from the Walker Creek community to which Sarah Mills, daughter of Amherst's Jesse Mills, migrated and married:

On 31 August 1782, Henry Davies and wife Jane of Montgomery sold 140 acres to James Davies Junior for 140 acres "on the head branch of Holston River" which was "part of thirteen hundred acres called **Davies fancy** and adjoining **Robert Davies**." ¹¹⁹

- Muncy (var. "Monsey") bought the Back Creek land from James Thompson on 1–2 May 1775, when the area was part of Fincastle.¹²¹

At the time of the 1860 census, the Gordon Cloyd land lay in Pulaski County; William Mills-Witt, wife Drucilla, son Thomas and Thomas' family and in-laws were all living on Gordon Jr.'s land and farming for him. COMMENT:

- Fort Chiswell was in Tax District B. The Schreiner-Yantis map of 1789 shows it just above the dividing line between A and B, near the site marked "Lead mines."
- Callaway's Iron Works lay in southwestern Franklin County.
- Multiple generations of this Callaway family were neighbors and associates of the Millses of Bedford, as well as Ambrose Mills and siblings of Albemarle. See my reports for those counties.
- In the late 1840s, William Mills-Witt's son Samuel E. moved to Georgia where his offspring intermarried with Callaways. 140

COMMENT:

- One George Boyd died *c*1810 in Franklin Co. VA, owning land in Patrick and other surrounding counties. His daughter Sarah wed Joseph Hobson. They are potential grandparents of Mary Ann Hobson who married Samuel E. Mills, son of William Mills-Witt and Drucilla Kemp.
- Other Boyds in this volume are Andrew, called "Gentleman," and John.





Map 3Tax District A—Montgomery County, *c*1787–1790¹⁶³







Lloyd's 1862 map of Virginia shows "Doe R." running off New River. It is across the river from (and the second stream down from) the point at which Walker Creek runs into New River. (See Map 2.)

In short, Glymph (who took out a marriage bond to marry Frankey Mills in 1788 but did not marry her) was in the same general neighborhood as the man she eventually married, John White Sr.

Containing Five hundred Acres [500 acres] by Survey bearing date the first day of August one Thousand Seven Hundred and Eighty Seven [1 August 1787] lying and being in the County of Montgomery On Cole River and bounded as followeth To wit:

Beginning at a Cucumber and white oak one mile below the fork at the foot of a hill about twenty poles above the third fording of Said River below the forks and running thence South 40° W 100 poles to two black oaks, thence S 7° E 380 poles to a hickory Corner to Said **Smith's Survey No. 20** and with a line of the Same N 40° E 320 poles to a poplar, and leaving said line N 42° W 290 poles to the Beginning.

With its Appurtenances to have and to hold the Said Tract or parcel of Land with its Appurtenances to the Said John White and his Heirs forever. In Witness where of the Said Edmund Randolph Esquire Governor of the Commonwealth of Virginia hath hereunto Set my hand and caused the lesser Seal of the Said Government to be affixed at Richmond on the Twenty Second day of July in the Year of our Lord one thousand Seven hundred and Eighty Eight [22 July 1788] and of the Commonwealth the thirteenth."

COMMENT:

- Cole River (now Coal River) is a tributary of the Kanawa River, now flowing northward through Western Kanawha Co.
- Big Cole/Coal River rises in Raleigh Co. from Clear Fork and Marsh Fork near Whiteville.
- Little Cole/Coal River rises from the Spruce Fork in present Logan Co. and Pond Fork in present Boone Co.
- While maps seem ambiguous for this period, it appears that Little Cole could have later fell into extreme East Cabell along the Giles line.¹⁷⁶

Both Big and Little Cole River lay in Montgomery prior to 1789 when Kanawha was created.

John Toney also received a grant on Cole River, as **assignee of Smith**, Treasury Warrant no. 18750 issued 14 August **1783**, being 344 acres **surveyed 7 March 1787**. ¹⁷⁷

The John White above appears to be the "John White Sr." (husband of Frankey Mills) whose family associated with John Toney in Giles County from the time Giles was created through the 1830s. (See my reports of Giles County and Giles County tax lists.)

Various Akers appear in this volume and on the tax rolls, in the same district with Glimp, Thomas Mills, and Whitt—but not a *Milliton*.

This volume has no index. It arranges marriages by the surname of the groom and probate data by the name of the deceased. I have read every entry throughout the volume in search of relevant names that are embedded.

The actual marriage bond (below) identifies the surety as Milliton *Atkins*. **Frankey Mills apparently did not marry Glimp.** He subsequently appears in Newberry District, SC, with a different wife by whom he left many offspring. Meanwhile, an 1807 marriage bond in Giles County, VA, for **Samuel Mills** to marry Rachel Prince, includes the permission of two sets of parents: "John & Frankey White" and "John & Rachel Prince." ¹⁷⁹

From the actual bond, we may deduce two things:


- Frances "Frankey" Mills who married John White Sr. in Montgomery soon after 19 August 1792 [see that date below], with Thomas Copley Jr. as surety and Rev. Alexander Ross as officiant, was almost certainly the 1787 woman identified in the Glymph-Mills bond as "widow Farney [Fawney?] Mills."
- For the potential birth family of Frankey, we might begin with the family of Milliton Atkins, her bondsman.

COMMENT:

- In 1801, the testator's daughter Sarah Weacks (and husband William), were residents of Montgomery Co when they sold their inherited land to the testator's grandson Samuel [Mc] Carril—the man in whose presence William Mills-Witt first emerged on the 1806 tax roll.
- Note that the testator did not use the "Mc" prefix for his grandson.
- The testator is previously named as a son in the 1786 Bedford Co. will of John Ferguson/Farguson. Bedford records also call the son, "John Ferguson Jr." 182
- Note that John Ferguson (whose Menafee tract went to Samuel McCarrell, in whose presence William Mills-Witt made his first adult appearance in 1806), operated a mill—as did John Toney of Giles for whom William Mills appeared to be working in April 1816 or 1817.

COMMENT:

Most online trees assert that Parker Adkins Sr. was the father of Milliton Adkins who served as surety for the 1788 marriage bond of John Abraham Glymph to wed "Widow Frankey Mills." The Parker above may have been a younger man, Milliton's son.

Note that Sarah Mills, Frankey Mills, and Parker Adkins all belonged to a congregation headed by Rev. Alexander Ross. A cursory scan of published literature for Montgomery County provides the following information on Ross:

10 Jul 1770 Alex^{dr} Ross, 1 tithe, list of James Robertson (Capt. David Robinson's Co.) "on the North & South Fork of Rone oak." None of the other individuals are names associated with other individuals in this project.

1772 Alex^r Ross, 1 tithe, "John Bowmans List" [also Robertson community] 192

1773? Alex^r Ross, 1 tithe, "List of Titheables taken by Chisom" [including Robertsons]¹⁹³

"Rev. Alexander Ross purchased 150 acres on the head of Kittle Hollow on the waters of Devil's Den in Montgomery County (VA), 23 May 1783, and sold it on 4 March 1804. He purchased 109 acres on Den [Doe?] Creek, one of the waters of the North Fork of Roanoke River in Montgomery County (VA), 24 June 1789, and sold it 5 April 1804. These two transactions suggest that Alexander Ross lived in Montgomery County (VA) from 1783–1804. He was the minister of North Fork of Roanoke Baptist Church in Montgomery County (VA) from 1788–1789 (and possibly from 1783, when that church was constituted, until 1789) and of Walker's Creek Baptist Church in what was then Montgomery County (VA) and is now Giles County (VA) from 1789–1793. He probably remained active as a Baptist minister from 1793–1800 because he performed 89 marriages in Montgomery County between 1791–1800, and 8 marriages in Botetourt County (VA) from 1793–1795."

"Rev. Alexander and Barbary Ross witnessed and signed the will of Michael Drake dated 11 Dec 1797 in Montgomery Co., Va. Michael Drake was married to Jane Davidson. The will of Michael Drake was presented for probate at the Montgomery Co. May Court 1798. A settlement of Michael's estate was made from Giles Co., Va. on 1 Nov 1816 and signed by Janie Ross and some of her and Michael's children. A note written by Janie's name says: "widow of Michael Drake m. Alexander Ross 1803 Mont. Co. VA." The deed was approved at Giles Co. June Court 1817."

"Marriage: 7 September 1803, Montgomery County, Virginia, to Jane Ross Davidson.¹⁹⁸

This biographical data, if correct, suggests that the Sartains, the Whites, and Frankey and Sarah Mills belonged to Ross's Walker's Creek Baptist congregation. HomeTownLocator.com provides the following:



All of these families need to be studied—but particularly note the following:

- Atkins appear to a backbone of Ross's church, appearing more times than any other
- **Burtons** appear three times. (In 1786, Bedford County, one Elizabeth Mills married William Burton and seems to disappear from the county. Parents of neither are known.)
- McCoys appear twice.
- Webbs appear twice and were inlaws of the Atkins.

Additionally, this read of Worrell's marriage compilation reveals seven instances in which Milliton Atkins served as surety for someone's marriage bond—only one other time for an individual or couple married by Ross. In chronological order, his actions were:

Two things are worth noting in this set of entries:

- 1. **The intermarriages between Mills, White, and Whitt.** This may be relevant to our search for the parents of William Mills who carried the Witt Y.
- 2. Parts of the Marcum family also lived in Franklin County, where they appear amid tax roll records of William Mills-Witt and his in-laws.

Re the surety, Thomas Copley Jr.:

The following **Copley-Lawrence marriage** (same page) might prove to be significant, considering that one daughter of William Mills-Witt married a John B. Lawrence, son of John Lawrence, here in Montgomery Co. in 1854.²⁰²

• "Copeley, Joshua, and Elizabeth Lawrence. **John Lawrence**, surety—Apr. 11, 1804." Most online trees assert that Joshua was the son of Thomas Copley Sr.²⁰³



COMMENT:

Re Daniel Tilman: the only known man of this name in this era was the brother-in-law of Jesse Mills and maternal uncle of Sarah (Mills) Sartain of Montgomery, who named her daughter Lucinda Tilman Sartain. In 1787–92, Daniel and his brother and father (Thomas Tilman Sr. and Jr.), appear on the Fluvanna Co. tax list of John M. Haden (subsequently Hezekiah Stone and Thomas Winn), along with Archibald, John, Patrick, and René Napier (the latter two intermittently lived in Montgomery and Amherst). I've not yet pursued them past that point.


Re uncertainty of the county:

Daniel Tillman has not been otherwise placed in Montgomery or Franklin. Patrick cannot be assumed. The **1797 and 1798 tax rolls** of Patrick includes a **William Witt** and Charles Witt (who did not submit lists on the same day—but no others in his grouping appear on the tax rolls.

COMMENT:

Without documentation, numerous online trees identify Obediah as the son of James and Elizabeth (Larkin) Bias of Amherst County; James allegedly was born 17 May 1722 at Milltown, Carlow, Ireland, and came to Virginia by way of Pennsylvania.²¹⁶

A search of Virginia Land Office grants via the new search engine at *Library of Virginia* has not turn up a grant for John Hammon(d)(s) or variant spellings.



I do also Will to **my beloved wife** [not named] her equal one third of all my personal Estate her Natural life time the balance to be equally Divided between **my three daughters.**

"(To Wit) **Elizabeth Cassiday, Ruthy Whitt, and Susanna Creswell,** and also Should there be any part of my Wifes Legasee left at her death also to be equally divided among my three daughters and their Heirs forever. And for the good performance of my will and to execute the content I do appoint *John Ingles* and my son Archibald Whitt to act as executors. And it is my request as I can to leave the fullest confidence in them that they shall act without being bound in security. Signed and Subscribed to this my hand and seal this 25 day of April 1807. Richard Witt. Test: William Casseedy, Thomas Farmer." ²³⁹



"The assessment tickets for Wythe County in 1815 are listed below. The acreage, loction of the land, the buildings on each tract, and the number of slaves are given. The size of many of the houses are also described. In 1815, Wythe Couty included part of Bland, Smyth, and **Pulaski** County; consequently, many of the residents are from those areas. The Town of Evansham (now Wytheville) was also referred to as Wythe Court House, abbreviated C.. or W.C.H. The list is incomplete, because some of the tax tickets were destroyed or lost. There are two brick houses mentioned (Jacob Kent, and Thomas Warner) but most are made of wood, either frame or log."²⁴⁶

Wythe tax entries are in alphabetical order, diminishing the ability to determine neighbors.

"The ones from Washington County include a couple in the alphabetical listing D and many from E through the end of the alphabet. In Wythe County, many were for the Graham and Miller families, and several of Simmermans, among others.

This supplement has an every name index although the entries have been arranged alphabetically."248
