FOCUS: 1. Pre-1815: All Millses in this set of counties.

2. William Mills-Witt who emerged 1806 in Franklin, lived there intermittently until his marriage in 1815, is mising 1820-30 from Franklin tax rolls, returned 1830 when he inherited land from father-in-law Robert Kemp, was taxed on that land in 1848 as a resident of Floyd County, enumerated 1850 in Floyd, enumerated 1860 in Pulaski, d.

c1863 likely in Pulaski, widow Drucilla d. 1866 in Montgomery County¹

EXCLUSIONS: For the post-1815 years for which William's presence is known, I did not read petitions

of other counties. For years that William's presence is unknown, I read petitions of all

this set of counties.

EXECUTIVE SUMMARY

Many of the signatures on these petitions are faded and torn. The research notes that I've taken tell us the following:

- Middleton Atkins (Adkins), who served as surety for the 1788 Glymph-Mills marriage bond, was first found on a 1787 petition from Montgomery County.
- John Glymph (Johan Abram Glymph) is first found in August in 1779 and November 1785 as a near neighbor of John Clendining. He was not a consigner with Clendenin on 1 December 1778. After his planned 1788 marriage with Frances "Franky" White fell through, he is not found on subsequent petitions.
- John White Sr. and Jr. of Montgomery (Sr. being the man who married who married Frances "Franky" White in 1792) also make their first appearance in 1787. Their origins remain unknown. A

Thus, in my study of Virginia Millses, I am referring to him as William Mills-Witt.

John White Sr., John White Jr., and John White also appear in Louisa County from 1786, in close proximity to Fleemans.

- Blayney Mills of Augusta, brother of Hugh and John Sr., is last found in Botetourt, November 1787.
- Charles, John, Robert, Nathaniel, and Nicholas Mills—descendants of the well-known immigrant Nicholas Mills—were the only Mills found in Louisa. Jesse Mills Jr., who is known to have been in Louisa c1798–1803, was not found among petitioners.
- Hiram Mills of Franklin, grandson of James of Franklin, appears 1821 in Grayson County.
- Hugh Mills, formerly of Augusta and brother of Blayney, is also last found in Boutetourt in 1787.
- James Mills, unidentified, appears in 1783 Botetourt amid several Crows, signing adjacent to John Mills and near William Mills. These three have not been conclusively identified, but appear to be rooted in the Alexander and Gilbert Mills family of Augusta, where men of their name from the 1760s forward associated with Crows.² (This John Mills would not be John Sr. of Botetourt, who died by 1782. He would appear to be John Jr., who was enumerated in Botetourt in 1785 as the only John Mills there and head of a family of eight.³) In 1789, the Botetourt will of Samuel Baldwin named his widow Mary "and her brother James Mills" as executors.4
- James Mills of Franklin first appears on petitions South of Staunton River in December 1779. This was about the time he married—possibly to a Slone. His signature appears near one Patrick Slone, but not in the big cluster of Slones where he would appear when he next surfaced in 1782. Later petitions also place Patrick amid that larger cluster.
- Samuel E. Mills of Franklin, son of William and Drucilla, last appears there in late 1850.
- William Mills, unidentified appears on Botetourt petitions of 1783 ("Wm Mills"), 1786 ("William Mills") and 1789 ("Wm Mills"). He has not been found thereafter. The William of the 1780s could not possibly be William Mills-Witt. The William of 1825 does not appear amid known associates for William Mills-Witt.
- William Mills-Witt is likely to be the William Mills found on the 1814 Montgomery petition, near a Samuel Maddox, a few months before his marriage in Franklin County to Drucilla Kemp, stepdaughter of Sarah Maddox. While he was first taxed in Franklin in 1806, he is intermittently missing prior to his marriage.

[Document] "Since our independency has Been happily Confirmed our Country has Grown more Popular and of Consequence our Publick Business more Accumilated and as we now do and always have Laboured under very Great Disadvantages by our Extreme Distance from our Court of Justice So that Numbers of us having Seventy or Eighty and Some few near one hundred miles to travill which Considerating the Mountainousness of our Country with the Crossing of Rapid rivers which in times of high waters is very Dangerous and Rendezvous Situations Still more Grevious and Burthensome ... [request that a new county be drawn with the following lines]

"Beginning on the top of the North Mountain on the line that Divides Rockingham from Augusta and

- along the ridge that Divides the Waters of the South fork and North river untill the head of the Cowpasture waters,
- then along the ridge that Divides the waters of the two Rivers of the Calfpasture on the west from the waters of the Middle River on the East Side thereof untill where the Said Rivers of the Calfpasture Enter the Gap of the Mountain
- thence along the Ridge which Divides the Waters of Gays run from Kerr's Creek waters till the head of Pdds Creek,
- thence Down the Same Creek to the Cowpasture River and thence a Streight [line] to William Manns Plantation on Jacksons River and from thence with a Streight line to the head of Anthony's Creek,
- from thence along the ridge which Divides the waters of Doughthers Creek and Naps Creek from the waters of Beaver Lick Creek, and
- thence in a Streight line Crossing Green Brier River at the Mount of Sweago Creek, thence up the said Creek to the fork thereof and up the South fork thereof to the head,
- thence North-Easterly along the top of the Allegania Mountain which Divides the Elk, Monongahalia and Chest Waters on the western Side from the Waters of Green Brier and the Waters of the North fork of the South Branch on the East Side untill the Rockingham Line,
- thence with Said line Crossing the North fork South Branch and South fork until the Beginning."

- This may be John Glymph Sr., rather than John Abraham Glymph who fought in the Revolution and subsequently (1787) posted bond to marry the widowed Franky Mills in Montgomery County.7

COMMENT:

- The Ewings were the inlaws of John Mills Jr. of Bedford, Augusta, and Botetourt.
- Lemaster Cooksey was formerly in Amherst, where he appears in deeds with Larkin Bias. (The Amherst Bias family is widely said to be the birth family of Obediah Bias who in 1796-98 settled in the Montgomery > Giles community where the "lone" females Frances "Franky" and Sarah intermarried with the John Whites, Sartains, and Whitts, and Atkinses.

The Glymph-Mills marriage appears not to have occurred. John Abra(ha)m Glymph appears extensively thereafters in record of Newberry, SC, with a different wife. Meanwhile, in 1806, one Samuel Mills posted a bond in Giles County (cut from Montgomery) to marry Rachel Prince; both sets of parents gave permission: "John & Franky White" and "John & Rachel Prince." Montgomery Co. marriage records document the 1792 marriage of John White Jr. to "Frances Mills." See John Vogt and T. As an alternate hypothesis, we might consider that the John "Abram" Glymph of the 1787 marriage bond was the elder John Glymph, while the younger settled Newberry and married someone else. However, when Franky married John White Sr. in 1792, she married under the Mills name—implying that she had not remarried and was still the widow Mills.

- This list includes a Thomas Watts and two William Wattses. I am not pursuing the Wattses there in that time frame. My line relocated to SC c1756–63.



Residents South of Staunton River thank the legislators for the division of Bedford County in the last legislature but report that a substantial number of inhabitants south of the Staunton are still suffering inconveniences due to distance from the courthouse and hardships of travel; the people south of the river will propose a further division, and the signers—who live north of the river—support that petition.

This James Mills and William Mills of Botetourt have not yet been identified. James's signature just after John would seem to suggest a kinship. It seems likely that they were also sons of John Mills Sr., who died in 1782. **His full probate needs to be studied.**²⁶ This William Mills of Botetourt also signed petitions in 1786 and 1789.

John C. Fleeman also continue to appear occasionally for another two decades.

I am noting Fleeman because Charles Mills, son of William Mills-Witt and wife Drucilla Kemp is said to have married Sarah Fleeman 22 December 1757 in Montgomery County where Millses were intermarried with a John White Sr. and Jr.36 I have not seen evidence of parentage for Sarah Fleeman or her family and have not yet begun to seek the family.

The origin of John White Sr. and Jr. of Montgomery is also unknown. Several Louisa petitions in the years before and after carry the names "John White," "John White Sr." and "John White Jr.," with some variances in the signatures.

In mid-1798, Toney took a partner: Robert Wilson. Wilson had a stock of merchandise. Toney provided a house on his plantation in which to open a store, along with the promise of lodging and board in exchange for 1/3 of the profits. In early 1802, the partnership dissolved—bitterly.

This is how we date the petition.

- Monroe County, which the petitioners wanted to join, was created in 1799.
- The Toney-Wilson partnership dissolved early in 1802.
- The cooperative efforts of these two men, seen in this petition, would place the petition at 1799–1801.

The partnership also explains why the 2 sheets exist with duplicate names.

Typically, petitions of this type were placed in stores and taverns, at mills, and other gathering spots.

- The sheet headed by Wilson would be the one he kept in his store, for customers to sign.
- The sheet headed by Toney was likely kept in his "public house" to take advantage of that traffic.

And then there is the sheet pasted onto the bottom of Toney's sheet, in a different format. That wasn't mentioned. But the difference in paper and penmanship suggests it was created at a third locale—logically Toney's mills.

Consequently: 42 names are duplicated. Those 42 men were importuned at different locales, on different days, when they were in the company of different men and different family members.





Thence along the Top of said Montain [sic] and with the Montgomery and Monroe Line to the Intersection of Botetourt County Line: and with the Botetourt and Montgomery line to the Top of the Gap Mountain. Thence along the Top of said Mountain to New River, crossing the same to the end of Walkers Creek Mountain. Thence along the Top of said Mountain to the intersection of Wythe County Line. Thence Northwestwardly with said line to the intersection of Tazewell Line: and with the Tazewell and Montgomery Line to the Top of Wolf Creek Mountain. Thence southwestwardly along the said Mountain to a point Two Miles below the mouth of the Clare fork of Wolf Creek, then a Strait Line to the head of East River called and know[n] by the name of the Big Spring. Thence a Straight Line to the head of Crane Creek on the Top of the Flat Top Mountain. Thence a strait Line to the three forks of Guyandott River. Thence down said River until it intersects Kanhawa County line. Thence with the said Line to the Beginning, forming a County about one Hundred miles Long and about forty Broad, Leaving

The six signature pages attached to this petition show duplications of more than a few names—including those of the White family. Typically, when a petition was created, multiple copies were made and posted at or taken to the major "community gathering spots" in the county: the courthouse on court days, the muster grounds on muster days, and the local taverns. Sometimes a determined instigator of a petition might even go door to door. Signatures would be taken on separate sheets. Note the petition of 4 June 1828 at which time Burwell Law signed immediately after William Mills's brother-in-law "William Kemp son to Ro."

However,

- William Mills has not been found on Franklin County tax roll from 1820-30.
- The William Mills signature above does not in any way match the William Mills signature on his 1815 marriage bond.

I am not convinced that this William of the 1821 petition signed his own name. Many signatures seems to be in the hand of one writer. As an example, I've included, above, a sample of the "signature" for Wm Wingfield, taken from image 16, col. 1.

A Joseph Miles and a Henry Miles also signed the petition—in fact, there are two such listings for Henry, clearly not Miles.

*These three men and various others in cols. 1 and 2 of this page have a dark X or + (the mark is ambgious) after their names. However, the X's do not represent "signature marks." These appear to be tallies of some sort. Note these two "tells" on the attached image:

- The ink of the X (or +) is noticeably darker than the ink of the signatures.
- The signature of "James his X mark Haner" carries the signature mark in the middle of the name, as customary. Yet it also carries the dark X at the end.
- The X that appears with the name Allen Christian Senr. is written amid his name, but does not carry the customary "his mark" statement. It is almost certainly a later addition.







This Logan County petition includes a survey showing the proposed location at the junctur of Guyandotte River and Peter Huff's Creek. Not surprisingly, the land was surveyed for Gordon Cloyd.

Note on the image below that the chair carriers for this survey in 1795 were Wm. Farley and "John White." White has no appendage after his name. John 'S' White owned land adjacent to Cloyd and the Farleys on Little Sugar Run of Walker Creek. However, the 'S' that he made on his 1796 bond to marry Susannah Marcum was extremly shaky, suggesting advanced age—an hypothesis supported by the fact that Susannah appears to be on the 1798 tax roll as a widow charged with two young tithable males (ostensibly stepsons) who were still underage, then dropped off th eroll in 1799 when two young tithables (including a John) came onto the roll. All things considered, it would seem more likely that the John who served as chain carrier was the younger John, a healthy male in his late teens. 158

Furthermore, "A surveyor of a road is appointed by the Court of his County without asking or requiring his consent. He is compelled to continue in that office untill another is appointed by the said Court in his stead. It matters not wether he is a man of industry or judgment; it matters not what are his general avocations; it matters not how frequently his business requires him to be absent from home. He is compelled to serve, and as this office is not one that is desirable, the courts frequently appoint persons that are fit for no appointment whatever."

In short: the system and the law needs overhauling because nobody wants to do road work. Grand jurors tend to overlook problems with roads because, if the overseer is thrown out of the post, one of them may have to fill it. If the grand jury brings charges, then the petit jurors are road hands themselves and may well have worked on the road whose overseer is being charged. Consequently, not one in ten men are convicted. Although the law says that hands will be fined for failure to serve, few "feel very little inclination to work" because they know the odds are they won't be fined. "Individual convenience







- Again, William did not sign, even though he is concurrently on the tax roll.
- John Mitts does appear from other local records to be a Mitts, not Mills.



The road running as usual in this County thro' a valley between two Mountains—and utterly impossible to be made such a road as described in the Indictment. He went to trial believing that he had done his duty, but the said road being required to be 30 feet wide and no evidence admissible to show a less width, he was fined, and has been obliged to give a delivery bond. Your petitioner being thus aggrieved to having no other alternative is forced to ask that your Honbl.

This is surely Robert Whitt, Jr. Robert Sr., as an RW veteran, would be too old to have this duty assigned to him.

The petition and signature is not own writing. There is no notation saying that it is a clerk's copy. However, image 3 of this file depicts the presentment of the grand jury, under **Mastin White**, foreman; the handwriting is the same as Robert's petition, but this document is signed "Copy Teste Edwin Robertson, Clk."

Image 5 of the file carries an incomplete document which reads:

"Dr. Sir. Mr. Whit requested this petition sent you, lay it before the house, they will send it to the proper committee. I think by your attention it will pass. It is a reasonable one and **Mr. Whit ought not pay the fine. he is a poor man** and had his road been 29 feet wide and cleared – he might have been fined because the court had not directed a less width. There is nothing new here it is court day and Snowing—a bad winter So far—Your friends are well in fact every thing is at a stand—I should ..."

A sheet of some sort appears to have been placed over the rest of the document before filming.

In 1860, Gordon Cloyd lived adjacent to William and Drucilla Mills' son Thomas and one household from William and Drucilla.



COMMENT:

Although Samuel E. Mills remained in Franklin County after his parents and siblings moved to Floyd, I have not seen on these petitions any signers of the surname "Hobson"—i.e., potential family for Samuel's wife.

Union Hall is today a "census designated place" about 7.6 miles east-to-northeast of Glade Hill, on the banks of the large lake that juts inward from Staunton River. ("As the crow flies" is about half that distance.)
