BACKGROUND:

Sarah Mills is a candidate for the mother of one **William Mills-Whitt** (b. *c*1783–88; d. *c*1863) who married 1815, in Franklin County, VA, William's wife **Drucilla Kemp** had been born to the 1786 marriage of Robert Kemp, of Kemp's/Camp's Ford of the Blackwater River, and Millie Edmundson (daughter of Richard). Drucilla's stepmother, from 1802, was Sarah **Mattox** (daughter of Nathan). Bondsman for the marriage of William Mills to Drucilla Kemp was Stephen **Standifer** of a nearby Blackwater family.¹

In 1814, William appeared on record in Montgomery County signing a fishing-industry petition with Samuel **Maddox**, James **Light**, Andrew **Wilson**, and other residents of Montgomery's Little River. In 1816, William appeared on record in Giles County (cut from Montgomery in 1806) witnessing a land lease between a tenant **John Conner** and the landowning John Toney (son of William Toney and wife Margaret Chastain of the Blackwater in Franklin; Margaret is said to be a granddaughter of William **Witt** of Albemarle County). John Toney's land, mill and tavern lay at East River and the Narrows of New River.

William's birth family is unknown. He cannot be attached to the one Mills family found contemporaneously in Franklin—that of James Mills of Maggoty (now Maggidy) and Elliott Creeks, who first surfaced on the 1782 tax roll of Bedford.² After the 1785 creation of Franklin from Bedford and Henry Counties, James's residence fell into Franklin.

William's Y-line is not a Mills Y. Rather, it is that of descendants of the Virginia immigrant John Witt/Whitt. For the purpose of identification in this ongoing project—one that involves numerous William Millses—I am calling him William Mills-Whitt.

Mills research in all surrounding counties has narrowed the search to two single mothers surnamed Mills who made their first appearances of record in Montgomery County in 1788 and 1791:

- Sarah Mills, who wed Elijah Sartain in April 1791, with the Rev. Alexander Ross of Walker's Creek Baptist Church officiating; and
- Frances "Frankey" Mills who was wed to John White Sr. in August 1792 by the same minister. B

Both women bear names that William and Drucilla gave to their two daughters: Sarah, b. c1830, and Millie Frances, b. April 1832. ("Millie" was the name of Drucilla's birth mother.)

In his sixties, this William Mills turned over his Franklin County land to a son and moved with his wife and unmarried adult children across the Blue Ridge into Montgomery County. The tax rolls of the 1850s place them in a small locale physically bounded by the town of Radford on the north, New River on the West, Little River on the South, and Meadow Creek on the East. That was, perhaps coincidentally or perhaps not, the neighborhood settled in the 1770s by Rev. Richard Whitt who willed his plantation to his son Archibald Whitt. In the 1850s, when William Mills-Whitt arrived, the land was occupied by Archibald's sons Abijah and Hezekiah Whitt, born c1795–96 and 1800–1 (according to the 1850 census).

Prior research in Montgomery and Giles focused heavily on Frankey and the Whites. Coupled with autosomal DNA results, some eight hundred hours of research sorting the Montgomery > Giles Whites and tracking their offspring remain inconclusive as to whether Frankey might be the mother of William.³ Research is now focusing upon Sarah Mills and her Sartain network. Several dozen offspring of Sarah (Mills) Sartain, through her daughters Lucinda (Sartain) Williams and Elizabeth (Mills) Chapman, are DNA matches to descendants of two different sons of William and Drucilla.

SARAH "SALLY" MILLS, born c1768, married Elijah Sartain (var. Certain, Sartin) by bond dated 7 April 1791, in Montgomery Co., VA;⁴ she apparently died between the 1840 and 1850 censuses of Gallia Co., Ohio. By Elijah, she bore (among others) a daughter whose name was written as "Lucy Tilman Sartain" when she married John Williams at the age of fifteen in 1818.⁵ No document has been found that explicitly names Sarah (Mills) Sartain as the daughter of Jesse Mills and Lucy Tilman. However, the reliably documented fact that Sarah named a daughter "Lucy Tilman Sartin" does strongly suggest Sarah was Lucy Tilman's daughter.⁶

Beyond reasonable doubt, Sarah was the mother of an older daughter born 1790–91,⁷ prior to her marriage. When this child, Elizabeth "Betsy" Mills, married their neighbor Archibald Chapman on 26 March 1811, Sarah's husband Elijah Sartain petitioned the court to have himself appointed her guardian, for the purpose of authorizing the marriage, and then served as bondsman for the groom. The 1810 Giles Co. household of Elijah and Sarah contains a female in this age bracket. The 1860 census of Gallia County, OH, places Elizabeth's widower, Archibald Chapman, next door to his proposed sister-in-law Lucinda Tilman Sartin and her husband John Williams.

When Giles Co. was cut from Montgomery in 1806, the Sartin neighborhood fell into Giles. In 1809 Elijah Sartain purchased, from other heirs of his father Joel Sartain Sr., the family land on Stoney Creek of Giles. On 4 October 1814 in Giles County, "Elijah and Sally Sartain" sold their land at the mouth of

Thus her birth should have occurred after March 1790—but before her mother's marriage on 7 April 1791. Her Chapman offspring claim for her a birthdate of 12 March 1787 *in Connecticut*; their attached evidence, however, is a published vital record for an entirely different Elizabeth Mills.

Elizabeth (Mills) Chapman's broken tombstone is inscribed: "Elizabeth wife of A. Chapman Died [unreadable] 8, 18_..." Descendants give the death year as 1857 and state that she was aged 71. The tombstone also states that she was "_1 Yr's, 8 M's, 18 D's" at time of death. Dying at age 71 in 1857 would place her birth in 1785–86, which is incompatible with the fact that she required parental or guardian consent to her marriage in 1811. Of the two conflicting pieces of evidence, the legal guardianship created to enable her marriage would be the more reliable.

Chinquepin Hollow, noting that the tract was adjacent to John Sartain and "Roberts"; on 19 November, they acknowledged the deed before justices of the peace Christian Snidow and Benjamin Peak¹¹ and then dropped from Giles County records. ¹² By March 1818 they were established in Gallia County, Ohio, where their daughter Lucy married that month. The 1820 census enumerates Elijah and family in Gallia, adjacent to the new son-in-law John Williams. Elijah's 1820, 1830, and 1840 households included a woman of age to be Sally; but in 1850 he lived alone, still adjacent to their daughter Lucy Tilman (Sartain) Williams. ¹³ In 1860, as previously noted, he lived adjacent to the Chapman widower of Elijah's proposed stepdaughter, Elizabeth Mills.

Online trees generally assert four children for Sarah and Elijah Sartain:¹⁴

- 1. JAMES B. SARTAIN, b. c1802, Montgomery County, VA; m. Elizabeth Williams 16 April 1831 at Maysville, Mason County, KY; d. 1858 at Maysville. On censuses for 1840 (Mason Co.), 1850 (Adams Co., KY). However, the location of the marriage raises questions as to whether this James B. Sartain was the son of Elijah B. Sartain who settled Kentucky. I have not yet explored this point.
- 2. LUCINDA TILMAN SARTAIN, b. 20 April 1803, Montgomery County, VA: m. **John Williams**; d. 28 November 1876 or 19 November 1877, Guyan Township, Gallia Co.
- 3. SUSANNA SARTAIN, b. 1806; d. 1862. However, the 1820 census of Elijah and Sarah's household does not include a female in this age bracket.
- 4. MARY JANE "MOLLY" "POLLY" SARTAIN, b. 1812; m. 10 May 1832, Gallia Co., **William "Billy" Bowen"**; d. 1876. Billy Bowen is said to have died 25 October 1876 in Ohio at which time he was buried in "Rome Cem (old part)." However, the 1820 census of Elijah and Sarah's household does not include a female in this age bracket.

land; and (2) Elijah B. remained in Garrard Co. and is enumerated there in 1830 while Sarah's husband Elijah is enumerated with his family in Gallia Co., OH, from 1820 through 1860.

SUMMARY OF FINDINGS

Sarah (Mills) Sartain:

Sarah appears in no record found to-date in Gallia. Her husband Elijah made rare appearances. He did not purchase land or leave an estate for probate. The 1840 census household headed by Elijah includes a female aged 60–70, presumably Sarah. That female is not in his household in 1850. I have found no newspapers for the time and place with an obituary—and no contemporary church records that might cross her off the membership list in a certain year.

Previously unidentified sons:

Census household data and sequences in Gallia County suggest that Sarah and Elijah were the parents of one or two sons not included in online trees:

JOHN SARTAIN, b. 1790–1800. Married Ann Johnson, 7 May 1823, Gallia County. In 1820, Elijah Sartain was enumerated adjacent to William Johnson. In 1830 John and wife were enumerated four houses from John Williams who married Elijah's daughter Lucy Tilman Sartain. In 1831 John and Ann sold their land and dropped from the Gallia County records that I have used to-date. He has not been found elsewhere in Ohio or states to the west on the 1840 or 1850 censuses. He appears to be the John Sartain, of compatible data, enumerated on the Logan County, Virginia, census of 1840¹⁷—a man who was not enumerated there in 1830 when John of Gallia was enumerated in Guyan Township of Gallia. (Logan, now in West Virginia, was created in 1823, partially from Giles and Kanawha Counties. In 1850 one Ann Sartain, aged 45, marital status not shown, was enumerated in the Logan County household of Isacc and Keziah Brewer, adjacent to a William Sartain family, in the same district with Robert and Peggy Whitt. 18

This William Sartain does not fit into the Elijah Sartain household, as enumerated in either 1810 or 1820. According to the 1850 census, he was born about 1807 and married Telitha [—?—] before 1830. The census five "children" in their household—James M. (21), Frances (18), Lewis V. (10), Andw. J. (9), Sarah 5—as well as one Rebecca Brewer, 36. Adjacent to William's family is a young couple that may represent his married daughter: James Brown (22), Lucinda (21), and Evaline Brown (1). 1850 U.S. census, Logan County, VA, pop. sch., dist. 32, p. 151 (stamped), dwell./fam. 449/449 W M [or Wm] Sartain household

Relocation:

1814 30 Aug Elijah Sartain & Archibald Chapman served on jury in Giles Co., VA.

1814 4 Oct Elijah & Sally sold their Giles County land to George Snidow. Last appearance in Giles.

1814-15

Probable arrival of George Chapman and Patrick Napier in Gallia County, OH. 1817 22 July

The earliest date found in Gallia for the Giles County Brumfields, Chapmans, or Napiers is 22 July 1817—the date on which the brothers-in-law George Chapman and Patrick Napier received a jointly titled patent to W¼ of S6 T5 R16. As a general rule, two or so years would have elapsed between (a) the date they filed for the land at the U.S. Land Office; and (b) the date the patent was issued. As a general rule, settlers chose the site, began clearing, and made at least one crop prior to their decision to file for the land.

This timeline suggests that George Chapman and Patrick Napier arrived 1814-15, with at least one crop made in 1815 or 1816.

1817-1818 Joel Sartain, Elijah's brother, stated in his pension application that he left Montgomery >

Giles in "1815 or 1816 (he does not recollect which)" and moved to Kanawha County, VA, where he lived two years before settling in Gallia. Given that no record has been found in Gallia for Elijah or Sarah prior to 1818, it is likely that they were also in

Kanawha with Joel.

1818 26 Feb This is the earliest date of record for the Sartains in Gallia. It is the date that Sarah and

Elijah's daughter Lucinda Tilman Sartain married John Williams. Odds are, the Sartains were in Gallia at least three or so months before the young couple wed.

Ping-pong Migration:

Joel Sartain's pre-Gallia residence in Kanawha County (now West Virginia) explains several subsequent events documented in this report.

- Robert Whitt Jr. on 20 March 1822, married Margaret Brumfield in Gallia County, then moved her back across the Ohio River into Virginia. He has been found in no other Gallia County record. His parents, Robert Whitt Sr. and Mary White of Montgomery County, did not migrate to Gallia. They had married in Montgomery in 1792 then left for the Kanawha frontier. 19 In 1824 four of the counties on Virginia's western frontier (Cabell, Giles, Kanawha, and Tazewell Counties, VA) were subdivided to create Logan County. Robert Whitt Sr. filed for a Revolutionary War pension from Logan County in 1833.20 Robert Jr. and Peggy were householders there on the 1850 census.21
- John Sartain (the son proposed above for Elijah and Sarah above), and one William Sartain also left Gallia County as young men. John married Ann Johnson in Gallia in 1823; they sold their Gallia land in 1831 and have not been found in Gallia thereafter. John is enumerated as a head-of-household in Logan Co. in 1840,²² but appears to have died before 1850. The 1850 census enumerates Ann two households from William Sartain and his family.²³ They are living in the same district as Robert and Peggy (Brumfield) Whitt.



COMMENT:

As the next several maps show, the sections, townships, and ranges by which Gallia County lands were surveyed are numbered in a highly irregular fashion, making it impossible to determine distance between any two pieces of land by using the legal land descriptions alone.

The maps that follow do not identify all townships and ranges; thus, all the relevant lands cannot be reliably located. I am including these as placeholders until I can obtain more explicit maps.



The Ohio Company Lands²⁵



Note: The Chapman-Napier lands in R16 lie now in adjacent Lawrence Co, Symmes Township.





RESEARCH NOTES

1803— GALLIA COUNTY, OHIO

Historical context

"Gallia Township ... was organized Dec. 4th, 1826, and the first election was held at the **house of John Swindler**, **on section sixteen**, the first Monday in April, 1827, at which eleven votes were cast. Among the first officers elected were Elijah Fowler and John Swindler, justices of the peace; Henry Swindler, constable and trustee; Samuel Holley, trustee, and Guy Fry, one of the ministerial trustees.

"The surface is very broken, some of the hills being quite high. The soil is very productive, and mostly a black loam, adapted for grazing purposes and raising all kinds of grain, and the cultivation of tobacco is recently receiving great attention. Iron ore and limestone are found in considerable quantities in the hills, but it has not yet been developed. Fine strata of coal are also found, and in the neighborhood of Saundersville, a small village near the Lawrence county line, a vein four feet thick is being successfully worked for home consumption. Fine farms and farm buildings are seen all over the township, presenting a neat, tidy and thrifty appearance.

"The first cabin was erected in 1814, by William Garlick and E. Hobbs, who settled at the present site of Crown City. A settlement was made at an early date on Indian Guyan creek, at the mouth of Little creek. Among the early settlers were William Sheets, James Brumfield, William Johnson, John Williams, John Brumfield, Elijah Fowler, William Fowler, John and Brice Henry, John Sheets, J. Johnson, Samuel Holley, Henry Radford, A. Chapman, John Swindler, Humphrey Brumfield, John Bay, High Clark and Frances Blake. The latter was born in the block-house at Marietta, and had the honor of being the first female child born in the state, and married Mr. Wheeler.

"The first child born in the township was supposed to be Mr. Blankenship. The first marriage was that of Seth Chase to Anna Garlick, the ceremony being performed by Elijah Fowler, justice of the peace. In those days they advertised, in lieu of obtaining a license.

"Big Indian Guyan creek takes its rise in Harrison, and enters this township from the north, runs west of south, and passes out at section twenty-five. Williams creek, Georges creek, Rocky Fork and Johns creek, are small streams within the township.

"In 1816 William Janson built a grist-mill, of logs, on Indian Guyan creek, which contained one set of stones and was run by water. In 1820 he attached to it a saw-mill.

"The **first school** was taught at an early day by **Elijah Fowler**, in a small log cabin which stood one-half mile west of Crown City. The first building erected for school purposes was built of logs, **in 1816**, near the mouth of George's Creek. There are now twelve good frame school houses in the township, and the schools are well attended.

"Mercersville was the first post-office, kept by Joseph N. Larry. There are now five in the township - Mercersville, Crown City, Saundersville, Chapman's Mill and Yaho.

"Rev. John Lee, a Baptist minister, preached at the house of John Swindler at an early day, and a religious society (Baptist), was formed on Indian Guyan creek in 1832; among the first members

were Elijah Fowler and John Henry. There are now nine church organization in the township - three Missionary Baptists, with two houses of worship; two regular Baptist organizations, one of which owns a church buildings; one Methodist Episcopal, with frame church edifice, at Crown City; the United Brethren have two organizations, and two buildings, one of which is in Mercerville. One of the Baptist churches is also situated here, and one Camelite organization, with church building. There was a Sabbath school organized in 1840, by Mr. Holley, and one at Mercerville in 1849, by John Clerk and H. R. Jones. There are now four Sunday schools in the township."³⁰

1803–1834 GALLIA COUNTY, OHIO

Land settlement

COMMENT:

As seen below under 1834, Elijah and Sarah's son-in-law John Williams took out land in 1834 in Township 4N Range 16 West. Sarah's grandson George Chapman took out land in the same township on the same day.

I have run a search of all land patents for this township-range and find no lands sold to Blankenships, Brumfields, Chapmans, Sartains, or John Williams before 1834. One Williams Williams did enter land in 1821 and 1824, sections 13 and 14. Whether he was related to the John Williams who married Lucy Tlman Sartain is unknown.

26 MAY 1803 GALLIA COUNTY, OHIO

Land purchase

Joel Smith of Gallipolis Township sells to **Samuel Denny** of same for \$42, three town lots containing 1 acre, numbered 214, 227, and 228, "adjoining and on the North side of the Third Street from the River." Witnesses: Anselm Tapper, George W. Putnam. Recorded 13 December 1803.³¹

COMMENT:

Part of each index page is torn away. I am visually scanning all pages in search of relevant names.

I'm taking this Denny note because Sarah (Mills) Sartain's family in Amherst County, VA, intermarried with Dennys. I'll include data on this Samuel Denny until I can determine whether he might belong to her family.

31 AUGUST 1804 GALLIA COUNTY, OHIO

Land purchase

Thomas Shepherd of Kizer, Gallia Co., sells for \$140 to Samuel Denny of said town, 100 acres of land

Beginning at the SE corner of S 19N in T6 R14, thence N 160rods, then West 100 rods, then S 160 rods, then E 100 Rods.

Purchase price is to be paid in five installments due before 1 October 1808. Witnesses: Wm. Spencer, Brewster Higley. Acknowledged 31 August 1804 by Shepherd before Fs. Kiser?, "one of the Judges of the Peace." 32

Land sale

Samuel Denny to Thomas Shephard, sells for \$140, 100 acres of land. Same land as above. Same witnesses.³³

28 NOVEMBER 1805 GALLIA COUNTY, OHIO

Land sale

Samuel Denny of Salisbury Township, Gallia County, to John Peter Roman Bureau of Gallipolis County, for \$60, sale of three Town Lots numbered 214, 227, and 228 lying in the Town of Gallipolis, purchased by Denny from Joel Smith on 26 May 1803. Witnesses: Robt. Safford, Moses Everett. Acknowledged by Denny 27 November 1805 before Robt. Safford, Asst. Judge.³⁴

COMMENT:

The next volume in this deed series is a volume labeled "Deeds, 3, 4, 7," consisting of typed transcriptions. It is not indexed. Because it covers years before the Sartain-Chapman-Williams clan arrived in Gallia, I am not reading it page-by-page for unindexed internal references.

28 JULY 1807 GALLIA COUNTY, OHIO

Marriage

"I the subscriber do certify that a marriage was solemnized between **Joshua Willis** and **Mary Blankenship**, on the twenty-eighth day of July, one Thousand Eight Hundred and Seven, in the County of aforesaid, by me, by advertisement. **Jacob Miller**, Justice of Peace for County."³⁵

COMMENT:

On 12 December 1794, one Jacob Miller married Sarah Chapman, daughter of John Chapman in Montgomery Co., VA (later Giles). This Jacob either died or abandoned Sarah by 1813 when her father's will made provision for "the children which she had by Jacob Miller." Meanwhile "Elder Jacob Miller" of Montgomery > Giles, together with Lybrook who had married the elder's daughter Anna, moved with the Lybrooks in 1805 to the Dunker Baptist Four Mile settlement in present Union County, Indiana (formerly Wayne and Franklin Counties). Whether "Elder Jacob" stayed is not reported in this history of the Four Mile Community. "Jacob Miller is a commonenough name that the J.P. of Gallia could be an entirely different person. However, the coupling of that name with Blankenships raises a possibility to be investigated.

"This may certify that **Andrew Blankinship** and **Hanna Kinne** was married by advertisement January 9th A.D. 1812, before me Peter Wakefield, Justice of the Peace for Ohio Township."³⁹

8 SEPTEMBER 1812 GALLIA COUNTY, OHIO

Probate

Margaret Blankinship, widow of Richard Blankinship, presented his will for probate, attested by witnesses Isom Blankinship and George Willis who declared that the deceased was of sound mind at the time he made the will.

"In the Name of God Amen, I, Richard Blankinship being verry weak boody, but sound in memory do make this my last will and testament in the manner following to wit—

"First, I leave my wife in possession of all my house hould furniture and my living stock Except **Lodwick Blankinship**, I wish him to Have the Sorrel mare I gave him, all so the riffle gun he calls his own, and also I wish all my children except my two eldest Boys and them I leave one Dollar Eatch, to Have an Enaquil part of all my property and I so wish all my Children to Do this under common besiness. I want my wife have the land untill her Disease and then left to the four youngest Boys—and I leave all my living property and house hold furniture to my wife's own Disposal, to do as she thinks proper to to. This I make my last will and testament, Dated this 13th April 1812, as witness my hand and Seal. **Richard R. Blankinship.** Test Geoge [sic] Willis, **Isom Blankinship.**"

Margaret then posted bond in the penal sum of \$300, with Isom Blankinship and Joseph Price as sureties, and letters of administration were issued to her.⁴⁰

COMMENT:

The inventory is on pp. 281–82 of this same volume, made 13 April 1814 in Centreville Township by William Miller and David McCoy. It consists of cattle, tools, and a "rifle gun," all totaling \$378.50. I am not transcribing or abstracting all the records in the process because I do not yet know whether this Richard Blankenship is part of the Richard Blankenship family of Giles Co., VA.

OCTOBER-DECEMBER 1812 GALLIA COUNTY, OHIO

Marriage

"I do certify that I joined together in marriage Isaac Hillis and Saney Blankenship by virtue of advertisement agreeable to law. William [no last name] J.P."41

COMMENT:

The date of marriage is not given. In this *recopied* register, it appears between entries dated 27 October and 24 December 1812.

18 FEBRUARY 1813 GALLIA COUNTY, OHIO

Marriage

"This is to certify that I have joined **Philip Adams** and **Polly Mills,** Lawfully joined in the holy State of matrimony. Given under my hand, February 18th 1813. James Howell, J.P."⁴²

"I hereby certify that on the 29th day of December 1814, I joined together in the holy state of matrimony, **Richard Sharp** and **Nancy Blankenship** of lawful age. Given under my hand and seal this 21st day of February 1815, Peter Wakefield, J.P."⁴⁴

19 MARCH 1815 GALLIA COUNTY, OHIO

Marriage

"I, Lewis Newsom a Justice of the Peace, do certify that on the 19th of March 1815, I joined together in the holy bonds of matrimony **Joseph Fletcher Junr**. and **Mary Chapman."** 45

2 JUNE 1815

GALLIA COUNTY, OHIO

Disambiguation

Stephen C. Smith and wife Ruth of Muskingum County to **Ezra Chapman** of Gallia, \$125, sale of Lot 268 in S187 [sic] **T2 R12**, Ohio Company Purchase. Witnesses: Elijah Spry, John Goshen.⁴⁶

COMMENT:

The legal description of the land places this Ezra Chapman more than 25 miles from the community in which the Archibald-George Chapman family settled.

14 NOVEMBER 1815 GALLIA COUNTY, OHIO

"I hereby certify that on the 14th day of December 1815, I joined together in the holy state of matrimony, **Thomas Sowards** and **Anna Brumfield**, both of lawful age. Given under my hand and seal this 15th day of December 1815. Thomas Hobbs, Justice of the Peace."⁴⁷

This document rules out the possibility that the Gallia County James Brown might be the James Brown who married Sarah (Mills) Sartain's sister Susannah Mills.

Probate sale of Henry Neff (widow Elizabeth). Lewis Blankinship bought one cow \$17.12%. 50

COMMENT:

Probate Book B begins in September 1815. I am skimming every page from this point forward for embedded names of interest—witnesses to wills, appraisers of estates, attendees at estate sales, etc.

"I do certify that I joined together **Spencer H. Hayman** and **Jerusha Chapman** in the holy state of matrimony on the 7th of April 1816. David C. Sayre, J.P."⁵¹

Apparently Jerusha is part of the Ezra Chapman family. I've found no evidence that George Chapman was yet in the county.

To Have and to Hold the said Quarter lot or Section of land with the appurtenances unto the said Chapman and Napier, this [their] heirs and assigns forever." Recorded 16 July 1819, Nath. Gates, Recorded, Gallia County. 59

COMMENT:

Deed Book 14: 458 identifies the purchasers as George Chapman and Patrick Napier. This George who married Joicy Napier was the son of John Chapman Jr. of Giles. He is named as such in the will of his grandfather John Chapman Sr. (Giles Probate Book A: 115–19). With Joicy, he participated in a land sale by John Sr.'s heirs (Giles Deed Book B: 6–7).

This set of notes includes a second George Chapman, born about 1811 to Archibald Chapman and wife Betsy Mills. The younger George of Gallia would marry Frances Garlick in the 1830s and then, about 1837, become a county justice. (See abstracts and transcripts subsequently in this report.)

The two Chapman males who settled Gallia (George and Archibald) were first cousins, grandsons of John Sr. of Giles. As noted above, George's father was John Jr. Meanwhile John Sr.'s son George (John Jr.'s brother) left for Kentucky where he died shortly after his father's will. In his own will filed in Giles (Probate Book A: 161–62), the Kentucky George named his son Archibald, as well as another son George Jr. who did not migrate to Gallia.

COMMENT:

One Nathaniel (aka Nathan) Marrs was a Sartain-Brumfield neighbor in Montgomery and Giles. When Humphrey Brumfield and wife Sally Sartin sold their Giles County land at Brumfield's Landing in Giles, preparatory to moving, they sold to Nathaniel Marrs. ¹³²

Sartain Brumfield was likely the son of John Bromfield of the 1820 Sartain-Williams-Gorlick-Bromfield cluster. John that year had 2 males 0–10 and 1 female 0–10. I have not found a marriage record for John Brumfield (not in Giles, Kanawha, Montgomery Cos. VA or here in Gallia). If John is Humphrey's son, then John named his son *Sartain* for the birth family of his mother, Sally Sartain.

COMMENT:

Arthur Blankinship married Salley Sartin, *c*25 February 1811, Giles County. Salley's parents were not identified in the marriage record, but two factors suggest she was the daughter of Joel and Aversilla: (1) Her husband bought land adjacent to Joel when they settled in Gallia. (2) The 1810 census places a female aged 16–26 in Joel's household who has not otherwise been accounted for.

Some online trees assert that Arthur's wife Sally was the daughter of Elijah and Sally (Mills) Sartain—apparently on the basis of that name Sally. The 1810 census household of Elijah and Sally did include a female 16–26 (the only female child of marriageable age) but that female was Sally Mills' daughter Elizabeth who married Archibald Chapman in 1811 and settled adjacent to them in Gallia County.

The clustering of the two different branches of the family offers an important clue to parentage.

COMMENT:

John Sartain should be the son of Elijah and Sarah. He married Anne Johnson in 1823, Gallia County. The 1820 census places Elijah Sartain in the household adjacent to William Johnson. The 1830 census places John Sartain five households from John and Lucinda (Sartain) Williams.

This is the last record I've found for John Sartain and wife in Gallia County. Apparently, this is the point at which they left (ostensibly for Logan County, Virginia, the next place they are found).

Note that Sartain Brumfield sold this land less than three months later, suggesting that he did not buy it because he wanted it to expand his farm. It would seem more likely that he bought it to help out his cousin who could not move without selling his land to finance the move.



Yet the said defendant although often requested so to do hath not delivered them to the said plaintiff by reason of which last mentioned promises the plaintiff [has?] sustained damages to the amount of other [sic] fifteen dollars ... often requested so to do hath not paid the said Several Sums of money or any or either of them to the said plaintiff." In a prior proceeding, the court ruled that Williams was to recover from Phelps damages of \$20. Phelps appealed. Verdict in favor of Williams.¹⁷⁹

COMMENT:

This book is heavily damaged at top and sides, making an accurate transcription all but impossible. Page numbers are also unreadable. The index to the book does provide a starting page number for the case.

The identity of this John Williams is still debatable.

"That he was **born in the County of Pittsylvania,** in the State of Virginia, in the year **1762,** where he lived eight years, when he removed with his parents to Montgomery County in the same State, where he lived until the year 1815 or 1816 (he does not recollect which) when he removed to Kanawha County, Virginia, where he lived about two years, and then removed to the county of Gallia in the State of Ohio, where he has resided ever since.

"That he entered the service of the United States under the following officers named, and served as herein stated.

"That sometime in May, A.D. 1778 (the precise day and month he does not recollect) he entered into the service of the United States as a volunteer, under Captain John Dollason, who commanded a company of militia from the County of Pittsylvania in the State of Virginia, which company was then stationed at Hatfield's Fort, on Big Stony Creek, in the County of Montgomery, in said State of Virginia, where he volunteered as aforesaid—of which said Company one John Gwynn was their Lieutenant. He served in said Company, at said Fort, under the command of said Capt. Dollason, until the September following in the same year (1778) when he was dismissed by said Captain, but received no written discharge.

"Some time in April or May A.D. 1779, he again entered the service of the United States, as a volunteer under the Command of **Captain Christian Snyder**, at the Fort then under his Command on **Little Stony Creek**, in the County of Montgomery and State of Virginia, and served at said Fort, in the company commanded by said Capt⁻ Snyder, until some time in the September following, in the same year, when he was dismissed by said Captⁿ Snyder, but received no written discharge.


"That he knows of no person whatever by whom he cam prove the services aforesaid, nor any person now living who served with him during said service, except one **Humphrey Brumfield**, who now lives in his neighborhood, and who was with him during the greater part of said Service. That he never knew any regular officers or general officers of the regular [Army]. He is old and infirm, very poor and needy, unable to live even with convenience in life. Has served faithfully and if testimony other than he hereby offers is required, he can never get it.

"He hereby relinquishes every claim whatever to a pension or annuity except the present, and declares that his name is not on the pension roll of any State, or the Agency of any State or Territory, &c.

"Sworn to and subscribed in open Court, this 21st day of July, 1836."



"We, Cornelius Holly and **David Ripley**, residing in the neighborhood with said Joel Sartin, hereby certify that we are well acquainted with Said Joel Sartin who has subscribed and sworn to the above Declaration; that we believe him to be seventy-four years of age; that he is reputed and believed in the neighborhood where he resides to have been a soldier of the Revolution, and that we concur in the opinion. There is no **minister** of the Gospel living in the neighborhood of the said Joel Sartain, except **himself**.

COMMENT:

There are no subsequent documents, suggesting that Sartain may have died without further prosecution of the claim.

COMMENT:

This John Williams, given that his land is adjacent to the land Chapman is buying, should be the John who married Chapman's sister-in-law Lucy Tillman Sartain.

1830: not found. The only Mills family in Gallia Co. is from New England.

1840: not found. There is no new Mills family in Gallia—and no Nichols family in Gallia (1830 or 1840) to which Phebe could belong. **Across the river in Kanawha Co., VA (home of Jesse Mills** b. c1805 to John Mills b. c1774–75, son of Jesse Mills & Lucy Tilman of Amherst) there are **four Nichols families** (Isaac, Zepaniah, Jonathan, and Solomon), living near Ruffners (also neighbors of Jesse Mills).

Note, below, that all of Costine's children, b. 1839–50, are said to have been born in Virginia. He and Phoebe do not appear to have remained in Ohio.



COMMENT:
