SUBJECT: William Mills of Haile's Tithe List, 1750, Lunenburg Co., Virginia: Identification Needed

BACKGROUND: The Nicholas Haile precinct of this tax roll enumerates 118 males who were of tithable age—i.e., aged 16 or older. Among them was one William Mills charged with one poll. No other data is provided for any of the men, only the number of tithes. 1750 is the only year in which he appears on the Lunenburg lists.

Numerous William Millses were settled across Virginia at this time. Most appear in records of multiple counties—often because of county splits and often because they chose to migrate onto new lands. I am attempting to separate the Williams and identify each as to origin and family.¹

Colonial Virginia land and court records identify a William Mills family whose activities straddled the Lunenburg–Albemarle border during the 1740s and 1750s.² In brief:

- 1747–48: 54 acres were surveyed for William Mills somewhere in Albemarle County, at an unstated location by Joshua Fry, surveyor for Albemarle County. On 1 April 1749, he received a patent to 400 acres on Pedlar River and Dancing Creek, just above the Lunenburg line. That land now falls into Amherst rather than Albemarle.³
- 5 April 1748: Thomas Watts, son-in-law of William Mills of Pedlar, received a patent to 400 acres on branches of Pedlar River. The land lay adjacent to that of Edward Watts, Thomas's father. Thomas sold the land shortly after getting his patent.
- 1748–52: This Thomas Watts appears on the Lunenburg lists consistently in one district. In 1749 Lewis Deloney was the captain; in 1749 and 1750, William Howard was the captain. In 1752, Field Jefferson was the captain. His data is consistent across all four lists.
- 1750: A second Thomas Watts was taxed in Lunenburg—in the same Hailes precinct as the William Mills of 1750.
- 1749–52: Ambrose Mills, son of William of Albemarle, was also taxed in Lunenburg. He appears on the Mathew Talbot list of 1749, and John Phelps's lists of 1750 and 1752 lists. (The 1751 Lunenburg lists are missing.)
- 1749—52: the Lunenburg lists include John Earl (reputedly married to Mary Watts, daughter of Edward Watts of Pedlar River.

- 1752: Edward Watts, father of Thomas of Pedlar, was taxed in Phelps's precinct, together with his three unmarried sons: Edward Jr., John, and George.
- William Mills of Pedlar had a son William Jr. who, *possibly* could be William of the 1750 Lunenburg list. However, unlike his older brothers Ambrose and Thomas, no land grant was obtained in his name during the 1750s, suggesting that he was not yet of tithable age in 1750.

Also relevant:

- Tithe lists for Albemarle do not exist for this period.
- Lunenburg County was established in 1746 from Brunswick. In 1750, it was a huge dominion, spanning what is now nine different counties. (See Map 1) Determining exactly where in Lunenburg this William Mills was tithed is essential to determining his identity.
- TASK: Study the 118 men on the Nicholas Haile list of 1750 to determine more precisely the location of Haile's precinct. Use online land grant records and a literature survey of published deeds, probate records, and road orders to place these men into residential and associational clusters on specific waterways.

Executive Summary

- The evidence strongly suggests that this William Mills was in the area that is now Franklin County (created 1784 from Bedford and Henry).
- 80 of the 114 men could be tracked for at least a few years after the 1750 list. A significant number could be tracked for decades.
- Most of the trackable men named immediately before and after William on the 1750 list were landowners along the Staunton River, that being the lower bounds of Bedford County after its 1754 creation and before its 1785 subdivision. The captain who compiled the 1750 list, Nicholas Hailes, held lands on both sides of the Staunton.
- 51 percent of the trackable men from this list lived in the part of lower Bedford (Staunton River down to Maggoty River and on to Blackwater River) that fell into Franklin County in 1785. Only 36% of the 1750 tithables on Hailes list remained in Bedford after Franklin was cut away. The last 13% of the 1750 men scattered across 6 other counties.
- The most-important associate for this William Mills appears to be the man listed immediately after him: WIlliam Hays. In 1752, Hays appears on the Phelps list, 6 listings from one John Mills. Before 1753, Hays married the widow of Edmond Smith—with John Mills and John Beard (of this 1750 list) servings as sureties for her (and then Hays's) administration of the Smith estate. This John Mills was still in the county in 1764 when estate heirs sued him and Beard claiming that Hays mismanaged the estate. One document filed by John Mills in the proceedings showed that he paid a total of 12.7.6 ½ to 8 men—debts due to the estate. The first of those eight was William Mills; another was an Andrew Hayes. Meanwhile, in 1753 John Mills was appointed overseer of the road from Ewings Fork on Otter River, to the Blue Ridge "in lieu of Wiliam Mills." He remained in Bedford until c1786, then sold his land and moved to Botetourt. William May, between 1764 and 1770, moved

to present Henry Co. where he appears in land records along Mayo River, Smith River and Fall Creek (later Franklin Co.) Associates included David and Jesse **Witt** (son of John), Drury Smith & John Jonnikan (Jernigan), the latter of Franklin.

- I have found no convincing evidence to connect the William Mills of this list to the Mills-Watts family along Pedlar River. The one tenuous connector is the fact that (a) William Mills and then John Mills were appointed overseers of a road from Otter River, while (b) William Mills of the Pedlar had a daughter who married into the Watts family of Otter River.
- I have found no evidence to connect the William Mills of this list to the still-unidentified Thomas Watts who lived in his precinct in 1750.
- I have found no evidence to connect the William of Lunenburg 1750 to the William Mills of Aberdeen, Scotland, who resided in Goochland and Cumberland from 1730–1765.⁴
- Several of the 1750 tithes migrated down from Bedford, past the Blackwater, to current Henry County—most notably, the William Hays who is listed consecutively with William Mills in 1750. There in Henry (after it was cut from Pittsylvania(, these men are found interacting with yet another William Mills. That William of Pittsylvania and Henry first received land on Matrimony Creek in 1770 via a patent made out to "William Mills and Elizabeth Mills." (The document did not name Elizabeth as his wife; the two appear to be coheirs to a patent process initiated by someone who died before the patent was issued.) That William of Henry—alleged to be the William Mills who married Elizabeth Fontaine in 1782 Goochland—wrote his will in 18____ and died in Henry in 18____. In 1787, he filed several deeds interracting with Millses of Hanover County, suggesting Hanover as his point of origin.
- The Franklin County locus for most men of the 1750 list may have another major significance. A younger William Mills (b. c1785), parents unknown, emerged in 1806 as a newly adult male on the Franklin County tax rolls. Although he was propertyless for years, he married into and associated with prominent families that were early settlers of the Blackwater River and its creeks—including several families founded by men enumerated on the 1750 Hailes tithe list with the William Mills of this study. (N.B. Y-line descendants of this William Mills carry the Y of the Virginia Witt family. Until further identification is made, I am referring to this William as William Mills-Witt.⁵

Research Notes


Lunenburg County in 1750 stretched 150 miles from east to west along the Virginia–North Carolina border. (See Map 1.) It embraced 9 modern counties. Its creation and division followed this timeline.


- 1746 Lunenburg was cut from Brunswick County
- 1752 Halifax was cut from Lunenburg; to the southwest of current Lunenburg
- 1754 Bedford was cut from Lunenburg; it now lies several counties to the west
- 1764 Mecklenburg was cut from Southeast Lunenburg; to the south of current Lunenburg
- 1764 Charlotte was cut from Lunenburg; to the west of current Lunenburg and Mecklenburg
- 1767 Pittsylvania was cut from the west of Halifax
- 1777 Henry County was cut from western Pittsylvania; called Patrick Henry County until 1790
- 1785 Franklin County was created from N half of Henry and S half of Bedford
- 1790 Patrick County was cut from western Henry

Landon Bell's published compilation of Lunenburg tithable lists, 1748–83, presents "a map of the County as it was when organized in 1746, and as it stood in 1748." (See Map 2) Bell used descriptors from the 1748 title lists to "approximate" the boundaries of the precincts as they existed in 1748.

Bell also tells us: "The ... most thickly populated area of Lunenburg County at the time was that section north of Roanoke River westward to Falling Creek and ... probably the most thickly settled part of that territory was that lying upon the watershed of Meherrin River." That would be the districts of Bacon, Lawson, and Delony—the Meherrin being the E-W dividing line between Delony on the South and Lawson and Baon on the North.

"The size of John Phelps' precinct from Falling River westward indicates that it was sparsely settled [current Campbell and Bedford Counties] ... This was true in greater degree of the **precinct of Cornelius Cargill.** Theoretically, his precinct embraced, presumably, all the territory from Butcher's Creek westward, and in **the Forks of the Roanoke (and Dan) rivers**, and from the North Carolina line northward to the boundaries of other precincts, and westward to the limits of the County. **But probably such inhabitants as were then in the area were clustered in and about 'the fork' of the river. There were probably but few persons then resident in what is now Patrick, Henry, Franklin and a considerable part of Halifax Counties."**

Bell's reference to a cluster at "the fork" is ambiguous. Apparently, he is referring to the region where creeks of the Eastern Dan feed into the Roanoke along the Cargill-Talbot line. Cargill's Creek appears on later maps at the area I have circled in black on Bell's map, being in present Charlotte County.⁸

No tithable rolls survive for 1747, according to Bell.

1748

At a June court in 1748, precinct boundaries changed and Cargill's precinct was subdivided. The new bounds were as follows:

Hugh Lawson	"from upper Hounds Creek to Meherrin to the extent of this County downwards"
Lyddall Bacon	"from Hounds Creek to the head of Nottoway and Maherrin Rivers"
Cornelius Cargill	"in the fork and to Butchers Creek"
Lewis Delony	"from Butchers creek to Meherrin and from there to the extent of the county downwards"
Matthew Talbot	"from the fork to Cubb creek"
William Caldwell	"from Cubb creek to Falling River"
John Phelps	"from Falling River to the extent of the county upwards"

No William Mills was taxed in any of these precincts.

At a June court in 1749, precinct boundaries changed yet again, as follows:



Note that

- No Hailes precinct existed prior to 1759
- No William Mills was taxed in any of these precincts prior to 1750.


Goose Creek appears on Bell's map in the Nortwest quadrant, above Roanoke River. Haile's precinct should fall entirely in present Bedford County. After Bedford was created in 1752, Haile's assigned region would be bounded on the north by Albemarle County (now Amherst) and South by Lunenburg.

As we proceed to analyze the 1750 list, the Fry-Jefferson Map of 1754 helps us to identify locations more precisely than the maps by Bell and Lloyd.

COMMENT:

On this annotated list,

- **Column 1** identifies the present county in which this man held land.
- Column 2 presents the name as given by the transcriber, Bell on the 1750 list.
- Column 3 notes whether the person was there in a prior year and the name of the district the following year when Hailes was no longer a precinct captain. It presents details of land ownership or location that are documentable for this person. For each land grant or survey cited in this column, I identify the online database that I've used. For locations of streams, I have used VA HomeTownLocator (<u>https://virginia.hometownlocator.com/features</u>), as well as the historical maps cited in this report.

A 1924 history of Halifax includes this list of patentees:, "Philip Finn, 119 acres south side of Stanton River; William Hill, 240 acres both sides of Black water River; Nicholas Haile, Gent., 654 acres, being two surveys joined together south side of Stanton River; Neal McNeal, 125 acres on Maggotty Creek; Robert & Thomas Jones, 520 acres on Pig River." No John Mills appears on the next two surviving Lunenburg tax lists: 1764 and 1769. Lists also survive for 1772–76 and 1783. In **1772 Lunenburg**, one appears on the list taken by Elisha Betts, living in the home of Elisha Betts. **In 1783 Lunenburg**, one John Mills is taxed in the district of Christopher Robertson, with 10 white tithes and 6 black tithes. No links are yet known between these various same-name men.

The John Mills who associated with William Hays, more certainly, is the John Mills of Bedford who seems to be one person there from its 1754 creation until 1786. Principal documents:

- 1753 Appointed surveyor of the road "from Euing's fence to the Blew Ridge in room of **William Mills**." "Ewing's Fork" lay on Otter River (see Bedford Deed Book A-1: 342), which was the locus of the Edward Watts family.
- 1754 Road order: "Nicholas Welch [q.v.] is appointed Surveyor of the Road in the room of John Mills.
- 1755 Sued Patrick Downey
- 1757 Sued William Woods
- 1764 Witnessed 3 Bedford deeds (filed 26 July 1764), between Alexander Sayers of Augusta County and Israil Christian, for land adjoining New London Town; other witnesses were An. Bledsoe, Fran. Thorpe, James McFall, Thos. Barnes, and Francis Smith.
- 1774 Probably the "Mills" who sued "Bandy," with no other identifying information
- 1777 May be the "Mills" who bought land from "Crawford"
- 1784-5 Taxed on 240 acres in Bedford; ditto 1785; not taxed 1786
- 1786 Not taxed
