Many online trees identify Neal as "Cornelius." Across the course of his life, only one known document calls him Cornelius—the September 1838 tax roll of Lawrence Co. that was, two months later, corrected to "Neal" Williams. Until and unless other evidence emerges, I consider this corrected outlier to be an error.

(John Holly) Williams" Facts page. However, all known documents created by and about him in his lifetime call him only *John*. He did have two grandsons named John *H*. Williams, for whom Holly or Holley is claimed to be his middle name; in those cases, the middle name also remains unproved.

#### 2. UNIDENTIFIED, born c1823; d. c1824, Lawrence Co., MS.<sup>13</sup>

JOHN WILLIAMS, born c1825,<sup>14</sup> m. 8 June 1844, *Jenette Johnson*, in Attala Co., Mississippi.<sup>15</sup> 1850: Not found. 1858: Together with his brother Thomas, he filed a document with the Chancery Court of adjacent Madison Co., on behalf of "their father Neill Williams"<sup>16</sup> who had obtained Attala Co. land in the corner of the county where Madison abuts Attala and Leake Counties.<sup>17</sup> 1860: The census places John's household across the line in Leake, on land they had obtained adjacent to his brother Jacob N.; children Newton A. R. (14), James A. J. (13), Jordan A. (10), Ebenezer N. (8), Dicy A.V. (6), Cicero B. H. (5), Mary D. (2).<sup>18</sup> The obituary of John's son Cicero would report that John "died of disease while serving with the Southern forces in Tennessee."<sup>19</sup>

Several dozen John Williamses enlisted in the Confederacy from Mississippi, but only one service record has personal details that appear to be appropriate. This John of Leake enlisted for three years at Carthage, the county seat, on 23 April 1862, as a private in Co. E of the 27<sup>th</sup> Mississippi Regiment. The October muster roll states that he was sent to the hospital at Knoxville, TN, on 26 October; the muster roll of November–December 1862 states that he died at "Ringgold Hospital." At his death, he was in possession of \$40.75.<sup>20</sup>

The document does not state the name, age, or gender of the person who died within the "Neel Williams" household. Typically, when the death is attributed to the household of a male, the deceased was a wife or child. In this case, evidence proves that Neal's wife of 1820 continued as his wife until his death *c*1863 and was his widow in 1880. The birth pattern of Neal and Polly's children suggests the deceased was an infant whose death left a childspacing gap between living children.

By 1870, the widowed Jenette had moved her family to Texas, first to McLennon Co, but then to Johnson Co. before 1874.<sup>21</sup> By 1900, she had moved again, this time to the Chickasaw Nation of Oklahoma."<sup>22</sup> From there, Dicie, James A.J., and numerous offspring made unsuccessful Dawes claims asserting that John's grandmother, Penny Fisher, was a "full-blood Choctaw."<sup>23</sup>

- 4. THOMAS WILLIAMS, born about 1827; represented by a tick mark in parental households of 1830 and 1840; filed petition with brother John in 1858, Madison County, calling Neal Williams "our father." The 1850 census of Attala, where his parents then lived, presents him as a young farmer, aged 23, with Elizabeth aged 18, living six houses from the farm of his sister Luvicy and her husband Francis Marion Gatlin.<sup>24</sup> In 1858, together with his brother John, He has not been reliably connected to any other Thomas Williams on record.
- 5. GRACIE LUVICY WILLIAMS,<sup>25</sup> born May 1830;<sup>26</sup> d. 26 Sept. 1917 at the home of her son Edward Gatlin, at Aley in Henderson Co., TX.; buried King's School House Cemetery, Henderson Co.<sup>27</sup> She m. 1849, in Attala Co., MS, *Francis M. Gatlin*, who died 12 April 1900 at Grandview, Johnson Co., TX. The widowed Luvicy then filed for a pension as a Confederate widow, citing her late husband's service from 1861 through 1865 in Co. C, 7th Mississippi Battalion, Price's Brigade.<sup>28</sup>

The name Gracie also appears for her in a 1986 family sketch, "Edward Gatlin Family," published in *Cherokee County History* (Jacksonville, TX: Cherokee County Historical Commission, 1986), 280–81. This source misspells the name of the family's ancestor "Neal" Williams as "Noah" Williams.

Luvicy is routinely misidentified in online trees as *Elizabeth* Luvicy. The only evidence provided is her memorial at *Find A Grave* (https://www.findagrave.com/memorial/73707804/elizabeth-louvice-gatlin : accessed 20 February 2022), "Elizabeth Louvice 'Levicy' *Williams* Gatlin," created 21 July 2011 by Amber D. Gatlin-Jenkins; no tombstone is imaged or transcribed; no evidence is presented for the assigned first name "Elizabeth" or for her maiden name.

The Gatlins began their married life as landless farmers, with the 1850 census enumerating them in Attala Co. three pages from her parents and six houses from her newlywed brother Thomas. Luvicy and Francis were already the parents of a daughter Martha E.<sup>29</sup> In 1853–54 their families began migrating out from Attala. Luvicy's parents obtained land in the adjacent county of Madison<sup>30</sup> and her brother Thomas moved with them.<sup>31</sup> Her brother Jacob settled across the county line in Leake, adjacent to their brother John.<sup>32</sup> Francis's brother William Gatlin tried Leake Co. also,<sup>33</sup> but moved further south to Clarke Co. with his Kitchens and Rials kin; notably, he moved *without* his son Jeremiah<sup>34</sup> who married Luvicy's sister Penny about 1854.

Francis and Luvicy were the last to abandon Attala; he was taxed there in 1854 but left before the 1855 tax roll was compiled.<sup>35</sup> The 1860 census places them in Jones Co., MS, where Francis was a mechanic living adjacent to (and likely on the land of) his more-prosperous brother Mitchel Gatlin.<sup>36</sup> Both men were called into the Confederacy; only Francis returned. The 1870 census taker found the family of Francis and Luvicy in the neighboring county of Wayne Co., where Francis had become a house carpenter, with less than a quarter of the resources he held in 1860.<sup>37</sup> By 1880, the family had relocated yet again; this time, to farm with Luvicy's landowning brother J. N. Williams (Jacob N.) in

Leake Co.<sup>38</sup> Their removal to Leake occurred before 30 July 1879, when their son Major Slade Gatlin married there to Rhoda Ann ElmIra Elizabeth Odom, the daughter of his first cousin Samuel E. Odom.<sup>39</sup> The following day, their son Edward married another first cousin, Matilda Rachel Williams, daughter of Luvicy's brother Jacob.<sup>40</sup> All would move to Texas between Leake Co.'s tax rolls of 1884 and 1886.<sup>41</sup>

6. PENELOPE ANN "PENNY" WILLIAMS, b. 1831–32; m. apparently 1854 in Attala Co., MS, Jeremiah Gatlin,<sup>42</sup> said to be the son of William W. Gatlin and wife Elizabeth Ryals.<sup>43</sup> 1860: not found. 1870: Holmes Co., MS: Jeramire 32, Penny A. 30, Hardy L. 15, Mary E. 11, Sarah D. 7, Emeline 5, Annie 3.<sup>44</sup> Jeremiah served as a private in Capt. Sam Young's Co. G, 30<sup>th</sup> Regt., MS infantry, having enlisted on 5 April 1862 at Grenada, MS, under "Col. Neill" for three years or the duration of the war. A muster roll of 30 June 1862 notes that he had received no pay. The July–October musters report that he was absent and in the hospital at Tupelo, MS. When discharged, he was sent back to the field and participated in the Battle of Murfreesboro (Tennessee) on 31 December 1862. The muster of 3 February to 3 March 1863 reports that he was "absent, Sick, Surg." and that he had been paid a bounty of \$50. He signed a receipt for clothing on 3 June 1863; and in August, he was said to be present, but "in arrest"; no reason was given. The service record ends at that point.<sup>45</sup>

Online trees assert that Jeremiah Gatlin died about 1878 in Attala County, but cite no evidence. They also assert that Penny died "aft. 1875" in Holmes County.<sup>46</sup> Their daughter Mary Elizabeth Gatlin (b. c1859), is said to have married George Skelton 5 December 1880 in Leake Co.<sup>47</sup> The 1880 census of

Leake shows one "Mollie" Gatlin, aged twenty, living with Thweatts as a "cousin," two households from "M. S" Gatlin and wife "E" (Major Slade Gatlin and wife Rhoda Elmira Elizabeth Odom). A fifty-year-old "G" Gatlin, living without wife or children, appears several households on the other side of Major Slade.<sup>48</sup>

JACOB N. WILLIAMS, b. c1834–35; m. Mary Ann —?—. 1860: Leake Co., MS 1860, adjacent to brother John Williams.<sup>49</sup> 1870: not found. 1880: Leake Co (Beat 2, Thomastown), as J. N. Williams 45, wife Mary 49, they lived adjacent to the family of his sister Luvicy Gatlin, on one side; on the other was his daughter Rachel, newly married to Luvicy's son Edward Gatlin.<sup>50</sup> Daughters Savannah Q. V. E. Williams (b. 1857) and Sarah F. B. Williams (b. 1859) of the 1860 household are not enumerated with their parents in 1880.

On 22 March 1862, as a farmer whose nearest post office was said to be Kirkwood, MS, Jacob enlisted in the Confederacy at either Thomastown in Leake Co. or Canton in Madison Co. (his service cards disagree), promising to serve for the duration of the war in exchange for the bounty offered by Lt. J. P. Mills, a Leake Co. officer. Jacob was assigned to William H. Dudley's Co. G, 21<sup>st</sup> Mississippi Infantry, the same company to which his brother Solomon had just been assigned. With the 21<sup>st</sup>, they marched to Virginia. From 18 October until 8 November, Jacob was hospitalized with pneumonia in the General Hospital of Camp Winder in Richmond. After a short return to active duty he was hospitalized again on 8 May 1863 at Richmond's Mississippi Soldiers' Hospital, where he remained until 11 August, suffering from "Vul: Sclo"—i.e., vulnus sclopeticum, a gunshot wound. The November 1863 muster roll notes that he deserted on 19 September; likely, as with many soldiers, he returned home to help the family harvest their crop. On 6 February 1864, after crops were harvested, he returned to duty, but fell ill again. He was admitted on 18 June to the General Hospital at Petersburg, VA, with "Int. fever, and was re-hospitalized at Farmville, VA, between 20 June and 1 July 1864, for chronic diarrhea. Upon his release from Farmville, he returned to his unit and suffered a severe arm injury in the Battle of Berryville, VA, on 3 September 1864. He remained with his company through April of 1865, but was captured that day at the Battle of High Bridge and sent to Point Lookout, Maryland—one of the largest and worst of the Union prisoner-of-war camps. Six days later, the Civil War ended. He was not released, however, until 22 June—at which time he was provided transportation from Point Lookout to the town of Canton. The oath of allegiance that he took at the time of his release described him as a resident of "Leek Co. Miss.," 5' 6¾", dark complected, with brown hair and grey eyes.<sup>51</sup>

- 8. SOLOMON D. WILLIAMS, b. about March–June 1837 (1860 census: 2 June 1836–1 June 1837; 1850 census: 2 June 1834–1 June 1835; CSA enlistment: 6 March 1837–5 March 1838); m. Ellen Fisher, 11 July 1859, Madison Co., MS.<sup>52</sup> Solomon was also a farmer whose nearest post office was Kirkwood when he enlisted at age 24 on 5 March 1862, at Canton (Madison Co.) or Thomastown (Leake Co.), by Lt. J. P. Mills for the duration of the war, and was paid a bounty. As a private in Co. G, 21<sup>st</sup> Mississippi Infantry, he was "wounded in face" and admitted to General Hospital Camp Winder, Richmond, VA, on 1 July 1862, then returned to duty on 10 August 1862. His company's muster of November–December 1862 reported that he had "left sick Sept. 15, place unknown," and the muster of July–August 1863 also reported him sick and absent. The muster of March and April 1864 reports that he was "Supposed dead." However, a summary service card covering 1861–1865 reports "Missing since September /62 Supposed to have gone to the U.S."<sup>53</sup> No Union Army record has been found for him. Neither he nor Ellen has been found thereafter; Ellen does not seem to have filed for a widow's pension.<sup>54</sup>
- **9. SARAH WILLIAMS,** b. 1843–44, enumerated in the parental home in 1850 and 1860. *Possibly,* she was the Sarah Williams who married "N.C. Dees" in Madison County on 7 November 1866. The couple has not been found thereafter.<sup>55</sup>

### COMMENT:

- Jacob's daughter Mary and her new husband Neal Williams are not found in a separate household and do not fit into the Williams household. The one young adult male in the Sessums household is the age of Jacob's son Reding; however, Reding is known to have left home as a young adult practicing the trade of house carpenter. He was taxed on the roll compiled early in 1820 but was not taxed on the county's 1821 roll.<sup>71</sup>
- In John Williams's household, the male 16–25 and the male 16–18 were one and the same. Males 16–18 were double-listed this year under census instructions.





COMMENT:

This undated census is filmed together with an 1841 state census of Lawrence County. The 1841 document is dated. Ancestry has erroneously assumed that its date also applies to the undated census.

The Mississippi State Archives, which holds the originals of both documents, labels this one as "Lawrence (Births and Deaths) Date Unknown." All other Mississippi rolls that I have seen for registration of births and death are for the 1822–25 period. No known record of births and deaths were kept thereafter until the twentieth century.

Other Williams males included on this list: James, Thomas.

Williams males enumerated on censuses of Lawrence between 1820 and 1841:

- 1820: D.C., Jacob, James, Jesse Sr., John, Lewis, Martin, William
- 1830: Benjamin, Daniel, David, Elisha, James, John, Jordon, William
- **1840:** Byrd, Daniel, Isaac, Jas H, John, P.B., Robert

**1841:** Daniel, James, James Sr., Demser? Jun., Lewis? N?, W. W. Sr.

As a further test of the likelihood of the *c*1825 date, I randomly chose 16 individuals from the birth and death list, whose names were clearly written.<sup>74</sup> Then I searched for each of those men in 1820, 1830, and 1840. Results:

- 11 of the 16 were heads of household in 1820
- 8 of the 16 were heads of household in 1830
- Only 4 of the 16 were heads of household on either the 1840 or 1841 censuses.

Conclusion: the list almost certainly was created in the 1820–30 decade. The list is significantly longer than the 1823 list, suggesting that it was created after 1823 (as the county expanded) rather than before 1823. The fact that dated lists exist for 1823 also places this at 1824–25.

The next document below, a set of totals dated 1825, have tallies that match the undated document above. It confirms the 1825 date for the "census of births and deaths" on which Neal Williams reported one death. **However, this "1825" compilation covered births and deaths for the preceding year, 1824.**

- Polly's brother Thomas Sessums would, this year in Rankin, marry Zilphy Cooksey Jr. Zilphy's brother John Cooksey does appear on the 1829 tax roll of Rankin.<sup>77</sup>
- Polly's brother-in-law, Jesse Courtney ("Cortney") was taxed in Simpson, where Polly's father still resided.<sup>78</sup>

## 1833–1839

Tax rolls

COMMENT:

- The 1832 Simpson Co. tax roll, above, is **Neal's last known taxation until 1838.** Lawrence Co.'s tax roll finalized in August 1835, one month before Neal purchased Lawrence County land, did tax him as a resident poll. In 1836, after his purchase of land, he is again not shown on the land and poll-tax roll. He is also missing in 1837. He only appears on Lawrence's roll of 1838 (finalized 18 September), after which he sold his land in December to brother Robert.
- For Neal's missing years, I have searched for him (and Simeon of the 1832 Simpson roll) on the rolls of Attala (whose rolls begin 1835), Copiah, Lawrence, Madison, Neshoba, Newton, Rankin, or Simpson.
- 1833: Polly's father Jacob is enumerated on Simpson Co.'s census, along with son-in-law Jesse Courtney and newest son-in-law, Samuel Courtney.<sup>82</sup> That would be Jacob's last appearance until he emerged on the 1840 Newton County census.
- 1834: Polly's brother Thomas Sessums and his Cooksey and Odom in-laws were taxed in Neshoba. This new county had only 35 tax payers that year.<sup>83</sup>
- 1835: Thomas Sessums and his Cooksey and Odom in-laws entered government land in Neshoba (now Newton), which was patented to them in 1841.<sup>84</sup>
- 1835–36: Polly's brothers-in-law Jesse and Samuel Courtney were taxed in Simpson in '36; the '37 roll is missing; and both were dropped in 1838.<sup>85</sup>
- 1838–39: The Courtneys (with Sessums wives), Thomas Sessums, and Thomas's Cooksey and



Odom in-laws were all taxed in Newton County<sup>86</sup> (cut 1836 from Neshoba).

• All points considered, it seems probable that, when Neshoba was created in 1833, Neal moved onto those new lands with Polly's brother Thomas and his Cooksey in-laws. From there, they were cut away into Newton. While he bought Lawrence Co. land adjacent to his many brothers in 1835, there is no evidence that he resided in that county except for the year 1838. After selling his land late that year, he returned to Newton.

Allen Sterlings and wife Lydia of Lawrence to **Neil Williams**, sale for \$300 cash in hand, E½ of NE¼ S13 T8 R19W, 80 acres of the lands formerly sold at St. Stephens, Ala. Witnesses: **Joel Polk** and W. B. Sterling. Acknowledged 9 September 1835 by the Sterlings before **James Shannon**, President, Board of Police for the county.<sup>89</sup>

### COMMENT:

- Joel Polk was 1839 bondsman for **Daniel Williams** and **William Williams**; the body of evidence gathered for him suggests that his wife Mary was a daughter of John and sister of Daniel, William, and Neal.
- James Shannon married **Catherine Williams** in 1822, with **Daniel Williams** as bondsman and consent of unnamed parents.<sup>90</sup> Shannon's land in S29 of T9 R18 lay adjacent to **John Williams**.<sup>91</sup> Beyond reasonable doubt, he married John Williams's daughter—and Neal's sister.
- Neal's purchase in Section 13 was contiguous with Section 11 where Isaac Williams owned land. Isaac owned land in 5 sections immediately north of the tract Neal chose: S1, 2, and 11 in T8 R19 and S35-36 in T9 R19. Robert Williams was roughly 2 miles to the NE in S5 and 8 T8 R18. Robert and Isaac also owned land about 2 miles above Robert, adjoining father John in S20, 28, 29, and 30 of T9 R18.

- Isaac Williams in 1863, petitioned to be administrator of Daniel's estate, stating that he was Daniel's brother.<sup>92</sup>
- Given the direct evidence for Isaac and Daniel's siblingship, the residential pattern of this cluster of Williamses, all of the same generation with no other Williams family within forty or fifty miles, attests that they should all be siblings. Much additional evidence is presented in my substantially longer research report for Lawrence County.<sup>93</sup>

Acknowledged 7 December 1838 by Neal Williams before William Harrison, JP, who attested the appearance and relinquishment of Mary Williams. Filed 28 January 1847. Recorded 17 Sept. 1847.<sup>97</sup>

### COMMENT:

Neal has not been taxed since 1832, Simpson County. He is not found on the Lawrence rolls of the 1830s—not even after the 1835 purchase of land. The usual explanation for such situations would be that Neal was not a resident of county—or was there only briefly after his purchase—that he placed his land in the hands of a renter or agent, and then sold the land after he was certain that he would not return.

Robert was incontrovertibly a resident of Lawrence this year (and for 20 years before and 30 or so years after). It is possible that the scribe reversed the residences and wrote "of Lawrence Co." for the seller instead of the buyer.

## COMMENT:

Evidence is ambiguous as to whether the female enumerated with Shadrack Odom is his first wife (proposed to be Margaret Williams) or second wife (Elizabeth Cooksey). Factors to consider:

### Timing:

- Shadrack's second child by his first wife was born 2 February 1840.<sup>100</sup>
- Shadrack's first child by his second wife, a daughter Rhoda, was born in June 1841 (according to the 1900 census).<sup>101</sup> Therefore, she was conceived about September 1840.
- The official census date for 1840 was 1 June. Rural households were visited across the next several months, but data was supposed to be collected as of 1 June.
- If the first wife were still alive on 1 June and the second wife conceived in September, then Shadrack's "period of mourning" was three months or less. If his first wife died from childbirth, then he might have waited nine months before remarriage. In either case, a quick remarriage is not surprising, considering that his wife's death left him with two infants under age three.

### Location:

The 1840 federal census, above, enumerates Shadrack adjacent to his parents. The early 1841 state census, below, enumerates his parents adjacent to Neal and Mary Williams, the parents proposed for Shadrack's first wife—while placing Shadrack adjacent to his second wife's brother,

Samuel Cooksey. The suggestion is that, between the two censuses, he moved to be near his new wife's family.

Age of wife on census:

- A death certificate exists for the second wife, which cites her death on 27 May 1917 at the age of 96 years, 11 months, and 19 days—dating her birth to 8 June 1820. She would have turned 20 on 8 June 1840.
- The official census date for 1840 was 1 June, but rural households were visited across several months thereafter. If Shadrack's wife's age were cited as of the day the enumerator arrived and inquired, then Wife No. 2 would have been correctly entered into the 20–29 age bracket. If her age was cited to 1 June 1840, as regulations required, then her tick mark should appear in the 10–19 bracket, along with Shadrack. If the proposed Wife No. 1 was still alive, then her tick mark should also appear in the 10–19 column.

COMMENT:

Neal Williams, Jacob's son-in-law, is on Newton's 1840 census, but not the tax roll.

The census description of the Williams household is missing one daughter and one age is tallied in the wrong column. According to 1850–1900 censuses, daughter Gracie Luvicy was born in 1830; the 1900 census explicitly says *May* 1830. She and an older sister were tallied on the 1830 taken after 1 June. Neal & Polly's daughter Penny was born c1832 and is still in the parental home in 1850 (age 18), by which time Gracie Luvicy had married.

Conclusion: Gracie Luvicy in 1840 should be tallied as a female 10–15, not 15–20. Penny should be the female tallied above as 5–10.

## COMMENT:

- Neal did not purchase any Newton County land from the federal government. If he bought land from another individual, that purchase (along with its subsequent sale by him) would have been recorded in deed books that have been destroyed by Newton's several courthouse fires.
- Similarly Haden Watts took out no government land in Newton County (although he patented several other tracts in Rankin (1827), Kemper (1841), and Lauderdale (1841).

• One other circumstance existed in which a man might pay tax on land he did not own—i.e., he rented a tract under a lease that assigned the tax liability to him.

#### 1842-1846

#### COMMENT:

The extended Sessums family broke apart in this period. Neal and Polly (Sessums) Williams moved northward into Attala County. Her father Jacob Sessums and her sisters who married the Courtneys migrated to Panola County, Texas. Her brother Thomas Sessums followed them and was absent for a year or so, but returned to Mississippi. I have found no evidence that Neal and Polly went to Texas with her father and siblings.

One of the claimants for Choctaw land (and tribal status) asserted that Jacob's wife Penny died in Mississippi in 1845. No evidence has been found for her death place. For detailed evidence relating to the time frame of the move, see the previously cited research notes for Jacob Sessums & Penny Fisher.

COMMENT:

- T15 R8E lies above Kosciusko, about a half-dozen miles to the NE, along the Yockahockany River between Kosciusko and Ethel.
- Neither the Kitchens nor Fletcher neighbors took out federal land whose legal description we could use to more precisely locate Neal and Polly's residence.
- A Washington *Ellington* took out land in Section 29 of T15 R8E in 1841, according to the BLM online database.

## COMMENT:

Four years would elapse before the next land assessment roll in Madison Co.—that of 1857. In that interval, Neal Williams, as a resident of Attala Co., went to the U.S. Land Office at Columbus (Lowndes Co.) and selected a tract of federal land in Madison Co. As shown below under 1854, 1857, and 1859: he paid cash for the tract and paid taxes on it, but the patent would not be issued to him until 1859.

- I have captured the data on Simon and his consecutive tax payer Joel because one Simon/Simeon Williams appears on the 1832 tax roll of Simpson County consecutive with Neal and one Joel of Lawrence was a brother to Neal.
- Neither Simon nor Joel would appear on Rankin's land assessment roll this year. <sup>120</sup>
- Neither Simon nor Joel would not appear on Rankin's next tax rolls, 1856–57.
- Other Williamses in county: Samuel, L. D., J. W., S. S?, Thos., M. S., S. M., C. M., Rebecca, Dr. David, Charls [*sic*], P. H., A. J., John, Robert, W. J. [second of that name], W. B.
- Considering the impermanency of Simon and Joel's residence, though each was charged above with several enslaved people, they may have been overseers on the lands of absentee owners.

Witness the Hon<sup>1</sup> J M Simmons Judge of Probate of said County the 2<sup>nd</sup> Monday in February AD 1858, seal of said Court Issued 8<sup>th</sup> February A. D. 1858. John T. Cameron? ## COMMENT:

There are no further loose papers in this record set, saying who was appointed guardian or administrator of his estate. I have examined the only three relevant record books, imaged by *Family Search* or *Ancestry*, that cover this time frame:

COMMENT:

- At the time that John and Thomas Williams appealed to the court for aid with their father, neither seem to have been residents of Madison Co., even though the petition drafted by their lawyer described them as such. Neither appears on Madison's tax rolls or the census. The oldest son still at home, Solomon D., was still a minor at the time of the proceedings.
- John in 1860 resided across the county line in Leake.
- Thomas has not been found on the 1860 census indexes in any Mississippi county. Although many Thomas Williamses appear, none have compatible data.



Neal & Polly's Location in Madison County, MS<sup>126</sup>

This land lay along Hinds Creek in the corner where Madison, Leake, and Attala all meet—almost due west from the Thomastown area of Leake where Sam Odom (proposed son of Margaret Williams) lived. Neal's land is about 25 miles SW of the Attala community in which he was enumerated in 1850. (See map, p. 31.)

In search of a reason (kinfolk being the usual reason) why Neal chose this land in Madison County, I have analyzed the others who owned or entered land within a two-mile radius prior to Neal's selection of the land, using the BLM database and the 1857 Madison County tax roll.<sup>127</sup> The image numbers cited below are to the tax roll.

His adjacent landowners in Madison County were

on the EAST: W½ of **S24** was issued 1842 to John Henderson & Gordon D. Boyd; Boyd was a surveyor and large-scale land speculator operating largely in Leake and Attala. Everyone else in S24 patented the land between 1824 and 1841: Thompson Harvey, Jacob K Hill, John & William Huddleston, William W. Lloyd, Richard Ratliff, and Evan H Spencer.

on the SOUTH: E½ of NE of S26 was issued 1824 to Jacob K. Hill. Others in S26 also patented the land between 1824 and 1841 except for an Alexander C. Parker purchase in 1875, a John & Riogrande Ketchen purchase in 1881, and three Levy purchases in 1890 and 1891. The 1824–41 purchasers were Silas Allen, George Barnes, Benjamin Cooper, Enos Fletcher (NE¼ SE¼), Elisha Greenlee, William Hagan, D. Hardiman, William W. Lloyed. 1857 land tax roll includes Hardeman & Pugh J.T. (Heirs), A. C. McCurtney, Silas Allen, J. W. Hines, and J. S. Prichard. (image 124)

### COMMENT:

Ellen Williams was née Fisher, having wed Neal's son Solomon D. Williams in 1859. "Mrs. Gatlin" could be either of two daughters of Neal Williams: Luvicy who married Francis Marion Gatlin; or Penny, who married Jeremiah Gatlin.

#### 1861–1865

#### COMMENT:

No other records have been found for Neal or Polly during the Civil War years. Military records document the enlistment of at least three of their sons and the deaths of at least two of those sons in service, as well as the service of two sons-in-law. For each, see the brief biographical sketches at the beginning of this paper.

No record has been found to document the death of Neal, which likely occurred during this period, or the disposition of his land. Madison County deeds, probates, and court records all have a gap 1859–1865.

#### 11 NOVEMBER 1866 MADISON COUNTY, MS

#### Marriage record

"Sarah Ann Lecor [Leeor?] Williams" married N. C. Dees, before William Bailey, J.P. and Mayor of Canton, by bond dated 7 November 1866, for which L. T. Bell was bondsman.<sup>133</sup>

#### COMMENT:

- I have not found Dees and wife Sarah on the 1870 or 1880 censuses of any state.
- No Dees family is enumerated in Madison County in 1860 or 1870, suggesting that N.C. was not raised in Madison.
- The only L\_\_\_\_\_ Bell enumerated in Madison in 1870 was one Leonidas Bell, a 37-year-old wagon maker living in the city of Canton.<sup>134</sup> This would suggest that N.C. Dees may have been an urban laborer also. The site of Neal and Mary's land, in the NE corner of Madison Co., was about as far from Canton, the county seat, as it was possible to be and still remain within the county.

1868MADISON COUNTY, MSPersonal tax roll(p. 99)Williams, Sol1 dog, 1 free male, \$2.40 tax.Certified 7 November 1868.

### COMMENT:

This is the first personal tax roll available since 1861. The assessment covers a long list of personal property; every "male inhabitant" was charged \$2. There is no distinction between white and black, and no identification of freedmen.

This "Sol" Williams should *not* be Neal and Mary's son Solomon D. Their Solomon is said to have died in CW service, leaving a widow Ellen—neither of whom have been found thereafter.

Other taxpayers named Williams: Henry, Watt, Richd., Granville, Billy, Wiley, Calvin, Wiley [again], Dave, Bob, Jordan, Jerry, Sam. Robert, Mike, Pat, Willis, Henry, **Sol.**, William, Meclin, Jno., Jeff, Peter, Robert, Sam, Isaac, Jasper Sr. & Jr., and Henry.

#### 20 MAY 1870

#### MADISON COUNTY, MS

#### Marriage record

"Miss Sarah Williams" married William A. **Cauthen**, before W. McMurtray, M.G., by bond dated 13 May 1870 for which R. J. Cunningham was bondsman.<sup>135</sup>

### COMMENT:

This second Sarah Williams marriage is the only other Sarah Williams marriage in Madison Co. Evidence is ambiguous as to whether she might be the same-name daughter who was still at home with Neal and Polly in 1860 but the weight of the evidence appears to negate the possibility:

- Although the county records yield no deed, probate, or court record by which Neal and Polly conveyed their land, the first surviving tax roll after 1860—that of 1887, below—shows Neal and Polly's land being taxed to J. B. Cauthen.
- The 1870 census below identifies one J. B. Cauthen as a son of William A. Cauthen who had just married Sarah Williams.
- However, that 1870 census places William A. and Sarah Cauthen next door to a widowed **Elizabeth Williams**, aged 60, suggesting that the Sarah who married Cauthen was Elizabeth's daughter.
- The 1860 census shows the widowed Elizabeth Williams with a daughter Mary A. (29) and Sarah J. (23), living next door to Milton Cauthen (53), wife Sarah (33) and children—just nine houses from Neal, Polly, and their daughter Sarah. One Jno. B. Cauthen, aged 28, with \$3350 in land, lived adjacent to Milton on the other side.<sup>136</sup>
- The 1860 census shows **William A. Cauthen,** with wife Nancy and children Wm. A., James M., Ann J., Josephine, and Jno. B. living eighteen houses from the widowed Elizabeth Williams.<sup>137</sup>
- All things considered, it appears that the Cauthens who seemingly intermarried with the Elizabeth Williams family was in possession of Neal Williams' land simply because they were neighbors who had bought the land from Neal's guardian, widow, or heirs.



COMMENT:

- This is apparently the first land tax roll that survives for Madison since the 1857 roll that charged this tract of land to Neal Williams—at least no other roll appears in the imaged State Archives Collection and none are among the local courthouse tax books filmed by *FamilySearch*.
- A transfer of the land from the Williams family (or N. B. Stewart, Neal's legal guardian) has not been found in surviving deeds, probates, or court records.

# Re: Alleged Native American Ancestry

Between 1896 and 1914, about eighty-six descendants of Jacob Sessums and Penny Fisher, residing in Oklahoma, filed claims to be recognized as Choctaw—most with the Dawes Commission. All claimed to be descendants of the "full-blood Choctaw Penny Fisher, who married the white man Jacob Sessums." All claimed "family tradition." None had any evidence of any type to support their claims. As background:

"The Commission to the Five Civilized Tribes was appointed by President Grover Cleveland in 1893 to negotiate land with the Cherokee, Creek, Choctaw, Chickasaw and Seminole tribes. It is called the Dawes Commission, after its chairman, Henry L. Dawes, [and those who were approved appear on ] the "Final Rolls of the Citizens and Freedmen of the Five Civilized Tribes in Indian Territory".

Tribe members were entitled to an allotment of land, in return for abolishing their tribal governments and recognizing Federal laws. In order to receive the land, individual tribal members first had to apply and be deemed eligible by the Commission.

The first application process for enrollment began in 1896, but was declared invalid. So the Dawes Commission started all over again in 1898. People had to re-apply in order to be considered, even if they had already applied in 1896. The Commission accepted applications from 1898 until 1907, with a few additional people accepted by an Act of Congress in 1914.

The resulting lists of those who were accepted as eligible became known as the Dawes Rolls."<sup>142</sup>

The descendants of Jacob and Penny who applied for Choctaw citizenship (and free land) descended through four of their children:

- **1. Reding Sessums,** who moved to Texas in the 1840s and died 1879 in Bowie County. The principal claimant in this line was his son
  - Wilson Russell Sessums (Claim No. 452)<sup>143</sup> who first applied in 1896 under the Congressional Act of 10 June 1896 (29 Stat.L., 321); but he and his offspring were rejected. They appealed their case to the U.S. Dist. Court for Indian Territory, and on 20 January 1898, the court overturned the tribal decision and admitted them. That admission was overruled in 1906 for lack of any evidence that Penny Fisher was a Choctaw.<sup>144</sup> A more-detailed synopsis of the case *W. R. Sessums vs. Choctaw and Chickasaw Nations,* was published amid Senate Documents in 1913.<sup>145</sup>

The initial success of Wilson Russell Sessums in 1898 prompted his cousins to apply.<sup>146</sup>

- **2. Reuben Fisher Sessums,** who also moved to Texas in the 1840s and allegedly died 1873 in Fannin County, Texas. The principal claimants for this line were his sons:
  - William Thomas Sessums (Dawes Packet MCR 119, 14 pp.)
  - Reuben P. Sessums (Dawes Packet MCR 473, 25 pp.)
  - John Washington Sessums (Dawes Packet MCR 641, 18 pp.)
- 3. **Mary (Sessums) Williams,** who remained in Mississippi. Her son John Williams died in the Civil War; his widow (née Jeanette Johnson) and several children moved to Texas about 1870 and then to Oklahoma before 1900, first to the Chickasaw Nation and then the Choctaw. Two lines of his descendants joined the Sessums cousins who were already filing claims:
  - James A. J. Williams (Dawes Packet MCR 5571; also see MCR 184)
  - Dicey (Williams) Wren (Dawes Packet MCR 6153; also see 5812, 5813 5814, 5815, 6153)<sup>147</sup>
- 4. **Thomas Sessums**, who remained in Mississippi. One line of his descendants joined the cousins in filing claims. The principal representative was Thomas's son and grandson:
  - William John Sessums (Dawes Packet MCR 183, 17 pp.)
  - John Sessums (Dawes Packet MCR 184, 89pp.; also see MCR 119, 132, 183, 186, 473, 474, 475, 641, 5571, 5529)

The following offers a sampling of the depositions taken and "evidence" provided. Many of the claims were consolidated into the John Sessums case and affidavits by the other claimants appear therein.

# Choc. MCR 184, John Sessums

# 12 June 1900

Examination of claimant. Age: 64 years. Post Office: Cumberland, I. T. [Indian Territory], have lived there for 6 months. Before that, lived at Ryan, I. T. for 10 years. Before that, lived in Texas but can't say how long. Came to Texas from Missouri [*sic*]. *Father was Thomas Sessums, "part Choctaw.* I don't know what [proportion of Choctaw blood] he claimed to have [but] *I claim to be %."* 

He is married to Luticia. "**Q**: Is she a white woman? **A** No, she is a full blood Irish lady. She never was in Ireland I don't suppose." They married in Mississippi "a long time ago," but he doesn't recall when. He has no record of the marriage. The claims of his children, who live with him, have the "same foundation." They are *Maggie L* (18), *Lilly M.* (16).

"And then I have seven grandchildren that I am keeping under my control as guardian; their father and mother is dead and I have to take charge of them." They live with him. Two are Sessums, the children of his son. The "other bunch of five" are children of his daughter, *Eliza Maderis*. When asked who was Joseph V. Sessums, he answered that this was his dead son. *Joseph Virgil Sessums* (10) and *Sarah Ellis Sessums* (8) were his children. The children of his daughter [which he is said to have read "from a meme"] are *John O. Maderis* (10), *Thomas E. Maderis* (8), *Clarence Maderis* (6), *Mary L. Maderis* (4), and *Lilly B. Maderis* (1).

When pressed, John said that he does not claim under any specific treaty and does not know of any ancestor who were beneficiaries under the provisions of Art. 14 of the treaty of Dancing Rabbit Creek.

### Undated list of claimants in this set of consolidated cases

("pages" 6–11 in the imaged file)

"All of the applicants herein testify orally that they reside in the Indian Territory.

"The proof ... consists of a transcript of the court proceedings in citizenship case No. 10 [i.e., that of Wilson Russell Sessums] ... and the affidavits of W. R. Sessums and J. R. Sessums. These affidavits show the blood relationship of the applicant, John Sessums, to the affiants who are parties plaintiffs in said citizenship case No. 10; by reference to the affidavits of A. B. Sessums and **S. B. Perry** as shown by the transcript, **a conflict is found as to the residence of Pennie Sessums, nee Fisher, the common ancestor.** In the affidavit of A. B. Sessums it is averred by him that he is a descendant of Pennie Fisher a full blood Choctaw Indian woman who died in Mississippi in about 1845. S. B. Perry in his affidavit makes averrment as follows: 'knew Pennie Fisher who was a full blood Choctaw woman. She married a white man named Jacob Sessums. Didn't know the names of their children as they were small last time I saw them. I knew Pennie Fisher below Doaksville she died down there somewhere.'"

"Doaksville is located in the Choctaw Nation, Indian Territory. ... This is the only evidence disclosed by the transcript in this case as to the residence of the common ancestor. ...

"No proof, either oral or documentary, is offered to show any act of compliance on the part of the ancestors of these applicants with any of the provisions of article fourteen of the treaty between the United States government and the Choctaw tribe of Indians, concluded September 27<sup>th</sup>, 1830.<sup>148</sup>

# COMMENT:

While "Doaksville" was in Oklahoma, many Oklahoma sites carry names of earlier sites in MS. "Doaks" was also the name of a "stand" on the Pearl River in Mississippi where the Choctaw Treaty of 1821 was signed. It is now in southeast Madison Co., MS, near the boundary line that Madison shares with Leake Co.—about six miles due west of (and across the Pearl River from) the Leake Co. community of Good Hope, where Thomas Sessums and his widowed sister Mary (Sessums) Williams lived in 1880.<sup>149</sup> The land that Jacob Sessums obtained from the U.S. government in the newly created county of Simpson was land ceded by the Choctaw at the Treaty of Doaks Stand in 1821.

# 21 January 1902

# Muscogee

# (File pages 15–21)

Examination of claimant John W. Sessums [son of Reuben Fisher Sessums]. Age 44, Post Office: Ryan, Indian Territory. He has lived "in Ryan and near Ryan for about thirteen years. He is the "identical John Washington Sessums who appeared before this Commission at Muskogee, Indian Territory, August 30, 1900, and made application for the identification of [him]self and minor children as Mississippi Choctaws."

John W. claims "my grandmother was supposed to be or said to be a full blood ... Pennie Fisher." His grandfather was a white man, Jacob Sessums. He claims through his father, Reuben Fisher Sessums, who was one-half Choctaw.

He does not remember whether, in 1900, he claimed under the fourteenth article of the 1830 treaty. "I told them I knew nothing about the article, and I couldn't say whether I complied with that article or not. ... No sir ... I don't understand anything about the provisions of the fourteenth article [or] the treaty of 1830." [Details of both were explained at length to him at this point.]

"I don't know whether my foreparents have complied with it or not; I have never heard they [*sic*] say, and [was] never taught whether they did or not. I notice in some of the affidavits of W. R. Sessums [Wilson Russell Sessums, son of Reding], my cousin, in the courts, where **they claimed that Pennie Fisher and Jacob Sessums came to the Choctaw nation with the tribe, but they ... never**—my father died when I was small, that is, comparatively small, and he never did tell me anything about it whether they came to the territory or not. ... I suppose she [Pennie Fisher] died in Mississippi, but I don't know where." (pages 15–18)

"Applicant offers the joint affidavit of Wilson R. Sessums and Margaret Bailey averring that John W. Sessums et al., are 'legal heirs and representatives' of Reuben F. Sessums."

Names of children: Jacob Sessums; Mattie Pearl Sessums, William Edward, John Henry, Roy Lee. Yes, his brothers and sisters made application also; their names are William, Reuben P., Elizabeth (who married J. F. Sessums, "a son of W. R. Sessums Sr., he and his wife ... are ... second cousins"), Amanda Pettigrew, Penny Dry, and Martin Van Sessums. Reuben P.'s wife is Blanche. Both Amanda and Penny have families. Penny has appeared before the commission; he doesn't know whether "Manda J." has.

When asked whether he knows "A. B. Sessums," he replied: "I don't know whether I know him by his initials or not." He knows the children of "William Sessums deceased" and could name his children "probably by studying a little bit. I haven't been with them so long I have forgot the names of some of them—*Elizabeth Sessums* … her husband's name was A. *Harrison*. And there was *Janie Sessums*, she married a *Stephens*. … Yes sir, *J. R. Sessums* is a son of William Sessums deceased. … Yes sir, *Buchanan Sessums* … and there was one they called *Alex* but I don't remember his initials. He was just a lad like when I saw him last. … *Mattie Sessums* who married *Fleming* was [also a daughter who is] party to this suit." [William Buchanan Sessums was brother of Reuben Fisher Sessums, both sons of Reding.]

"**Q** Do you know any of the children of *Thomas Sessums, deceased*? **A** No sir, I don't." [Thomas, the older brother of the claimant's father Reuben, had remained in Mississippi.]

"Q Do you know John Sessums? A I know a John Sessums ... he's somewhere about sixty probably; upwards of sixty. ... [His children are] William John ... Eva Goodwin, Thomas R. Sessums, and there [is] a single girl at home—Lillie Sessums, and Maggie. ... They made application before the Commission."

When pressed, the claimant said he knew nothing about whether his ancestors complied with provisions of the treaty, etc.

Interrogator's note: "The applicant has light brown hair mixed with gray, grayish blue eyes, fair complexion, and doesn't speak or understand the Choctaw language."<sup>150</sup>

#### 21 January 1902 Muscogee

(File pages 21–24)

Examination of claimant **William Thomas Sessums.** Age 42, post office: Colgate. Same man as the "William Sessums, forty-one years of age, post office Coalgate, Indian Territory, heard at Atoka, Indian Territory, on June 6, 1900." When told that he made his earlier claim under the fourteenth article of the 1830 treaty, he responded: "Don't know nothing about that fourteenth article." When asked whether he heard the examination of "your brother who just preceded you" [John Washington Sessums], he said *yes*.

The long explanation of the fourteenth article was read to him, after which he said "I don't know sir, whether they did or not." Yes, **he claimed through Pennie Fisher**, who was his grandmother. No, he didn't know whether she got any land as a Choctaw. Yes, he made application at Atoka in June 1900 for his children also. Those children are *Laura Estelle*, *Julia Evaline*, *Viola May*, *William Wesley*, *Hardy Clifton*, *Joy*, *Bert*, *Elmore*, and Edna. Yes, the last two are twins. Yes, he wants the evidence submitted in his brother's claim to be considered in his and for their cases to be considered together.

Did he make a claim to the Choctaw Tribal council? Answer "Nothing only through McPherren … my attorney." No, he doesn't know whether McPherrin made application with the tribe on his behalf. No, he was not "a party … in the case of W. R. Sessums et al. vs. Choctaw Nation." No, he does not know where Pennie Fisher died or whether she was living and a head of family in 1830, or where she lived in 1830. "I was small when my father died." No he does not know whether Pennie Fisher made any compliance with article 14. No, he has no other proof aside from the transcript of the proceedings in the case of W. R. Sessums et al. vs. Choctaw Nation.<sup>151</sup>

### 21 January 1902 Muscogee

## (File pages 24–29)

Examination of claimant **Reuben P. Sessums.** Age 36 "this coming April." Post office: "Wayne, now. It was McGee." Have lived in Indian Territory since '87, that is, permanently; nowheres else since '87 and have been in and out ever since '83." He is the same Reuben P. Sessums who appeared before the Commission on 21 June 1900 at Colbert, Indian Territory, applying for identification as Mississippi Choctaws for "self and [his] minor children and [his] brother Martin Van Sessums." Also applied for "intermarriage rights" of his wife. He made no application before this to any other Commission of the Five Civilized Tribes. "We sent once to meet you at Caddo, the year before. And by McPherren putting us off—[saying] that he would present the papers—but still he didn't put it before you. [He was] Charles E. McPherren ... a Lawyer," not connected with the Commission, just acting as "our attorney." "That was in August '99; I guess."

On what did he base his claim? "Well ... I had always been taught, that my father was a Mississippi Choctaw and that if he ever derived any land or anything of the kind why that was more than I know anything about."

Was his father "a member of the old Choctaw tribe of Indians living in Mississippi? A Well he ought to been according to our knowledge. He was raised right there in Mississippi." Q "What right did that give your ancestor and give you as Mississippi Choctaws? A Well he was Mississippi Choctaw—Choctaw raised there."

After the explanation of the fourteenth article was read to him, he was asked if that's what he claimed under and he responded "Yes sir." **He was claiming under Pennie Fisher.** Didn't know whether she got lands under the treaty. As for whether she "was married and the head of a family at that time," he responded "Why, I guess she was."

Yes, he's a brother of William Sessums and John Washington Session who also appeared that day. The children for whom he made application at Colbert in June 1900 were *Levinia Burnice; Allen Sessums, Lettie Evaline* (yes, she's the same as "Leta" from the 1900 claim). Yes, he's a cousin to the W. R. Sessums "who was ordered admitted to citizenship by order of the United States Court." Yes, W. R. Sessums Sr. is the father of W. R. Sessums Jr. No, no other member of his family was party to that suit. Yes, Mary E. Harrison and Martha Fleming who were admitted in that suit are his cousins.

Any other evidence to present? "Well, I would like to state about W. R. Sessums there [Wilson Russell Sessums]—the old man W. R. Sessums—I went to get him to come up here and he said he thought it was

of no use as they had his testimony. He is old and in very poor health. ... He said that as he was in such feeble health ..." [cut off at this point by another question]. Yes, Penney A. Dry and Manda Jane Pettigrew are his sisters.

Note by interrogator: "This applicant has light brown hair, bluish gray eyes, fair complexion, features and appearance of a person of white parentage and doesn't speak or understand the Choctaw language."<sup>152</sup>

# INDIAN TERRITORY

## 15 MAY 1902

# Choctaw MCR 5571, James A. J. Williams:

Examination of claimant. Age: "Will be fifty-five in June," receives his mail at Morvin, Oklahoma, where he will have resided for "ten years in June." Before that, he lived in the Chickasaw Nation for four years and before that in Texas.<sup>153</sup> He was "born and raised in Mississippi" and left when he was 23. His father, John Williams, "died in the Civil War." His mother is Jeannette Williams. He claims Choctaw blood through his father, saying "my grandmother was a half breed."

James stated: "I claim that **my grandmother was a daughter of Penny Fisher;** it was a name that was kept up in the Fisher family." His grandmother was Polly Sessums who married Williams. When pressed, James stated that

- He does not speak the Choctaw language.
- He knows of no family member who was enrolled in the Choctaw tribe by tribal authority; but (when asked if any of his ancestors complied with the 1830 Choctaw treaty), his answer was "Any of my aunt's sisters." He did not name that aunt.
- He did not know the name of any "Choctaw ancestor who lived in Mississippi or Alabama in the old Choctaw nation in 1830 and was the head of a family there then."
- He did not know any who went to the "Choctaw Nation West of the Mississippi River with the other Indians between 1833 and 1838."
- He did not know of any ancestors who held land under the Choctaw Treaty or received scrip for land in "Mississippi, Alabama, Louisiana, or Arkansas as a result of treaty-claims adjudications of the 1840s."
- He has no proof of the marriage of his father and mother, does not know when they married, but they married in "Keller County" Mississippi (Atalla County).
- His wife Henrietta is a white woman. They were married in "Keller County" by a minister, under license.
- Their unmarried, minor children are *Walter* (15), *Dovie* (12), *Calvin* (10), *Mertie* (7). Their adult and married children are *Millie Boggus*, living "up in the Pott Country of Oklahoma, p.o, Morvin, who is

not a claimant; *Ida Henderson*, "Tom Henderson's wife" (who has filed a claim of her own) and other "sons and daughters that are married."

• He knows the two claimants "John Sessums. One is "a nephew of **Russ Sessums**" [Wilson Russell Sessums] and the other a son of Reuben Sessums. "One of them [one of the Johns] is a second cousin to me and the other one is a third cousin. The father of the third cousin was William Sessums.

The interrogator, G. Rosenwinkel, wrote: "This applicant has the appearance and physical characteristics of being descended from white parentage. He has dark hair, somewhat gray and gray whiskers and mustache, the applicant says his whiskers were formerly black; he has brown eyes."

# 21 June 1902

### Indian Territory, Southern District

Affidavit of **W. R. Sessums** and **J. F. Sessums** attests "This man **James Williams** claiming a right is a second cousin to me W. R. Sessums. And a third cousin to J. F. Sessums. And is a son of John Williams and John Williams is the son of Polly Williams and Polly Williams was the daughter of Penny Fisher and **Penny Fisher** was a Choctaw woman who married a white man by the name of Jacob Sessums.

#### 6 June 1902

### Muskogee, Indian Territory

#### (Sent by registered mail)

Letter to James A. J. Williams from "Tams Bixby, Acting chairman," notifies the claimant that a decision has been made in the "consolidated case of

Also: "under the provision of law above quoted, no person is entitled to identification as a Mississippi Choctaw by marriage, and [thus] the application made by Reuben P. Sessums for the identification of his wife Blanchie Sessums, as an intermarried Mississippi Choctaw, should, therefore, be refused, and it is so ordered."

**The claimants,** who applied "under the provision of the act of Congress of June 28, 1898 (w) Stats. 495)" **have not produced the required evidence to support their claims and are therefore denied.** The letter provides a long list of all claimants who participated in these eleven cases.<sup>154</sup>
