BACKGROUND: Core list of names provided by:

G. Glenn Clift, Kentucky Soldiers of the War of 1812 (1931; reprinted, Baltimore, Genealogical Publishing Co., 1969), 344–45, citing "Roll of Captain B. W. Sanders' Company, Kentucky Infantry—Commanded by Colonel John Miller," a payroll spanning

1 June 1814–31 October 1814, no place stated.

TASK: 1. Extract service data on each fellow soldier from:

Register of Enlistments in the U.S. Army, 1798–1914, National Archives microfilm publication M233, 81 rolls; accessible as "U.S. Army Register of Enlistments, 1798–1914," database and images, Ancestry.com.

- 2. Attempt to locate each individual's place of residence in the 1810–20 period, using U.S. censuses and other resources.
- 3. Check each individual against online bounty-land warrant databases at *General Land Office Records* (www.glorecords.blm.gov) and *Ancestry.com*.
- 4. Check each against the available War of 1812 pension files at *Fold3* (a digital collection that is still seriously incomplete).

OBJECTIVES: 1. Determine where Lt. James Hackley recruited Samuel Witter on 4 April 1814.

2. Create a basic profile of each fellow soldier as a base for research in the pension files and other resources that might connect them to Witter or otherwise assist in

his identification.

#### **OBSERVATIONS:**

- Hackley's recruiting station was at Russellville in Logan County, Kentucky.
- Recruiters were not assigned to every county. A recruiter typically was responsible for a section of the state and did recruiting throughout his section. The 31 March 1814 duty roster states that he was "at Logan and Christian" counties.
- A three-week gap (29 March-18 April) exists between the only two Logan or Christian County recruits that can be proved for Hackley. Witter's recruitment falls within that gap.
- Lewis Parker was recruited on the same day as Witter; no evidence found for Parker's location.
- . Thomas Cravens was recruited one day after Witter and Parker. He was a lifelong resident of Jessamine, having been born in the part of Fayette County (seat: Lexington) that became Jesssamine.
- Presumably, Witter and Parker's location was within a one-day ride from Thomas Cravens.
- Jessamine County, adjacent to Fayette on the southwest, lay along the road from Hackley's station at Russellville to his Lexington headquarters.

A comparison of Witter's service summary to those of all men in this unit results in several corrections and additions to Witter's entry. His fuller chronology would be as follows:

#### COMMENT:

The referenced pension case has not yet been found. Nor have I yet found the pension cases for most of his fellow soldiers whose Enlistment Register entry asserts a pension.

- Received invalid pension, 1830, Fayette Co., Ky.
- Enlisted Madison Co., Ky.
- "Marched to Lexington, from there to Detroit & from there to Machinaw & then back to Malden & from then to Fort Erie & afterward sent to Buffaloe & from there to St. Louis ..." [This Buffaloe to St. Louis dispatch is the point at which he and Witter's unit parted company.]
- Richard Kinney, fellow soldier, also in Fayette Co., filed affidavit for him on 24 May 1830.
- Circa 1851 affidavit for bounty land, Baker said "he gave his discharge to Capt. Holder to obtain his land Bounty Warrant."

Holder, [but] can't say whether he gave him a power of attorney." Richard Holder died shortly after, and Baker "called on Holder's wife to get information and she stated she knew nothing about them."

*Note:* Hackley enlisted Cason on 28 March and lago on 19 April. They bracket Witter, timewise. Both are in same county, Logan, but they were recruited 3 weeks apart—which allows time for Hackley to canvass a far broader area. These are the only 2 men of Sanders's Co. who have been placed in Logan County.
