SUBJECT Mills & Associates: Botetourt County, Virginia: Initial Survey

BACKGROUND: This project centers upon two William Mills lines in south-central and western Virginia, with two goals:

- separating them from other same-name inviduals.
- correctly reconstructing their birth families and origins.
- 1. William Mills (c1695–1756) who settled land on Lickinghole Creek in Goochland County about 1728, patented the first of that land there in 1732. In 1744, he disposed of the last of his Goochland land and migrated west to Pedlar River of the Albemarle (later Amherst). His offspring by wife Mary (possibly née Walton) are well proved: AMBROSE MILLS, c1721, migrated to Wateree River, SC, then Rutherford Co., NC, Loyalist colonel hung at Kings Mountain; THOMAS MILLS, c1723–24, d. by 1755; SARAH "SALLY" MILLS, c1726; married Thomas Watts, moved to Wateree River, SC; WILLIAM "BILLY" MILLS c1728, migrated to Rutherford Co., NC, also hung as a Loyalist shortly before the King's Mountain battle; ELIZABETH MILLS, c1730, married Thomas Learwood and John Ripley, migrated to SC; ANNE MILLS, c1732, married Lewis Witt, lived in Bedford Co.; MILDRED "MILLY" MILLS, c1734, married William Lavender and William Walton, migrated as a widow to Maury Co., TN; JESSE MILLS, c1736–40, married Lucy Tilman, remained in Amherst.¹

This William Mills is often erroneously merged with Millses of Augusta County who also owned land in Bedford and Lunenburg. The land of the Augusta Millses fell into Botetourt in 1770.²

2. William Mills (b. c1784–88), first emerged in 1806 as a young tithable in Franklin County, adjacent to Botetourt. His birth family is unproved. His Y-line descendants carry a Witt/Whitt Y. To distinguish him from other William Millses under study, I am referencing him as William Mills-Witt.

William married 1815, in Franklin Co., **Drucilla Kemp**, daughter of Robert Kemp and Millie **Edmundson** (daughter of Richard) who wed 1786 in Franklin. Drucilla's stepmother was Sarah **Mattox** (daughter of Nathan, formerly of Bedford), who married Robert Kemp in 1802. Bondsman for William's marriage to Drucilla was

Stephen **Standifer,**³ whose family migrated from Bedford to Henry before being cut away into Franklin.

William and Drucilla disappear from Franklin County records in the 1820s but reappear in 1829 when she inherited land. About 1848, they left that land for adjacent Floyd County. In 1860 they were in Pulaski County, living on land of the wealthy planter Gordon Floyd, where William appears to have died c1863. In 1867 Drucilla died in Montgomery Co., 1867, at which time the son-in-law who reported her death, **George Bradberry**, stated she was born in Montgomery. (That birthplace is provably wrong for Drucilla but *might* reflect the informant's confusion over the birthplace of his in-laws, projecting upon his mother-in-law the birthplace of his previously deceased father-in-law.)

Offspring of William and Drucilla were JAMES H. MILLS, c1816; d. after 1844; SAMUEL E. MILLS, 26 February 1818; m. Mary Ann Hobson 1841 in Franklin Co., settled in Upson and Meriwether Cos., GA (progenitor of my in-laws); WILLIAM B. MILLS, c1820, d. 1865, Civil War; ROBERT WILLS MILLS, c1824, m. Mary Jarrett, daughter of Allen, d. 1862, CW; SPARRELL MILLS, c1826–27, m. 1848 Martha Susan Jarrett, d. c1900 Montgomery Co., VA; CHARLES T. MILLS, c1828–33, m. Sarah E. Fleeman in Montgomery Co., moved to Claiborne Co., TN; SARAH "SALLIE" MILLS, c1829, m. George Bradberry; d. after 1870, Montgomery Co.; MILLY FRANCES MILLS, c1830–33, m. John B. Lawrence in Floyd Co. 1854; THOMAS R. MILLS, c1834–36, m. Sarah Nunley, d. allegedly 1915 Pulaski Co.

All these counties where William and children resided after leaving Franklin were cut out of Botetourt > Montgomery. Gordon Cloyd, for whom he and his son Thomas farmed in 1860, was the son of Gen. Gordon Cloyd of Giles and Pulaski and grandson of Col. Joseph Cloyd who first appears in Fincastle shortly after it was cut from Botetourt.

ASSOCIATES: The Millses with known ties to Boutetourt prior to this project include

- John Mills Sr., who first appeared in Lunenburg Co. in 1749 in company with a William Mills; Edmund Smith (wife Ann and son Henry), William Hays, John Beard, and Robert Ewing, Esq. When Bedford was cut away in 1754, he and Ewing fell into Bedford. His Bedford activities (1753 and 1764) involved Alexander and William Sayers of Augusta Co. In 1769, he sold his Bedford land, at which time he identified himself as a resident of Augusta Co—apparently the part of Augusta that became Botetourt, where his probate was opened in July 1782.⁴
- John Mills Jr., who appeared in Bedford as a young adult in 1777. He bought land
 and married Patty, the daughter of Robert Ewing. After Ewing's death in 1786, he
 and Patty sold their Bedford land, saying that they were then living in Botetourt Co.
 (cut from Augusta in 1770). I've found no evidence to identify the person who

would have leased John and Patty's Botetourt land while they lived in Augusta.

James Mills of Bedford (1782–85 tax rolls) and Franklin (1786–1823), who owned land on Maggoty Creek about ten miles from William Mills-Witt and his Kemp inlaws; no association has been found between the two sets of Millses in Franklin County. James's wife is widely said (without evidence) to have been Octavia Breckinridge. The Breckinridges were a prominent contemporary family centered in Augusta, Botetourt, and Montgomery. The life style of James Mills of Franklin was not that of the Breckinridges.

TASK:

Survey materials available at the Library of Virginia, to the extent that time allows, beginning with the published literature available for the county.

EXECUTIVE SUMMARY

This brief review, which began with the few Botetourt resources in my personal library and extended to include onsite work at the Library of Virginia and supplemental work online, has helped to separate the Millses of Augusta > Botetourt from those of Augusta > Fincastle > Montgomery. This summary recaps what is now known and links to findings from recent research in other locales. In brief:⁸

- The associations and lifestyle of the Botetourt Millses differed radically from the Montgomery County families that began with two unattached Mills females.⁹
- No direct evidence has been found to connect William Mills-Whitt of Franklin County with the William Mills family of Goochland > Albemarle > Amherst that intermarried with Witts.
- A possibility remains that the James Mills of Bedford and Franklin Counties, whose wife is alleged to
 be a Breckenridge, may be the James Mills who appears twice in Botetourt: first, at his 1784
 marriage to Elizabeth Phipps, daughter of Josiah; and second, in the 1789 will of Samuel Baldwin
 who named James Mills as the brother of his wife.

Within this summary, information from prior reports are footnoted to that particular report. For the new findings, documentation and fuller details are found in the research notes section of **this** report—chronologically arranged—and can be located easily by using the date referenced in this summary.

MILLS OF BOTETOURT COUNTY:

This Mills family, present in Botetourt records from its creation, is solidly rooted in Augusta County. Members include:

- William Mills, who took out land on Clark's Creek of Anson Co., NC (later Mecklenburg and Tryon).
 William died on Clark's Creek by 1765, without completing title to his land. Probate and deed records of Mecklenburg and Tryon identify his heirs: 10
 - 1. John, a young son who would eventually inherit his land.
 - 2. Sarah, who married John Leek.
 - 3. Ann, who m. James Lockhart.
 - 4. Jeanne (m. Powers Lamkin.

This William is the same William Mills of 1749–50 Lunenburg, to whom John Mills [Sr.] made a payment from an estate he was administering; all known evidence compatibly suggests that he was "son William" named in the 1757 will of Augusta's Gilbert Mills.¹¹

This William should *not* be a sibling of Hugh, Blaney, and John Sr., below. In 1751, when this William prepared to leave Virginia for NC, he gave his power of attorney to "my trusty and loving friend" John Mills. ¹² That term was used in his era for cousins and other relationships, but not for brothers.

- Hugh, who patented land on Clark's Creek of Anson in 1761, contemporaneously with William. In 1771, he sold that NC land, identifying himself as a resident of Botetourt. His will was proved May 1785 in Botetourt, naming brothers Blaney and John Sr. "dec'd," along with John's son Hugh.¹³
- Blaney (Bleney), who also settled in Anson, sold land there with William as his witness, and obtained land on Fishing Creek of Anson Co., which later fell into SC. (Blaney/Blenny as a surname is also found contemporaneously in Albermarle Co., VA.) He subsequently returned to Augusta, after which his residence fell into Botetourt. He died after the will of of Hugh Mills (proved Mary 1785) that named Blaney as his brother.
- **David Mills**, who married Nancy Hayes, with John Hayes as surety on 4 April 1797. The Hayes association suggests he was an offspring of John Mills Sr. who associated with Hayes in Lunenburg.
- John Mills Sr., who appears to be the Lunenburg > Bedford resident of 1745–66, discussed in the background to this report. In May 1774, he was executor of the estate of Irvin Patterson in Fincastle. He died about July 1781 when the court appointed appraisers for his estate; the appraisal was filed in Botetourt in February 1782. His offspring appear to include
 - 1. John Jr., who married Martha "Patty" Ewing, daughter of Robert of Bedford, in 1772 Botetourt and administered the Fincastle estate of William Beard, March 1775. He was a militia captain in Botetourt during the Revolutionary War. (Other Ewings also appear in Botetourt and Fincastle during that period—notably James.) This John Mills is the John Jr. discussed in the starting-point information above.
 - **2. Hugh Mills,** son, cited in the 1785 probate of the will of his uncle Hugh, who explicitly said that his heir Hugh was the son of his "brother John, dec'd."
- James Mills, who married Elizabeth Phipps, daughter of Josiah Phipps on 24 March 1784. He was named in 1782 as a militiaman serving with "Joshua" Phipps under Capt. John Mills, 37th District. He appears to be the same James named in the 1789 will of Samuel Baldwin as brother of Baldwin's wife Mary. *Possibly*, he is the James Mills taxed in Bedford, 1782–85 and thereafter in Franklin.
- William Mills, who married Sarah Lemox, with her brother Wm. Lemox as surety, on 20 May 1788.
- Narcissa Mills, daughter of John [Jr.?], who married Robert "Sinoggin," 29 June 1797.
- Sydney Mills, daughter of John [Jr.?], who married George Stepp, 27 June 1803.

Additionally, a published aggregate list of taxpayers for 1780–86 includes:

• Mills, Mary for 1780 and 1781, said to be a resident of the 37th Dist. (In evaluating Mary, we have to consider that white females were not tithables. They appear only when they owned taxable property; but single females almost never appear in this regard. More typically, a female named on a tax roll was a widow.

14 FEBRUARY 1770 BOTETOURT COUNTY, VA

Road order.

"This Court doth appoint the several Persons to be Surveyors of the Roads as followeth to wit, ... Andrew Woods and **John Mills** from the said [Little Pine] Run to the Ferry [Ingles Ferry]." ¹⁵

11 JANUARY 1771 BOTETOURT COUNTY, VA

Estate Appraisal

Robert Looney decd. Appraisal by **John Mills Sen.,** James Smith, John Looney Jun. Recorded March 12, 1771. Teste: John May CBC."¹⁶

14 MAY 1771 BOTETOURT COUNTY, VA

Road order.

"Ordered that John Looney be appointed Overseer of the Road in the Room of John Mills Junr." 17

COMMENT:

This is likely the period that John Mills Jr. left for Bedford, where he married Patty Ewing. He did not remain long after his marriage.

11 OCTOBER 1771 BOTETOURT COUNTY, VA

Road order.

"Ordered that **John Mills**[,] Andrew Boyd and William Cross do View the Road to James River by Colonel Skillerns plantation and report the Convenience and inconvenience to the next Court." 18

13 DECEMBER 1771

BOTETOURT COUNTY, VA & TRYON COUNTY, NC

Land sale.

Hugh Mills of **Botetourt Co.,** Colony of Virginia, to **John Boyd** of Tryon Co., N.C. for £50 NC money, 350 A on **shady branch** of **Clark's Creek** adj. *Daniel Warbrights,* granted to sd. Mills 10 Apr 1761 ... Hugh Mills (seal), Wit: *William Ramsey, Joseph Love, John Andrew.* Rec. Apr. term 1774."¹⁹

COMMENT:

In past work on Botetourt (later Montgomery), I found the Boyds to be kin to Fergusons and inlaws of the McCarrells, in whose company William Mills-Witt of Franklin first appeared in 1806.

14 JANUARY 1772 BOTETOURT COUNTY, VA

Marriage.

"John Mills and Martha Ewing, dau. Robert Ewing (of Bedford)—Jan. 14, 1772."20

COMMENT:

This John Mills was John Jr., formerly of Augusta, Bedford, and Lunenburg.²¹

14 AUGUST 1772 BOTETOURT COUNTY, VA

Road order.

"Ordered **John Mills**[,] James Smith and **John Mills Junr** being first sworn before a Justice of the peace for this County to view the Road from Mr. Boyds by a ford above Crows near the old still House into the Road between Crows and the Courthouse and make Report of the Conveniences and inconveniences of the same to the Court."²²

7 NOVEMBER 1773 BOTETOURT COUNTY, VA

Association.

"Breckenridge, Robert. Pro[bate of will] Nov. 7, 1773. Names wife, Lettice, and ch. William John, Alexander, Robert, James, Preston, and Elizabeth."²³

COMMENT:

Note that this family contains no **Octavia Breckenridge**, the maiden name alleged for the wife of James Mills of Bedford and Franklin Counties. The ages of those Mills children suggest that their mother was of the generation of the children and heirs named above.

11 MARCH 1777 BOTETOURT COUNTY, VA

Road order.

"William Leagerwood (Ledgerwood?) is appointed Surveyor of the Road from his House to the Division of the Road in the Room of James McAfee[,] **John Mills Junr** from the Beaver Dams to James River, James Leatherdale Junr from the said Beaver Dams to Moores Creek & Wm McClelan from the said Creek Mrs. Breckenridges."²⁴

11 FEBRUARY 1778 BOTETOURT COUNTY, VA

Road order.

"Ordered that John Smith[,] John Compton & **John Mills** being first Sworn to view the Shore on Wm Adersons side of James River and Report to the Court the most Convenient Landing place for a ferry from Crows Land." ²⁵

COMMENT:

This John Mills should be John Sr., the long-time resident of the part of Augusta County that became Botetourt.²⁶

1780–1786 BOTETOURT COUNTY, VA

Militia & tax rolls.

"The original documents, from which I copy these names, are old and faded, and many are very hard to discipher [sic]. From year to year, the same man's name may be spelled differently. I have tried to use what appears to be the spelling most used. I did not copy the "Jr." and "Sr." when used, because, this, also, may change from year to year. [!] Some Captain's lists for some years are missing, some are not dated, and others lack the Captain's name. I have placed the undated, unnamed ones in the most logical places. In some years, the tithe tax was levied twice.

"Following each man's name are dated columns from '80 through '86, in which are entered the number of the Company in which he was taxed. Next is a column headed 'M.D.'; if he was eligible for the 1782 draft, I enter his Military District here. The last two columns, headed '82 and '85 are for the number of acres he was taxed with for those years. Usually, when there are more than one person with the same name it is not possible to tell to whom the land belonged. In that case, the land is listed after the first one listed."²⁷
