SUBJECT Mills & Associates of Floyd County, Virginia: Conner, Idding, Key, Light, Smith (Bird &

John), Walters, Wilson

PRINCIPALS: William Mills, born c1784–88,¹ allegedly in Franklin County, Virginia;² died c1863, likely

in Pulaski County, Virginia.³ Parents unknown. He does not fit into any Mills family or couple established in Franklin or surrounding counties. Male-line descendants of two separate sons carry Y-DNA (haplogroup I-L338) with markers matching offspring of the Witt/Whitt family that spread through numerous counties in central Virginia.⁴ My working hypothesis is that William (whom I reference as William Mills-Whitt to distinguish him from other same-name men) was born to a Mills female and a Whitt

father who did not wed.

Drucilla Kemp m. William Mills *c*24 August 1815 (date of bond; return not filed). She was the daughter of Robert Kemp⁵ and Milly Edmundson who m. 2 November 1786.⁶ Her stepmother was Sarah Mattox who married Robert Kemp on 9 December 1802.⁷

More recently, Clay and Dan are an exact match, on the 111-marker test, to Edward Eugene Mills, a male-line descendant of William and Drucilla's son William B. Mills—thereby confirming that William's Y was also the Witt/Whitt Y.

No. 15, p. 391b, fam./dwell, 204/204, dated 25 July 1850, cites his age as 62—suggesting that his birth was between 2 June 1787 and 1 June 1788. He first appears as a tithable on personal tax rolls in 1806, placing his birth by 1788 or by 1785, depending upon whether Franklin that year considered 18 or 21 to be the tithable age. The state law did not require the charging of tithables, leaving it to the county, and the county's roll this year does not state the tithable age.

Pratt has established his Y-line descent from Elizabeth Pratt and Henry Witt, b. c1762 to Lewis and Ann (Mills) Witt of Bedford County; see Pratt, "Finding the Father of Henry Pratt of Southeastern Kentucky," *National Genealogical Society Quarterly* 100 (June 2012): 85–104. In backtracking the Y-lineage of Clay and Dan (Gary Bernard Mills < Harold Garland Mills < Hugh E. Mills < Joseph H. Mills < Samuel E. Mills < William Mills & Drucilla), I find no Mills couple or female past puberty in the direct line who can be placed in proximity to a Witt/Whitt male at the time a direct-line son was born—until we reach the generation of this William Mills who married Drucilla Kemp.

The 1850 census places William, Drucilla, and their family in a cluster of interrelated families, with the following two individuals as adjacent neighbors:

- Samuel Light, 30, constable (b. Floyd) \$500; Margaret [Smith⁸] 23 (b. Franklin); Furdinand 6, Henry 4, McAlin? 2, Angeline 1/12 (b. Floyd)
- Henry Iddings, <u>38</u>? (b. Penn.) farmer \$1500; Charles Vest 30 (b. Franklin); Martha [Idings]⁹
 Vest 49 (b. Floyd), Children 8 to 16 (b. Floyd), Polly Idings 51 "Ediot" (b. Floyd).

TASK:

Comb online resources for Floyd County, with principle resources being at FamilySearch.org and Ancestry.com. Include the Lights and Iddings to determine

- what drew William and Drucilla to live among them; and
- whether they offer any clues to William's origin and birth family.

CHILDREN:

Children of William and Drucilla:10

- 1. **JAMES H. MILLS,** b. *c*1816; first appeared on Franklin Co. tax rolls, adjacent to William, in 1837. He has not been found after the Franklin roll of 1844. (Drucilla had a brother named James Kemp.)
- SAMUEL E(DMUNDSON?) MILLS, b. 26 February 1818; died 31 July 1894, Talbot Co., GA; married
 Mary Ann Hobson, 17 December 1841, Franklin Co., VA, with James Patterson as bondsman; (2) Rebecca Amy Collier, 19 March 1868, Upson Co., GA. (Samuel was not a male name used by the Kemp family.)
- 3. **WILLIAM B(RECKENRIDGE?) MILLS,** b. *c*1820, makes his first appearance in Franklin on the 1841 tax roll, appeared again in 1842, was dropped in 1843, was back again in 1844; and on 19 October 1847, in Franklin County, he married **Mary M. Matthews.** He died of gunshot wound on 30 April 1865, while returning home from war. (The name "Breckenridge" is assigned to him by tradition; all known documents call him simply "William B.")
- 4. SPARREL MILLS, b. c1824, Franklin Co., VA; first appears on the Franklin Co. tax roll of 1845; married Martha Susan Jarrett, daughter of Allen Jarrett, 1848, in Henry Co., VA. In 1850, he and his inlaws and parents were all in Floyd Co. In 1852–54 he was taxed in Montgomery Co. The 1860 census of Montgomery cites him as a laborer, living among other laboring families, apparently on the substantial farm of Andrew J. Lucas. Postwar, he remained in Montgomery, and died after 3 May 1900, when he filed an application for a Confederate pension as a resident of Radford. (The first usage of the name Sparrel as a given name in

Many online trees erroneous assign two other "sons" to this couple: Larkin Preston Mills (said to be b. c1814, husband of Hannah Wimmer) and Anderson Mills (said to be b. c1816, husband of Hannah Smith and Sarah Gearhart). However

- Franklin County appears to be the 1798 birth of a son to the prominent John and Theodocia (Saunders) Hale—Theodocia being the daughter of Col. Peter Saunders and wife Mary Sparrel. By the time Sparrel Mills was born, many families unrelated to the Saunderses and the Hales were giving that name to their sons.)
- 5. ROBERT WILLY, b. c1826; died 31 May 1862, Battle of Seven Pines near Richmond. He married 18 December 1843, Henry Co., VA, Mary Jarrett, daughter of Allen Jarrett. In 1850, as "Wiley Mills," he farmed in Floyd Co.'s militia district 15 (Beaverdam Creek, allegedly). He enlisted at the Floyd Co. courthouse on 14 March 1862 (age 36) in Co. A, 24th VA Infantry, under Lt. G. M. Helms. (No basis is known for his name; several Robert Wileys lived before him in Botetourt, Montgomery, and Giles Counties.)
- 6. CHARLES T. MILLS, b. c1828, or 1833, Franklin Co., VA; married Sarah E. Fleeman, daughter of Elias and Patsy Fleeman," 22 December 1857, Montgomery Co., where they were enumerated in 1860. By 1870, they had moved to Claiborne County, TN, by 1870. Both died after the 1880 census of Claiborne. (No family basis is known for his name. One Charles Taliaferro was a prominent resident of Franklin at the time of his birth.)
- 7. SARAH "SALLIE" ANN MILLS, b. ca. 1830, m. in Floyd Co., c16 December 1850, William H. Key, (parents unidentified). The 1850 census of Floyd places William, 23, "born in Giles Co.," in the home of George Key, 36, and wife Hannah Kester, adjacent to Sparrell Mills and his Jarrett in-laws. In 1860, the Keys lived in the Mills-Jarrett family cluster in Pulaski County's Western District. On 6 April 1864, as "Sarah A. Key," age 35, daughter of "William Mills" and "Drucella Mills," she m. a widower from Lovely Mount (now Radford) in Montgomery Co., George Bradbury (var. Bradberry), son of Mark and Mary. Sarah died 1 July 1889 in Summers Co., WV. (Any argument that Sarah might be named for William's mother is weakened by the fact that Sarah was also the name of the stepmother who raised Drucilla.)
- 8. MILLY FRANCES MILLS, b. April 1832 (variously 1830, 1832, 1833) in Franklin Co., VA; died after the 6 June 1900 census visitation and, apparently before the April 1904 death of her husband whose obituary cites children but not a wife. On 27 July 1854 (by license of 22 July) in Floyd Co., VA, Milly married John B. Lawrence, who had been born in Bedford Co., VA, as son of William and Agnes Lawrence. (Milly was the name of Drucilla's mother-inviting speculation that Frances might be the name of William's mother.)
- 9. THOMAS R[ICHARD?] MILLS, b. 11 March 1833, according to his death certificate; married ca. 27 August 1855, in Montgomery Co., Sarah S. Nunnally [var. Nunley], daughter of Richard and "B" Nunnally. The couple are cited on the 1860 census, Pulaski Co., VA, next door to both sets of parents. In 1880, they resided in Montgomery Co.; in 1900 they lived in Pulaski Co. where he was employed as a "river ferryman." Thomas died 5 April 1915 of "chronic Bright's disease." (Thomas was a name used within the Kemp family. Richard was the name of Drucilla's grandfather Richard Edmundson).

SUMMARY OF FINDINGS

- One William Mills appears intermittently in Floyd, 1840–48. Apparently a young to middle-aged man (judging by the fact that he was charged with brawling), he is coupled with Larkin and Anderson Mills. Meanwhile, an unidentified William Mills, husband of Mary "Polly" Showalter/Shewalter, appeared in Franklin 1833–37, where he was called William "Jr." to distinguish him from William Sr. of the Maggoty and Elliott's Creek.¹² His location on Elliott's Creek of Franklin placed him in proximity to Larken Mills (Franklin 1833–38 tax rolls & 1840 census) and Anderson Mills (Franklin 1841–42 tax rolls). That location also suggests the possibility that they were sons of the taxpayer Nancy Mills, widow of James Mills Jr.; as noted earlier, Anderson's 1859 marriage license in Floyd names his mother as "Nancy."
- William and Drucilla Mills appear to have moved into Floyd between July 1848 (his last appearance
 on Franklin County's personal tax roll) and 9 February 1849 (when he and his son Sparrel both
 turned in their list of taxable items to Floyd County's tax commissioner).
- The 1850 census cites William as a farmer but no record shows his purchase of land in Floyd. That enumeration places him adjacent to the young constable Samuel D. Light. As shown in this report, in February 1849, Light acquired more land than he could farm—suggesting strongly that William was leasing Light's land. Why William chose that site remains unexplained. The only hints of a possible connection I have found to date are these:
 - Young Light's wife, née Margaret Smith, was the daughter of one John Smith of Franklin whom I have not yet identified or pursued.
 - Peter Guerrant Sr., one of Franklin County's prominent early settlers and a land speculator, owned Floyd County land adjacent to William's 1850 neighbors. No connection has been found in Franklin County between Guerrant and William Mills-Whitt; however, Guerrant might well have advertised, in Franklin, the availability of land for rent in Floyd.
- William's other adjacent neighbor on the 1850 census, Henry Iddings Jr., was a well-established landowner and keeper of a "house of private entertainment," whose father Henry Sr. had subdivided his land among his children throughout the 1830s and 1840s. It was a tightly-knit neighborhood (and one in which Samuel D. Light was an in-law). In 1848, Henry Jr. was the only Iddings who apparently had sufficient land to need a renter or tenant farmer; in fact, he expanded his holdings by 200 acres early that year.
- The Samuel D. Light and Henry Iddings lands lay between Big Run and Pine Creek, two parallel streams that branch off Little River a short distance apart. Little River's head in Montgomery County (as a branch of New River) was the site of the Whitt settlement at the time William Mills was born.
- The Light-Iddings neighborhood, between Big Run and Pine Creek, appears to have centered near
 the headwaters of those streams, near the community called "Simpsons." Neighbors cited in the
 Light and Iddings deeds do not place them along Little River itself.
- Little River, nonetheless, seems to play a significant role in the trajectory of William Mills's life. As
 indicated by Map 1, below, the Blackwater River of Franklin, on which William spent most of his
 adult life, was a geophysical extension of Floyd County's Little River, broken by a mountain range

through which a gap existed (Dog Spur Gap, at roughly the site of modern Pine Spur Overlook) for travel between the two counties.

- William's first record in Franklin (the 1806 tax roll) places him, roughly, below that gap in the region
 of the McCarrell-Menafee-Ferguson clan, the intermarried Mullinses and Stanleys (who lived in both
 Franklin and Montgomery Counties), and the Napiers whose siblings also settled in Montgomery
 County at the other end of Little River on the waters of New River (where they were in-laws and
 close associates of Sarah Mills, one of the two candidates for William Mills-Whitt's mother).¹³
- William and Drucilla, in their sixties, left her inherited land in the possession of their newly married son William B. and moved up the Blackwater through the gap into Floyd County (old Montgomery). After two years in the Simpson's community of the Iddings and Lights, they moved again and would spend the rest of their lives in the region where Little River flows into New River. Coincidentally or not, that was the community settled in the 1770s by the Rev. Richard Whitt who willed his land in 1813 to his son Archibald. At the time of William and Drucilla's arrival there c1853, those lands were occupied by two sons of Archibald and wife Hannah Lowe: Hezekiah and Abijah Whitt who (according to the 1850 census) were born c1795–96 and c1800-01.



RESEARCH NOTES

1831 FLOYD COUNTY, VA

Floyd County was cut from Montgomery County in this year.

COMMENT:

William & Drucilla Mills remained in Franklin County until 1848, on the land they had inherited from her father. Their residences, thereafter, tie them to the counties of Floyd (1849-52) Montgomery (1853), Pulaski (1860), and again Montgomery (1867, Drucilla's death).

Pulaski County was cut in 1839 from Montgomery and Wythe. Wythe itself was cut from Montgomery in 1790.

5 APRIL 1834 FLOYD COUNTY, VA

Mortgage

Henry Iddings (s) and wife Abigal (x) of Floyd County to John R. Guerrant of Franklin County, sale for \$150 cash in hand, 113 acres on Piney fork of Beaver dam, waters of Little River, a branch of New River. On condition that "the said Henry Iddings obliges himself to pay the said Jno. R. Guerrant [\$150] back with interest if the title should not be a good one." [Metes and bounds not copied here.] Adjacent landowners: Bird Cole, Terry, Hornburger, Peter Wilson. Acknowledged 5 April 1834 before Peter Guerrant Jr. and Leonard Aldridge, JPs. Reviewed by the clerk and admitted to record, 19 April 1842.¹⁴

15 DECEMBER 1834 FLOYD COUNTY, VA

Bond

John Light, with **Andrew Conner** and **Jacob Hoback** as sureties, posts bond for \$2,000 as constable for Floyd Co.¹⁵

COMMENT:

John Light m. Polley Conner in March 1832, Floyd County. Her parents are not identified in that record. In 1816, in Montgomery Co., William Mills witnessed a land lease between John Conner and landowner John Toney (son of William Toney of Franklin County). In County (son of William Toney of Franklin County).

20 MAY 1836 FLOYD COUNTY, VA

Deed of trust

Elijah Light of the 1st part, Charles B. Reynolds of the 2nd part, and John P. Guerrant of the 3d part. Whereas Elijah Light is indebted to Guerrant for \$130 due 1 May 1837 by a bond of this day, Light secures the bond with this trust deed to

all that tract or parcel of land lying and being in the County of Floyd in the State of Virginia containing [137] acres, ... being the whole tract of land whereon the said Elijah Light now resides, with all appurtenances. [No waterway or neighbors named.]

If the debt is paid on time, then this trust deed is null and void, etc. All three parties signed. Witnesses: Peter Guerrant Jr., Preston Thompson (x), Wm. Simpson. Acknowledged in court, August 1838.¹⁸

13 APRIL 1837 FLOYD COUNTY, VA

Land sale

John Light to Thomas Helms, sale of land in Floyd County "on the waters of Little River, it being my entire wright and interest as Legatee of **Henry Light** Decd., being the tract that the said Henry Light formerly lived on and adjoining the said **Thomas Huling, Isaac Booth Sr.**, and others, together with all

appurtenances. Witnesses: Henry Shockey, Peter Guerrand Jr., William Webb, Thomas H. Slager?, Jacob **Walters**. Admitted to record, Floyd Co. Clerk's Office 27 May 1837.¹⁹

COMMENT:

See 19 April 1841, below, for sale by Henry, Samuel, and Lorenzo D. Light to Thomas Helm. It is likely (but should be verified) that all four were sons of "Henry Light Dec'd."

8 NOVEMBER 1837 FLOYD COUNTY, VA

Deed of trust

Lydia W. Iddings to Benjamin Howell of the 2d part and McCabe & Headin and Dickins and Thomas of the 3d part. Iddings is indebted to McCabe Headen & Co. for \$42.59 by bond bearing this date, also to the same for \$6 by bond bearing this date, also to the same for \$5 by bond bearing this date, and to Dickins & Thomas for \$19.09 by bond of this date. Therefore, for \$1, she gives a trust deed on 50 acres described as

Beginning at 2 chesnuts, thence N38 W28 poles to a gum, N22 E110 po to a cucumber on the **old line**, E57 po to a poplar & hickory, S30 W 39 po to a poplar, S10 E106 po to a chesnut, S70 W13 po to a white oak, N75 W67 po to the first station;

Also one feather bed, bedstead & bedding, 1 side saddle, 1 Cow & increase, 8 head of hogs & increase, 1 Bureau.

If debt is paid by 1 November 1838, this trust deed will become null and void. Otherwise, Howell is to sell the property at highest bidder to pay the debt. All 4 parties signed. Acknowledged in court 8 November 1837.

"Received in full my interest in the trust deed from Lydia Iding. [Signed] H. Dickins June 22 1847; Thos McCabe for McCabe Headen & Co. Delivered to McCabe June 1847."²⁰

COMMENT:

A major financial collapse occurred worldwide in the spring of this year 1837, plunging many families into debt. Mortgages (aka deeds of trust) would be common through the early 1840s.

4 JANUARY 1838 FLOYD COUNTY, VA

Land purchase

Michael Sowder and wife Ann, administrators of Jacob Sowder Decd., of Franklin County, to **Henry Iddings** of Floyd County, sale of "land lying and being in the County of Floyd Known by the name of the **Mackaronie Tract**," containing 10 acres described as

Beginning at a large chesnut and red oak by a small branch, corner to the land of **Mark Lykins** and thence with the line thereof S73 W12 poles to a chesnut on a line of **Humphrey Smith**'s land and with it leaving Lykins N43 W74 poles to two chesnut oaks and chestnut, N20 E5 poles to a four-pronged maple in a line of said **Lykins old survey**, and with it S82 E46 poles to two chesnuts and white oak, thence S13 E52 poles to the beginning.

Signed: Ann Sowder her X mark [a blank spot is left where Michael's signature should be]. Witnesses: Jabez Smith, Charles Vest (his X mark), Richard Sumpter. Proved in Floyd's June court session 1839.²¹

COMMENT:

Henry Iddings [Jr.] and Charles Vest were in the household adjacent to William Mills in 1850. Note, below, that Iddings (after buying the above tract) proceeded to divide his original patent between his children before the end of the year, suggesting that he may have remained on this "Mackaronie Tract."

Andrew Idings on 23 Oct 1847 gave a deed of trust to James Light and William Snuffer, trustee. James Light served as surety for the bond of Andrew Light's wife as administratrix of the estate of **Jabez H. Smith**, decd., her prior husband. The consideration to be held in trust was a tract of land that was part of [H]Umphrey Smith's old tract, bounded by **Henry Idings**, Bolin Childress, and others.²²

Witnesses: Isaac Booth, Isaac Moore, Jno. Howard. Proved in November Court 1838.²³

COMMENT:

- The 1790 tax roll of Montgomery County shows Abijah Booth Sr. submitting his tax list on the same day as **Militin Atkins**, apparently in the lower part of the county that lay between Walker's Creek and New River.
- In 1789, this Militin Atkins was the surety on the unexecuted marriage bond for Frances "Frankey" White and John Abram Glymph of Montgomery's Doe Creek (which lay across New River from Walker's Creek, a short distance upriver from the point where Little River enters New River). Male-line descendants of Frankey's son Samuel Mills, who was born about the time of this intended marriage, carry the Y-DNA signature of the Atkins family, with matches to descendants of the Booker Mullins to whom William Mills-Whitt is connected by 1806 tax roll data in Franklin.²⁴
- See Map 4 for location of Boothe Creek. Going east on Little River, from New River, the next major waterway past Boothe Creek is Big Run, site of Henry Iddings (& William Mills 1850).

Henry Iddings (x) and Abigail Idding [sic] (x) to Thomas Iddings all of Floyd County. Henry and Abigail "for the true regard to their friend Thomas Iddings makes a friendly gift" of land "on the waters of Little River" containing [100] acres by survey bearing same date, bounded as follows:

Beginning at a white oak near a branch the begin[nin]g corner to the above named tract of 220 acres, thence with a line S57 W32 poles crossing s^d branch to a chesnut saplin & five dogwoods on a hill side, thence **new lines** S30 poles to two chesnut sprouts, from one stump S79 E38 poles to a white oak stump near a branch S3 E82 poles down on the W side of sd branch to red & chesnut saplin, S83 W21 poles to a hickory grub and a double chesnut stump near the top of a **ridge** by addition of ten acres S14 E21 poles to two red oak sapling and a black oak on the top of a ridge, S67 W 30 poles to a large chesnut, S9½ E100 poles to three red oak saplins on flat ridge, N78 E150 poles crossing the **Old House branch** to a red oak sapling on the patten [patent] line, thence with the same N25 W33 poles to a chesnut corner thereof, N70 W20 poles to a double chesnut by a road, N23 W52 poles to a chesnut and chesnut oak, N76 W60 poles to a white oak & chesnut corner to patten [patent] of 220 acres, and with last line this of N12 W140 poles to the beginning.

Acknowledgment 20 October 1838 before Peter Guerrant Jr. & Leonard Aldridge, Justices of the peace. "Delivered Dec 1852." ²⁵

COMMENT:

With regard to the first reference to "sd branch," there was no prior reference identifying any branch, only a statement that the land lay on *waters* of New River.

Beginning at a black oak & spanish oak near the top of a **ridge** corner to tract of land of for [*sic*] **Wm Iddings**, with his line S74 W40 poles to a large chesnut & white oak saplin on a **ridge**, N80 W28 poles to a white oak, S64 W48 poles to a chesnut and white oak, by thence leaving same line N38 W21 poles to a double chesnut on a **ridge**, N82 W49 poles to two chesnut oaks & a white oak on a **ridge**, N21 W36 poles to two chesnuts and three red oak saplins on a **division line** run between **Henry Idings** & Guerrant, with the same line N53 E132 poles crossing a branch to a red oak saplin and white oak on a hill side, S56 E16 poles to two white oaks & a gum, S26 E24 poles to a branch, thence down the meanders of the same & binding thereon 45 poles to **Likins branch**, thence down the s^d branch as meanders 50 poles to a white oak & locus, thence S41½ W37 to the beginning.

Acknowledged 19 October 1838 by Henry and Abigail before Leonard Aldridge and Peter Guerrant Jr., Justices of the peace. Proved November Court 1838.²⁶

COMMENT:

The Iddings are dividing land between their children. Charles Vest wed Martha Iddings in 1831.²⁷

Metes & bounds [not copied] refer to "a flat ridge corner to a lot of land laid off to Sam! Vest, small branch. Also an adjoining tract "on the NW side of the aforesaid," containing 80 acres surveyed and 20 acres yet to be surveyed ... containing in all 100 acres. Signed J C Walters; Hannah Walters C her mark [that mark could also be read as a G or an unclosed O]. Acknowledged 20 October 1838 before Peter Guerrant Jr. and Leonard Aldridge, Justices of the Peace. Proved November Court 1838.²⁸

COMMENT:

Jacob Walters married Hannah Iddings, 19 July 1822, in Montgomery County.²⁹

COMMENT:

Bird Smith married Lydia Idings, daughter of Henry.³¹ I have not been able to locate Old House Run.

Henry Iddings (x) and Abigail his wife to David Hall, all of Floyd County. The Iddings "for their regard and friendship to their son in law David Hall make a friendly gift" of 100 acres, being part of a 400-acre survey patented to the said Henry Iddings. [Metes and bounds not copied]. Bounding James Simpson and Walters. Also another small piece "laying on the branch and on the north side of the above-named survey, which is marked off without coursing, supposed to be five acres." Acknowledged 22 December 1838 by Henry (but not Abigail) before James H. Gray and Peter Guerrant Jr., JPs. Admitted to record, 26 March 1839.³²

Beginning at two white oaks near a branch, corner to the said patent? land, and also corner to the land of **James Simpson**, thence with a line thereof N70 E220 poles to a large chesnut in **Walters line**, thence with it leaving Simpson's line N47 W66 poles to a white oak, N65 W60 poles to a chesnut oak, thence runs the **Division line** S56 W150 poles, crossing a branch to a white oak on a SW hill side in the patent line, thence with the same S23 E20 poles to a white oak on a hill side corner thereof, thence S45 E35 poles to the beginning.

Acknowledged 7 September 1839 before Leonard Aldridge and Peter Guerrant Jr., JPs. Admitted to record 30 September 1839.³³

Witnesses: Bird Smith, J. C. Watters, Jonathan Iddings. Proved February 1843 by oaths of witnesses.³⁴

William Mills, 1 white male 16+, 0 slaves, 0 horse, 0 tax

COMMENT:

William Mills-Whitt appeared this year on the personal tax roll of Franklin. His son William B. Mills, born about 1820, as the third son of William and Drucilla was not yet 21 and not yet liable for poll tax. The above William is clearly a different man.

This William of 1840 Floyd is not taxed in 1841, but would appear sporadically in tax and court records, sometimes in association with a Larkin and Anderson Mills.

Meanwhile, one William Mills (parentage unproved) appeared in Franklin County 1833–37, where he was called "William Mills Jr." to distinguish him from William Mills Sr. of Elliott's Creek of the Magotty. He was married in that period to Mary "Polly" Shewalter/Showalter of Elliott's Creek. In 1837, he and Polly (along with Polly's apparent mother Sally Shewalter) sold their Elliott Creek land and dropped from Franklin's records. That William's location was in close proximity to one Nancy Mills (widow of James Jr., who was the brother of William Sr.) and the same area as Anderson and Larkin Mills who weave in and out of the tax rolls of both Franklin and Floyd County in this period.

[Metes & bounds here, not copied.] Adjacent to **William Conner**. Also one other adjacent tract containing 70 acres, adjoining **John B. Conner**. Witnesses: **James H. Gray, Randal Wilson**. Acknowledged 4 September 1841 before Leonard Aldredge and Lewis Payne. Received in October court and ordered to be recorded.³⁵

COMMENT:

In 1850, Nathan Conner (36), Daniel P. Conner (22), and William Connor (age 60) were adjacent neighbors. William Conner m. Catherine Poff 7 May 1811 and Polly Poff, 1822, in Montgomery.³⁶

Meadow Run of Little River was a bit west of Dog Spur Gap through the mountain that divided Floyd from Franklin. Dog Spur Gap (Pine Spur Overlook) was a bit N of the end of Franklin County's Daniel's Run, just west of Jacob Prillaman's land, to the WSW of Callaway in Franklin County. (On the map below, from Simpsons to Check is roughly two miles by the road that runs above them.)

Acknowledged before Leonard Aldridge and Lewis Payne, JPs, 28 September 1840. Received by court clerk **M. Sandifer**, 29 April 1842, and ordered to be recorded.³⁹

19 APRIL 1841 FLOYD COUNTY, VA

Henry Light (s), Samuel Light (s), and Lorenzo D. Light (s) sell to Thomas Helms for \$90 a tract of land in Floyd County "on the waters of Little River adjoining Thomas Helms and others known by the name of Henry Lights old place, containing" 400 acres more or less. No witnesses. April Court 1841 deed "was acknowledged in Court" [doesn't say by whom, and ordered to be recorded.

Whereas Vest is indebted to Deskinis & Thomas for \$13.50 dated this day and payable on demand, also to Harvey Deskinis for \$26.30 dated this day and payable on demand, he secures his debt with a deed to **Jackson Godbey trustee**, for personal property identified as "2 cows, 2 beds and furniture, 2 Axes, 1 Scythe & Crowdel?, 1 mowing sythe, 2 chests, 2 pots, 1 oven, 2 skilets, 1 bay horse & calf, one drape, ½ doz chairs, and all the household & kitchen furniture on hand, saw, drawing knife, 1 set of tools, and their increase." Signed: Roland Vest, Deskinis & Thomas, H. Deskinis, Jackson Godbey. Acknowledged in the county court and admitted to record on 28 February 1842.⁴⁴

COMMENT:

Online trees identify Godbey (without evidence) as son of George & Nancy (Elswick) Godbey of Montgomery—and the nephew of Francis Godbey who married **Rhoda Whitt**, daughter of **Archibald Whitt** and granddaughter of Rev. Richard Whitt of Montgomery. After William and Drucilla Mills, the 1850 neighbor of Henry Iddings, left Floyd Co., their traceable action place them amid Archibald Whitt's offspring at the intersection of New River and Little River.

Iddings patent line, a corner of **Bird Smith's** land and running thence N87 W20 poles to a red oak, corner of the said patent line, thence with said line S71 W, crossing the Creek 42 p[oles] to four white oaks, corner of the same, thence leaving said patent line S80 W30p crossing a branch to a dead white oak and chesnut oak, corner of William Iddings' **new survey**, thence with a line of the same S57 W28½ up sd. branch to a cherry tree planted in place of a white oak cut down corner of the survey, thence with sd line S21½ W49 poles crossing a small branch to a chesnut oak beginning of sd new survey.

Also a corner of an [80] acres survey made for **Jacob Walters**, thence with a line of sd. 80 acre survey N89 W39p to two white oak saplings, corner of the same, thence with a line of the same N20 W24p to maple pointers in a branch, thence with the same 40p crossing two roads to a small black oak corner of the same, thence on leaving sd. line nearly N 40p crossing a road to a small white oak near sd road, thence nearly E 40p to a chesnut and white oak by a path, corner of **Charles Vests** land, thence with a line of the same N64 E48p to a white oak, corner of the same, thence with the same S80 E28p to a large chesnut and white oak sapling, corner of the same, thence with the same 45 poles crossing the creek to a white oak near sd creek, corner of the same, also a corner of **Jonathan Iddings** land, thence with Jonathan Iddings line 66 poles to four chesnuts from one root corner of the same, also corner of **Bird Smith**'s land, thence with Bird Smith 46 poles to the beginning.



Run, waters of the South fork of Roan Oak [Roanoke], being the same land the abovenamed Guerrant purchased of Jacob Prilaman," 152 acres. [Metes and bounds not copied.] Acknowledged by Guerrant in the Clerk's office, 19 September 1842 and admitted to record.⁴⁸

Peter Guerrant Jr. (s) to Jacob Conner, both of Floyd County, for \$250 cash in hand, sale of land in Floyd "laying on the West side of the Bent Road and the part of the land purchased of Johnathan Reed and bounded on the East by said Bent Road, on the North by Richard Rudaker's land, on the West by

9 DECEMBER 1842 FLOYD COUNTY, VA

Association

"General Briggs Lawrence" (s/ Ginnerl Griggs Lawrence) of Floyd Co. to **John Lawrence** of Montgomery Co., sale for \$250 cash in hand, 87 acres in Floyd Co. "on the top of the **Laurel Ridge**." Also his interest in a patent made to James P. & Briggs Lawrence for 125 acres dated 31 August 1840. The 87 acres start "at the first corner of the patent where it calls for three chesnuts and a double chestnut." [Rest of m & b not copied; no adjacent owners named.] Acknowledged in the clerk's office 9 December 1842.⁵⁰

15 FEBRUARY 1843 FLOYD COUNTY, VA

Association

"William Simpson (s) and Catharine Douglass (s) to Hiram Walters, all of Floyd County, sale for \$45, 18 3/8 acres of land lying on Pine Run, waters of Little River, adjoining the lands of old William Walters and said Simpson [metes & bounds not copied]. Witnesses: Bird Smith, James Light, Jonathan Iddings. Proved in court February term 1843 "by the oaths of the witnesses." 51

COMMENT:

In 1850, Hiram Walters was living with "old" William Walters, 9 dwellings from William and Drucilla Mills.

HomeTownLocator does not show a "Pine Run" off Little River. It does show a "Pine Branch" a bit SSE of Simpsons, VA, running NE off Little River where it abuts Hwy 221 (aka Floyd Hwy). Map 4 places "Pine Branch" just East of Big Run. Both came within a half-mile or so of the Simpsons community.

AUGUST 1843 FLOYD COUNTY, VA

Court order

"Ordered that Fleming Poff be and he is hereby appointed Surveyor of the Road in Precint No. 62 in place of **William R. Conner**, resigned, and that the hands assigned to the said Conner constitute his gang, and that they keep the said road in repair according to the law.⁵²

COMMENT:

I have begun my reading of court orders at this point—the start of volume 2—roughly five years before William Mills-Whitt arrived in the county. I am reading line by line; but I am not taking notes on deeds presented to court because I have already read the deed books, page by page. Ditto for performance bonds filed by incoming sheriffs, justices of the peace, and constables.

The only notes I am taking are those that have a potential significance to William Mills and family or to the locations of individuals with whom he associated.

3 AUGUST 1843 FLOYD COUNTY, VA

Affidavit

"I, **Henry Iddings** [Sr.] (x) do hereby certify that I was at Floyd Court house some time in the course of the last year when James Litteral and Henry F. Callaway were in conversation about the **Meadows run** land, when James Litteral loudly proclaimed that he put no claim to the land which he purchased of the heirs of **Zachariah Stanley** which is covered by the survey of **Daniel Conner** and the Said Litteral further Said that if said Calaway brought suit he might pay the Costs himself." Sworn 3 August 1843 before Peter Guerrant and James H. Gray, JPs.

"To all whom it may concern, know ye that I **Henry Iddings** (x) do certify that some time in the year **1780** a certain **Zachariah Stanly** with **Humphrey Smith**, a deputy Surveyor for the County of Botetourt, called upon me and **my cousin David Iddings** to carry the chain in a Survey they were then about to make on **Meadow Run**, beginning on the lines of **Nicholas Allay**, thence up Meadow run some distance, when **David Idding** told the Said Stanly and the Said Smith that they were crossing on the land of **Daniel Connor** & notwithstanding they continued on & completed the survey." Sworn 3 August 1843 before Peter Guerrant and James H. Gray, JPs. Presented in Floyd's October Court 1843.⁵³

5 AUGUST 1843 FLOYD COUNTY, VA

Deed of trust

Thomas Iddings (x) to Peter Guerrant Jr. (s), Charles B. Reynolds, and Henry Iddings (x) of the second part, both of Floyd Co. Whereas Thomas Iddings is justly indebted to Guerrant for \$32.70 with legal interest from 12 April 1839 "which is more fully set forth by a bond to that effect, also unto Charles N. Reynolds [for] \$26.00 and "perhaps a few cents" with legal interest from 5th day of November 1842, "which is more fully set forth by a bond to that effect," also unto Henry Iddings for \$80 with legal interest from 5 August 1843, "which is more fully set forth by a bond to that affect," therefore Thomas Iddings conveys to Bird Smith for \$1 a tract of land in Floyd County "on the Waters of Old House Run, waters of Little River, said to contain" 126 acres "being the place where I now live on, and all its appurtenances, also one Sorrel mare, seven head of cattle, eight head of hogs, all my household and Kitchen furniture of every description, also all farming utensils." Condition: if Thomas Iddings defaults on his debt "(but not until the 5th day of August one thousand eight hundred and forty seven)" then Smith may sell the land to cover those debts. Witness: Samuel Vest. Acknowledged by Thomas Iddings and admitted to record, in the office of the clerk, 7 August 1843.⁵⁴

19 AUGUST 1843 FLOYD COUNTY, VA

Henry Iddings (x) and Abbigail his wife (s) to Jonathan Iddings "for the true Regard for their Friend and son Jonathan Iddings" and for \$1 convey a tract of land lying in Floyd County on Lykens Branch, 100 acres, "being part of a survey surveyed by the said Henry Iddings, a fore hunned Acres survey, and a part of a survey surveyed by the said Iddings of About two hundred and twenty Acres" on Lykins Branch, corner to a lot laid off for Charles Vest" ... Witness: Bird Smith. Acknowledged in August Court by Henry Iddings. "Delivered to Burd Smith May 1853." ⁵⁵

- I have not yet located Lykens Branch.

Land purchase

J. N. Zentmayer, Deputy Clerk, County court of Floyd, to **John Lawrence** of Montgomery Co. Whereas on 19 October 1840, P. Howell, deputy sheriff for P. Guerrant Jr., Sheriff of Floyd, sold for taxes a tract of land under an act of 27 February 1835 for "nonpayment of taxes west of the Aleghany Mountain," and **John Lawrence** became the purchaser of 90 acres returned delinquent in the name of James Bowman, for the nonpayment of taxes due thereon "for the year 1832 & 37" [& 33?] lying on the waters of **Big Run**, a branch of the South fork of Roanoke [metes and bounds not copied]. Zentmayer conveys title to Lawrence "but ... only such estate in the said tract of land as was vested in the said James Bowman. Admitted to record 30 November 1843.⁵⁷

COMMENT:

Big Run was also the site of the land of Henry Iddings, who appears next door to William Mills on the 1850 census. On 27 July 1854, Mills's daughter Milly married John *B*. Lawrence, son of William and Agnes Lawrence. ⁵⁸ I have not yet determined the relationship between William and the above John Lawrence.

Booth Napier (s) to Elizabeth J. Burd, both of Floyd, "in consideration of the natural love and affection which he has and bears for his daughter, the said Elizabeth," and for \$1, conveys to her land on **Laurel Creek, waters of Little River ...** crossing a creek to two pines on a knole, near a corner of **Abijah Booth**'s Laurel Creek Survey, [etc.] also two horses, one cow, 3 feather beds, one pot, one oven and two skillets,

8 chairs, 3 tables, 4 head of Sheep, two trunks, one chest, 1 Iron tramal, 1 cupboard & contents & Sundry wooden vessels. Acknowledged by Napier and admitted to court, 3 January 1844.⁶⁰

COMMENT:

Laurel Creek is a branch of the West Fork of Little River, about halfway between Big Run and New River.

"Booth Napier" married Catherine Bird, 14 February 1832.⁶¹ Online trees place the birth of "Booth Wooten Napier" birth in 1790, place him in **Franklin Co.** in 1820, and identify him as the son of "Robert Booth Napier" and Elizabeth "Betsy" Champion. They also assert that his daughter [step-daughter?] Elizabeth m. 16 November 1848, Floyd County, John Jessee, and lived 1880 on **Walkers Creek in Giles Co.**⁶²

FamilySearch FamilyTree shows Robert Booth Napier G9M6-NSF (husband of Elizabeth Champion) dying in Franklin County in 1805. He is said to be the son of Robert Napier Jr and Mary Tarleton *Hughes,* and a **brother of Patrick Napier** Sr. (1713–1774), Ashford Napier (1734-1801), and Thomas Hughes Napier (1736-1804, Montgomery).

At *FamilySearch FamilyTree*, Patrick Napier Sr. (1713-1774), is said to be the father of Thomas Hughes Napier KNNR-B2C of Montgomery County and Patrick Napier (1744–1808) of Fluvanna.

"Patrick Napier Jr." married in Montgomery, June 1788, Fanny Brumfield,⁶³ sister of Humphrey Brumfield who married Sally Sartin.⁶⁴ Sally's brother Elijah in 1791 married Sarah Mills,⁶⁵ daughter of Jesse Mills and Lucy Tilman Hix. Sally is one of two candidates I have targeted for the mother of the William Mills who married Drucilla Kemp.

Henry Iddings (x) has "this day given and bequeathed and bestowed unto **Samuel Vest**" for \$1 and in consideration of the love I bear toward said Sml. Vest" a tract of land "supposed to contain" 300 acres.

Beginning at a white oak and red oak on the N side of a ridge, corner to Collins' land, also a corner to a entry survey made for Hall with a line of the latter S79½ E73p to a chesnut, N53¼

E42p to a chestnut oak & two red oak saplings on a flat ridge, N49 W98p to 4 chestnut oaks & red oak corner to B. Newman's land, thence with his line rather NE to a road leading from said Newman's to Jacob Walters, thence up the road to a division line made between Guerrant and **Iddings**, thence with the line SW to a corner marked by **Iddings** for said **Vest**, thence nearly S to 2 red oaks & 2 white oak on the line of the Widow Scotts land near Mill Creek with a line S6% W93p down sd creek to a stump on a large rock corner to the lott laid off by Bird Smith with a line S77½ E152p to a large & small chestnut and gum sapling and line begun on and with it at 18¾ E66p to the beginning.

"And I Charles Hall (s) do bind myself my heirs to warrant and defend 70 acres of the above named land on the NE side of it to him the said S. Vest. Witnesses: Bird Smith; Charles (his X mark) Vest, Jonathan Iddings. Proved 3d Monday in February 1844 in court, by oath of witnesses. Marginal note: "Delivered May 1847 to J. Godbey."⁶⁷

COMMENT:

- This tract and its neighbors seems to be the locus of the landless William Mills in 1850.
- Bird Smith was Iddings' son-in-law.
- "J. Godbey" should be the surveyor Jackson Godbey, a kinsman of the Whitt family of Montgomery.
- The USGS National map places one Mill Creek as a branch of Meadow Creek, just E of Radford. This was the site settled by Rev. Richard Whitt and his son Abijah—and the general locale of William Mills's residence between 1853 and 1860. However, that Mill Creek is clearly not the one above that lies adjacent to Iddings' land. Neither USGS's National Map nor HomeTownLocator identifies a Mill Creek in Iddings' neighborhood.
- See 30 June 1845 for a document relating to Mill Creek of Beaverdam Creek of Little River. Beaverdam is the next creek up from Big Run, when going NE on Little River. Beaverdam and Big Run roughly parallel each other for several miles. Iddings land apparently lay between them.

(Jonas?) Likins & designated by a marked line between the said Lykins and the aforesaid Iddings ... supposed to contain forty acres ... more or less, together with all and

singular the appurtenances thereto belonging." Acknowledged before Peter Guerrant and James H. Gray, JPs, 20 March 1844. Received and admitted to record, 18 May 1844.⁶⁸

COMMENT:

This appears to refer to an earlier location of Iddings, in his first years in Montgomery County. Neither USGS's National Map nor HomeTownLocator identifies a Pilot Run. HomeTownLocator places Pilot Mountain several miles north of Beaverdam Creek and even more distant from Big Run and Pine Branch.

James Light served as surety for the bond of Andrew Light's wife as administratrix of the estate of **Jabez H. Smith**, decd., her prior husband. The consideration to be held in trust was a tract of land that was part of [H]**Umphrey Smith'**s old tract, bounded by **Henry Idings**, Bolin Childress, and others. ⁸⁰

I have not yet located a waterway known as "Smith's Branch."

COMMENT:

This William appears *not* to be William Mills-Whitt of Franklin for two reasons:

- William Mills-Whitt paid his tax in Franklin in 1846.
- William Mills-Whitt would have been been in his 60s by this time. In this era, brawling is morecommonly seen among males in their 20s to 40s. Anderson Mills fits that profile. William Mills-Whitt does not.

This William appears to be the William who submitted his list of taxable items in 1844 on same day as And^w Mills of the Maggoty Creek, Franklin County, Millses.

"Ordered that process issue against **Anderson Mills** who stands indicted of a breach of the peace, to cause him to appear here on the first day of the next quarterly term to answer the said indictment.

"Ordered that process issue against **William Mills** who stands indicted of a breath of the peace, to cause him to appear here on the first day of the next quarterly term to answer the said indictment.

[2 additional orders against Anderson]

"Ordered that process issue against **Simeon Light** who stands indicted of a breach of the peace, to cause him to appear on the first day of the next quarterly term to answer the said indictment."

[A second order against William Mills and similar orders against the others on the indictment list.]⁸⁶

William Mills-Whitt and son William B. Mills are still taxed in Franklin.

COMMENT:

William Mills (Mills-Whitt), husband of Drucilla Kemp, is dropped from Franklin's personal tax roll this year. However, this William of 1847 Floyd does not seem to be Drucilla's husband. A comparable William was taxed in Floyd in 1846, while Drucilla's William was on Franklin's personal and land tax rolls. Franklin County land rolls do not identify our William Mills as a Floyd resident until 1849.

The 1846–49 tax lists of Floyd provide these couplings:

- 1846, William turned in his list on the same day as Larkin Mills.
- 1847, William turned in his list on the same day as Anderson Mills.
- 1848, William, Anderson, and Larkin all turned their lists in the same day.
- 1849, William Mills (the only one in Floyd) is listed consecutively with Anderson Mills, but did not turn in his list on the same day. Instead, he turned in his list on the same day as (a) William and Drucilla's known son Sparrel; and (b) Samuel D. Light, who would be enumerated next door to William and Drucilla on the 1850 census. 1849 clearly marks the first taxation of William Mills-Whitt in Floyd County.

The South Fork, approximately 20 miles long, rises in several streams in the mountains on the border of Floyd, Roanoke, and Montgomery counties and flows generally north, joining the North Fork from the south." 94

- In 1842, Samuel D. Light m. "Peggy Smith, d/o John." ¹¹¹ The 1850 census states that she was a native of Franklin County."

TO DO:

- Check deed index for Beedle's acquisition of the land.
- Read land tax rolls for 1840–43 to determine the description of the property.
- Study John Smith of Franklin.

"On the petition of **John Wimmer** who produced the sheriff's receipt for \$13.36 cents the tax imposed by law, and entered into bond with Pleasant Howell his security in the penalty of \$150, conditioned as the law directs, a license is granted him to **keep an ordinary at his residence** in the County of Floyd, until the next May Term of this Court. The court being satisfied that the said John Wimmer is a man of good character not addicted to drunkenness or gaming."

COMMENT:

There obviously is a significant difference between "a house of private entertainment" (as conducted by Henry Iddings) and an ordinary (as licensed to Wimmer), considering the tax difference of \$3.00 vs. \$13.36 and the fact that the ordinary license also required a bond. Likely, the "house of entertainment" (a billiard hall, perhaps) did not include the privilege of selling alcohol.

NOVEMBER 1848

"Ordered that the overseers of the poor for this County or any one of them do bind out according to law to George Redinger (farmer) **Silvester Mills** until he attain the age of twenty one years." ¹¹⁵

- William Key, future husband of William and Drucilla's daughter Sarah, was enumerated in 1850 with George W. Key.
- I have not located "Bones Branch" on any contemporary map.
- The "waters of Beaver dam Creek" location—if on the west side of Beaverdam—would place the Keys within five or so miles of William and Drucilla.

"William G. Peck, Surviving partner of Peck & Micou vs. **Philip A. Webb.** Debt. "The Defendant being arrested and in custody of the sheriff for want of bail acknowledges the plaintiffs action for the debt." \$3,043, plus interest from 19 June 1846 until paid, plus costs. However, the plaintiff was not a resident of the county and was not present in court. Therefore the defendant was discharged. 118

Muncy on charge of felony, and shall not depart thems[elves] without leave of said Court, then this recognizance is to be void." 126

COMMENT:

A court order on the preceding page states that Muncy was "charged with passing to John Gearhart of this County on the 26th day of June 1849, a false forged and counterfeited bank note purporting to be a bank note of the denomination of ten dollars."

COMMENT:

- One major question remains unanswered: Why did William, who owned land in Franklin County, leave Franklin and move across the mountain into Floyd County, where he did not buy land? Given that the 1850 census cites him as a 62-year-old farmer with no property, he would seem to be a renter, a tenant farmer or a sharecropper. All three statuses were inferior to that of a man who farmed his own land.

COMMENT:

- I have not determined whether this John Smith is the same John Smith whose daughter Hannah (b. in Franklin Co.) married Samuel D. Light.
- I have not found a deed by which Anderson Mills acquired this land; I have not yet searched the state land office grants for him.
- The 1850 census places Anderson Mills some miles distant from William and Drucilla's location between Big Run and Beaverdam Creek of Little River.

On 24 January 1846, Right Booth sold 530 acres to Samuel Black, on Booth's Branch of Little River and Daniel's Run, adjacent to F. W. Lester and "Howery." On 12 September 1846, Black and wife Evaline sold the 520 acres, adjoining Howry, Martin Walters, to Thomas G. Shelor.

- Why and how did William choose this locale when he left Franklin? The Iddings were not particularly prosperous at this point. After the elder Henry divided his land among his sons and sons-in-law, none of them (with the possible exception of Henry Jr.) had so much land that they needed a tenant farmer or renter.

COMMENT:

Tucker could not agree on a verdict. Cause continued.

COMMENT:

Assumpsit was a breach of contract—i.e., a civil case. Therefore, William Mills did not have to be a freeholder to serve on the jury. For petit jury service the requirement was (a) be twenty-one years of age; and (b) own "property, real or personal, of the value of one hundred dollars." For grand jury service, the requirement was to be "a freeholder ... and in other respects qualified ... and not constables, ordinary keepers, surveyors of roads, nor owners nor occupiers of water grist mills; and when they are grand jurors for a county court, not inhabitants of a town having a corporation court." 185

In 1852–53, Virginia's code was revised to state more explicitly that the county courts, "at the April or May term ... prepare a list of such inhabitants of the county or corporation, not exempted as aforesaid, as they shall think well qualified to serve as jurors, *being persons of sound judgment* and free from legal exception." ¹⁸⁶

The population schedule of the 1850 census, taken a month before this jury service, credits William with no property. His non-appearance on the 1850 agricultural census of Floyd also suggests that he had no agricultural property or animals in the county and raised very little in the way of crops. From this, one might surmise that he did still retain ownership of his land in Franklin County, for which no deed of sale has been found. Indeed, Franklin County tax rolls of the 1850s continue to tax the land to William.

Note that the land lay adjacent to lands of Humphrey Smith (by then deceased), one heir of whom (see 4 January 1838, above) was Jabez Smith. That 1838 document also identified the land as adjacent to Henry Iddings.

This day came as well the attorney for the Commonwealth as the defendant by his attorney and the said defendant for plea sayeth that he is not guilty in manner and form as in the indictment against him is alleged and of this he puts himself upon the Country and the attorney for the Commonwealth doth the like and the cause is continued.

"Commonwealth vs. **Sparrel Mills** On an indictment for an assault. Ordered that a capias issue against the defendant to be directed to the sheriff of Montgomery."²¹²

COMMENT:

A *capias* was an order for arrest. The order was sent to Montgomery because Sparrel had already moved there. He was taxed in Montgomery in both 1852 and 1853.²¹³

"It appearing to the satisfaction of the Court that **Mary Iddings**, a daughter and devisee of **Henry Iddings** Decd is an idiot and altogether incapable of taking care of her estate, on the motion of **William Iddings**, he is appointed a committee to said Mary Iddings, whereupon the said William Iddings, together with **Samuel L. Vest** and **Bird Smith**, his securities, entered into and acknowledged a bond in the penalty of one thousand dollars, with condition according to law."²²¹

21 SEPTEMBER 1854 FLOYD COUNTY, VA

"Bird Smith reported verbally that he had opened the road from the crossing of Meadow Run to the location of the road from Shawsville to the Bent Mountain Turnpike at Wiliam Idding's meadow, which being received the court appoints William Iddings surveyor thereof.

Walters allot to William Iddings Surveyor of the road, his hands out of the Company of which Peter Conner was formerly surveyor, the remainder to be assigned to Robert W. Kropff. Ordered that Robert W. Koopff be appointed surveyor of the road from the turnpike at Peter Conner Shop to the Cross Road."²²²
