Dorothée Monet: French & Indian Freedwoman (27 September 1774–22 July 1820)

Research Notes

Dorothée Monet Family Summary:

Born: 27 September 1774, Red River plantation of Louis Mathias LeCourt de Presle, LeCourt's Bluff *aka* Les Écores, Post St. Jean Baptiste des Natchitoches, Louisiana¹

Daughter of: **Thérèse** (Canneci *aka* Lipan Apache; b. *c*1742) and **Louis Monet** (1753–1804; French Créole)²

- Relationships: Étienne Rachal (French Créole), son of Jacques Rachal and Marie Castel; ward of Louis Monet³
- Died: 22 July 1820, lower Rivière aux Cannes, Natchitoches Parish⁴

Children of Dorothée Monet, apparently all by the French-Creole Étienne Rachal:

 MARIE LOUISE ADELAÏDE "ADELE" DOROTHÉ, aka RACHAL, a twin, b. 5 February 1801 at Les Écores; d. after 1838.⁵ On 25 June 1820, she and her French-Créole double-cousin François Dorsino Rachal (b. June 1790 to Barthélemy Rachal *fils* Louis and Marie Françoise Laberry)⁶ presented for baptism an infant François Ursin Rachal, b. 6 October 1819. The child was said to be their "natural" son and Adele was deemed "a free woman of color."⁷ Her second child, a daughter Florentine, was

baptized as the "natural daughter of Adel Dorothé, father unknown."⁸ In 1838, she presented a daughter who was baptized as Marie Florentine Cide, "daughter of **Jean B^{te} Cide** and Adele Rachal, his wife"; that last record applied no color to Adele.⁹

- MARIE LOUISE ADALINE RACHAL, a twin, b. 5 February 1801 at Les Écores. As "Marie Louise Adeline," with no surname, she served 25 June 1820 as godmother to her twin's newborn son. On 5 October 1837, as "Adeline Rachal," she sponsored a child of her sister Marie Céline.¹⁰
- 3. LOUIS MONET [RACHAL?], b. 15 February 1803 at Les Écores; he died after September 1829 leaving several offspring by Oresille Jacques, whose parentage and ethnicity has not been determined. By 1836, Oresille had married José Marie Robles.¹¹ For Oresille: given that no Jacques family resided before then on Cane River, and given that all the children baptized on the same day were from Les Écores families, her origin might be sought on the plantation of the French-Canadian Jacques St. André, Louis' mother's neighbor and in-law.
- 4. MARIE THÉRÈSE ROSALIE RACHAL, b. 6 July 1805 at Les Écores and baptized as "Indian."¹² She has not been found past the settlement of her mother's succession in 1820.
- 5. MARIE CÉLINE RACHAL, b. c1807 at Les Écores and baptized 29 December 1809 as "daughter of Étiene Rachal and Dorothé Monet." Her godfather was the Jacques St. André discussed under her brother Louis, above.¹³ By 1838, Céline had married civilly her French Créole cousin Siméon Rachal, a widowed son of Louis Rachal and Marie Louise LeRoy.¹⁴
- 6. NARCISSE MONET aka RACHAL, b. c1810 at Les Écores, his baptismal and marriage records have not been found. He was named as Dorothée's youngest child in her succession. By 1837 he had settled into a civil union with a French-German Créole, Marie Marcelite "Nolite" Christy. In the baptisms of their children between 1840 and 1846, as well as the 1850 and 1860 censuses, the family used the surname Monet; in all these instances they were considered white. Their children, as they came to adulthood, switched to the surname Rachal,¹⁵ perhaps to avoid the "free person of color" label carried by all other Monets in the region.

Dorothée's maternal family:¹⁶

- 1. Susanne, b. 10 August 1770; no baptism, birthdate provided on 1778 inventory of her mistress.¹⁷
- 2. Dorothé Monet, b. 27 September 1774, died 21 July 1820, the subject of this paper.

- 3. Rosalie Rachal, b. 27 March 1776;¹⁸ married Louis Guillory of the Adaïs or Opelousas tribe.¹⁹
- 4. **Gaspard**, b. 6 January 1778²⁰; no further record.
- 5. Marie Célestine "Céleste" LeComte, baptized April 1781.²¹ In 1804 she emerged at Fausse Pointe (present Iberia Parish) as mother of a daughter Rose by the Irish immigrant, John O'Reilly. The baptismal record of the O'Reilly son Pierre in 1807 states that the mother "Céleste LeComte" was "of "Nakitoches."²² When Rose (full name: Modeste Rosalie) married the North Carolinian William Rogers at St. Martinville in 1830, her mother was said to be "Celeste, *metisse*."²³ (No pattern of migration has been defined between Riviére aux Cannes and St. Martinville/Fausse Pointe. However, Célestine is not the only Rivière aux Cannes native to move there in that time frame. Jean Pierre Bodin of Rivière aux Cannes died in St. Martin of Tours Parish in 1805, leaving a child; Bodin's brothers Jean Laurent and Nicolas were married to daughters of the Natives Pierre *dit* Capitaine and Madeleine, who were inventoried with Dorothée and her family as LeCourt slaves in 1778.)²⁴
- 6. Jacques Ambrose "Jacquitte" LeComte, b. 25 May 1783; died 24 November 1813. He eloped to Natchez, Mississippi, with Marie Silvie Brosset (French Créole), where they were married in a civil ceremony on 23 June 1808.²⁵ Both died in an 1813 epidemic leaving two sons. One died young. The surviving son lived as white and wed three white wives, including the great-great-granddaughter of Natchitoches' founder, Louis Juchereau de St. Denis.²⁶
- 7. Marie Thérèse LeComte, baptized with Jacques, was possibly his twin;²⁷ married Louis Metoyer, fmc, son of Claude Thomas Pierre Metoyer (French) and Marie Thérèse Coincoin (Black Créole). Thérèse is last found on record on 30 January 1841 when, as Louis' widow, she donated five arpents of land to Louis' natural son by an enslaved woman named Rosalie, "for the amity she bore him." In that donation she reserved the buildings thereon, during her lifetime, for the use of "Marie Thérèse, widow of Augustin Cloutier, fmc." (Louis's natural daughter by Madeleine Grappe).²⁸ Thérèse's Native status was subsumed into her husband's African-American status.

RESEARCH NOTES

29 DECEMBER 1775

Baptism of **Dorothea**, aged about one year, slave of El Cour [Louis Matthias Le Court de Presle]. Godparents: Mr. Athanasio de Mézières (s) and Modesta Roujot.²⁹

Baptism of **Maria Susana**, aged about four years, slave of El Cour. Godparents: Luis el Cour [Le Court] and Maria el Cour.³⁰

COMMENT:

In the early 1760s, Lt. Louis Mathias Le Court de Presle was appointed the tutor (financial guardian) of the minor Louis Monet, the man who would be Dorothea's father.³¹ At LeCourt's death in 1783, Louis Monet bought his land. LeCourt's previously enslaved Native women who were not married, but were encumbered with children, stayed with the land.³²

Curiously, Dorothée is not named for her godmother or any member of the godfather's family, as was the most-common practice in her place and time. In contrast, her half-sister Dorothée, *mulâtre*, was godchild of Dorothée Peraut.

20 APRIL 1778

Succession of Marie Jeanne Leroy, wife of LeCourt. Inventory of slaves includes the following:

26 DECEMBER 1778

Baptism of **Rosalia**, aged about two years, slave of Le Court. Godparents: Luis Anty (s) and Marie Catalina Gallien.³⁴

COMMENT:

Rosalie's land claim with the U.S. government identifies her as "Rosalie **Rachal**, wife of Louis Guillory.³⁵ Given the location of her birth, her father was likely one of the sons of LeCourt's neighbor and brother-in-law, Louis Rachal.

17 APRIL 1781

Baptism of Maria Célestine, endoyé, a slave of Le Court and daughter of Teresa, an Indian.³⁶

COMMENT:

The 1807 baptismal record of Pierre O'Reilly, son of Célestine (aka Céleste), identifies his mother as a *métive* from "Nakitoches," daughter of "Ambroise LeComte and Marie —."³⁷

20 DECEMBER 1783

Baptism of a slave child [Jacques Ambroise], born May 25, son of Theresa, slave of Mr. LeCourt, and a father unknown. Godparents: Pedro and Magdalena, slaves of Le Court.³⁸

COMMENT:

This child should be Thérèse's son **Jacques Ambroise LeComte**, son of Ambroise LeComte. On 1 November 1795, as "Jacques Lecomte" he was godfather to Marie Barbe [LeCourt], daughter of Marie Ursule, "a free *métive*,"³⁹ by Barthelemy LeCourt, son of the late Louis Mathias LeCourt de Presle who owned Jacques' mother.

Pierre *dit* Capitaine and Madeleine were a married couple, both Native Americans, enslaved by LeCourt. See 1778 inventory of Jeanne LeRoy, above. After LeCourt's death, they removed to upper Riviére aux Cannes where Capitaine eventually bought a small tract of land.⁴⁰

Baptism of **Maria Theresa**, daughter of Theresa, slave of Mr. LeCourt, and of a father unknown. Godparents: François Langlois and Maria Nicolosa Langlois."⁴¹

COMMENT:

- No birth date is given for the baptism of Marie Thérèse ("Maria Theresa" in the Spanishlanguage baptismal record above).
- Marie Thérèse's surname, LeComte, appears in numerous later records of the parish—for example: Marie Thérèse LeComte, Widow Louis Metoyer to Théophile Metoyer (Donations Book 30: 52).

6 FEBRUARY 1793

Baptism of **Dorotea**, born 26 December 1792, *Negritte*, father unknown, property of Pedro Derbanne. Godparents: Manuel Bartolome Rachal and **Dorotea Monet**.⁴²

COMMENT:

This is the earliest reference I've found for Dorothée's use of a surname.

The child baptized here is the enslaved child inherited by Pierre Derbanne's son Joseph,⁴³ swapped by him to his brother Manuel in 1805,⁴⁴ sold by Manuel to Augustin Metoye, fmc, in 1810,⁴⁵ then manumitted by Augustin on 11 November 1814.⁴⁶ As **Dorothée Boisdoré**, she married Joseph LaVigne, fmc, by contract dated 7 December 1814.⁴⁷

7 FEBRUARY 1798

Baptism of Marie Guillari, aged four months, legitimate daughter of Louis Guillari, Indian of the Aidaie nation, and **Rosalie**, a free *metive*. Grandparents: unknown. Godparents: Manuel Derbane and **Dorothée**, a free *métive* living at this post.⁴⁸

7 APRIL 1798

Land sale. "Before Commandant Felix Trudeau and assisting witnesses François Dubois and Paul Marcollay, appeared **Dorothé**, a *métive*, the **natural daughter of Louis Monet**," who sells to Sieur Pierre Joseph Maës, a citizen of this district, a tract of land situated at a place called "the Bluffs" about 25 leagues [75 miles] from the town of Natchitoches, consisting of ten arpents on each bank of Red River. This land belongs to **Dorothé** by concession dated 1796. [Signed] Dorothé (X, her mark), Dubois, Maës, Paul Marcollay, Felix Trudeau.⁴⁹

18 OCTOBER 1799

ST. FRANÇOIS CHURCH

Baptism [at home of Mr. Monet] of **Marie Françoise**, aged seven months, *mulâtresse* daughter of Marie Louise, *mulâtresse* slave of Mr. Monet, and a father unknown. Godparents: **Jacques Lecomte** and **Dorothée**.⁵⁰

COMMENT:

Given that the godfather serving with this Dorothée was Jacques Lecomte, half-brother of the *métive* Dorothée, it is likely that the *métive* Dorothée was the godmother above. The infant's mother was Coincoin's granddaughter, Marie Louise LeComte, born 26 November 1781 to Coincoin's daughter Françoise by Ambroise LeComte.⁵¹ The 1829 church blessing of Marie Louise's son Louis Monet [Jr.], fmc, identifies his mother as Marie Louise *LeComte.*⁵² That name appears again for her in the document by which her son Louis Monet Jr. manumitted her.⁵³

Baptism, at home of Mr. Monet, with permission of Monsignor Leveque, of a four-day-old infant named **Theotise**, *negresse* daughter of Marie Joseph, *negresse* slave of Mr. Monet, and a father unknown. Godparents: **Jean Baptiste Baltasar**, a free *mulâtre*, and Marie Louise, a free *mulâtresse*.⁵⁴

COMMENT:

This "free mulâtresse Marie Louise," has not been identified.

Baptism in the home of Mr. Monet, with permission of Msgr. Leveque, of an infant named **Jeanne**, born April 20, 1799, the *negresse* daughter of Susanne, a slave of deceased Martineau. Godparents: Joseph Bissonet and **Dorothée.**⁵⁵

Baptism at home of Mr. Monet, with permission of Monsignor Leveque, of Marie Thérèse, born 20 August, *negresse* daughter of Françoise, slave of Mr. Monet, and a father unknown. Godparents: Simeon Rachal and **Dorothée.**⁵⁶

COMMENT:

This child is the granddaughter of Marie Thérèse Coincoin through her daughter Françoise, who was illegally sold away to Jean Baptiste Dupré when she was a child.

4 DECEMBER 1803

Baptism of twins born 5 February 1801 in this post, daughters of **Dorothée**, **Indian of the Canneci nation**, and of a father unknown. Godparents of **Marie Louise Adeline**: Louis Monet and Marie Louise LeComte, represented by Pierre Joseph Maës [French] and Marie Genéviève Agathe Maës [French Créole]. Godparents of **Marie Louise Adelaide**: Same.

Baptism of **Louis**, b. February 1803 in this post, son of **Dorothée**, **Indian of the Canneci nation**, and of a father unknown. Godparents: Nicolas Martin [French] and Marie Louise Clement [unidentified].⁵⁷

17 OCTOBER 1805

Baptism at *Les Ecords* home of Widow Monet, of an Indian born 6 July in this post, [Marie Thérèse Rosalie], daughter of Dorothée, Indian of the Canneci nation, and a father unknown. Godparents:

Jacques [Jacques Ambrose LeComte], *metif quarteron*, and Marie Archange, Indian of the Canneci nation.⁵⁸

COMMENT:

Marie Archange's parentage has not been determined.

27 FEBRUARY 1806

Pierre Joseph Maës sells to **Louis Lambre**, both habitants of this post, in presence of Mr. **Joseph Tauzin** and **André Rambin**, 5 arpents of land on each bank of the River at **Rivière aux Cannes** about 22 leagues [about 66 miles] from the fort in descending [a crude description here of survey lines] adjoining Sr. **Athanas Dupré**; and on lower by lands of the seller. Land formerly part of a large grant in 1798 to **Dorothé Monet**, *métive libre*. Signed: And. Rambin, Jh. Tauzin, Louis Lambre, and "by order *du mon père*, Maës *fils."* || 20 July 1807, Lambre appears before John C. Carr to say that he cannot comply with the terms of the sale and returns the land.⁵⁹

COMMENT:

This land is in the Les Ecores District, T6N R4W, near the current Natchitoches-Rapides line where Cane River and Red River (former Rigolet de Bon Dieu) come together.

Maës, the former post surveyor, had gone blind; hence, his document was executed by his son.

23 DECEMBER 1806

"Dorothée Monet claims sixty superficial Acres of Land on the left bank of Red River in descending in the County of Natchitoches, by virtue of Order of Survey bearing date 4th July 1798, signed by Manuel Gayozo de Lemos, by virtue of having resided on & cultivated the same agreeably to the Spanish Laws. For Dorothee Monet [by] Alexis Cloutier (x). Natchitoches Decr. 23 1806."⁶⁰

COMMENT:

In December 1806, the United States General Land Office set up a land board at Natchitoches and required all landholders to appear before the board and submit proofs of their legal right to the lands they "claimed" to own—whether by French or Spanish title or by occupancy after the American regime took over Louisiana in December 1803. Most of the "claims" would be adjudicated and titles issued within the next decade. Some few extended for several decades thereafter.

20 JULY 1807

Louis Lambre appears before John C. Carr to say that he cannot comply with the terms of the purchase he executed 27 February 1806 with **Pierre Joseph Maës** for 5 arpents of land on each bank of the river at Rivière aux Cannes, formerly part of the 1798 grant to **Dorothé Monet**, *métive*, about 22 leagues from the post. He has returned the land.⁶¹

10 APRIL 1809

Dorothé Monnet sells to Mr. **James Porter** a portion of her land on Red River, 25 arpents of frontage, with whatever depth it carries. The land is bounded on the upper by Sr. James Porter and on the lower by the seller. 805 piasters. Witnesses: P. Bossier, Antoine Coindet.⁶²

5 AUGUST 1809

Separation agreement between James F. Porter and Mrs. James F. Porter, née Marie Louise Lecomte. Whereas Mrs. Porter filed for separation on 3 August [present year] and on 4 August a decree of separation was issued ... the said Marie Louise Lecomte promises

- to pay all the debts contracted by James F. Porter during their marriage and cohabitation, of whatever nature, provided they do not exceed the sum of \$2,600.
- to convey to the said James F. Porter all rights to a tract of land of 15 arpents frontage on Red River in the parish of Natchitoches, at the place commonly called Les Ecores LeCour i.e., LeCourt's Bluffs], being part of a tract of land purchased by Porter from Dorothée Monet by deed dated 10 April 1809. This land is to be laid off and divided from the lower part of the said tract.
- to quit all claims to a Negro boy named **Tennessee** purchased by Porter from H. N. Grayham for the price of \$412.
- to convey and deliver to the said Porter at his first demand one black American-bred mare purchased by Porter from Mr. Browning of Georgia, together with her colt, also one mare purchased by Porter from the judicial sale of the property of Madame Bon Dieu, deceased, and two cows and calves out of their common stock.

Porter himself promises

- at first demand of Marie Louise LeComte, to deliver to the parish judge all papers, conveyances, etc., that relate to any property purchased by him during coverture [i.e., the period in which Marie Louise, as his wife, had no legal rights of her own], except those relating to the property covered by this agreement.
- he will not hold the said Marie Louise LeComte responsible for any debts contracted by him except up to the amount of \$2,600.
- to quit all claims entirely to other property of Marie Louise LeComte, so that she can enjoy all rights as though their marriage had not existed.

To guarantee their performance of the above both parties mortgage fully all the property "above designated."⁶³

20 APRIL 1809

Combined successions of Jean Pierre Cloutier and his widow Marie remarried to Jean Louis Hopok.

Due to **Dorothée Monet** (x), for having wet nursed the new infant born of deceased Madame Jn. Pierre Cloutier and having provided a servant during 15 months at \$16.66 2/3 per month: \$25.00.

Personally appeared before me **Dorotée Monette** and made oath that the above account as it stands stated is just and true. [Signed] Jas. F. Porter, 20 April 1809.⁶⁴

COMMENT:

Cloutier's land lay next door to the French-Indian Dorothée, on her on upper side.

This succession file also has bills submitted by two Natives formerly enslaved by LeCourt: (1) Nicolas Baudin's wife, the daughter of Pierre *dit* Capitaine and Madeleine; and (2) Louison, the mother-in-law of Pierre Césaire Brosset.

19 DECEMBER 1809

Baptism of **Marie Céline Rachal**, child aged two and one-half years, daughter of Etiéne Rachal and **Dorothé Monet**. Godparents: Jacques St. André [French Canadian] and Adelaïde Bricou [his wife].⁶⁵

29 DECEMBER 1809

Baptism of Marie Susanne Guillerie, child of four years, legitimate daughter of Louis Guillerie, Indian, and Rosalie, Indian. Godparents: Jn. Baptiste [possibly Jean Baptiste Balthasar] and Marie Louise Adele [daughter of Dorothée].⁶⁶

19 NOVEMBER 1810

Dorothée Monette of parish of Natchitoches sells to **Sr. Étienne Rachal**, citizen of the parish of Natchitoches, a tract of land "situated below the bluffs of **Dame Widow Monette**," containing 10 arpents of frontage with whatever depth it has, lying on right side of river. The land on the upper boundary belongs to the seller; the land on the lower belongs to Louis Guillorie. The seller derives her title from a concession dated 4 June 1798. Acquirer well knows the property. Price: \$300.⁶⁷

Succession of "**Jacques Ambroise** [half-brother of Dorothée] and **Silvie Brosset** his [French Créole] wife." Louis Derbanne, Justice of the Peace for Rivière aux Cannes, acting under order of the parish judge, has gone to the domicile of the deceased Jacques Ambroise who died intestate on 24 November last, to make the inventory of the deceased Jacques Ambroise and deceased Silvie Brosset his wife. Present were Sieurs Pre. Brosset, grandfather of the two legitimate minors named Valcourt and Tranquillin, and witnesses Pre Charuau and Antoine Coindet. COMMENT:

Surrounding plats in this file place her adjacent to "Representatives of Marie Salvant Cloutier" i.e., widow of Jean Pierre Cloutier who married Jean Louis Hopock. This suggests that the Dorothée Monet mentioned in the 1809 Hopock-Cloutier succession record was this *métive* Dorothée, rather than her half-African half-sister Dorothée Monet who, as a free woman, went back to the Grand Coast to live.

Register pursuant to the acts of Congress, entitled 'An act giving further time for registering claims to land in the western district of the Territory of Orleans,' passed the 10th March, 1812, and the act entitled 'An act giving further time for registering the claims to lands in the eastern and western districts of the Territory of Orleans, now State of Louisiana, passed the 27th February, 1813, classing and arranging the same as follows, viz: ...

"Class No. 2, will comprise claims founded on authentic orders of survey conceded by the Spanish Government of Louisiana, which, with or without proof of occupancy, ought in the opinion of the said Register and Receiver, to be confirmed. ...

"Class No. 6, will comprise claims for lands on which settlements had been made prior to the 1st day of October, 1800; and inhabited and cultivated for three consecutive years from that date by persons over the age of twenty-one years, or the heads of families, and not claiming or holding, in their own right, any grants or concessions for other lands from the French or Spanish governments, ought to be, in the opinion of the Register and Receiver, confirmed, pursuant to the first section of the act of Congress of the 21st April, 1806, for the quantity claimed, or within the acknowledged and ascertained limits of the same, not exceeding one mile square, or six hundred and forty acres. ...

"Class No. 7, will comprise claims founded on occupancy subsequent to the 1st of October, 1800, and previous to the 12th day of April, 1814; and claims founded on occupancy, commenced previous to the said 1st day of October, by persons holding, or having held, other lands in their own names in Louisiana under French or Spanish grants or concessions, and which claims do not come within the purview of classes Nos. 5 or 6, ought **not** in the opinion of the said Register and Receiver, to be confirmed, the right of pre-emption to the extent of one hundred and sixty acres (a quarter of a section) being secured to the settler by an act of Congress passed the 12th of April, 1814. ...

"Class No. 9, will comprise claims for land occupied as vacheries; and whether with or without evidence of occupancy, ought not, in the opinion of the Register and Receiver, to be confirmed. **See note I,** at the end of the report."⁷⁸

Class 2: "No. 39–252. **Louis Metoyer** claims four hundred superficial arpents of land, viz: five arpents front, by forty deep, each side of Red river, in the county of Natchitoches, bounded above by land of John Baptiste Dearbonne, and below by that of Charles Duret, claimed under an order of survey in favor of **Louis Monet** for twenty arpents by forty, each side of the river, dated 28th of May, 1788, and signed by Estevan Miro, then Governor of Louisiana. Accompanying the notice is the order of survey, and a certified copy of a deed of sale from J. B. Tessier, alias Lavigne, to the claimant, dated the 17th of January, 1812; and plat of survey by Joseph Irwin, for 266.50 acres. The evidence of Louis Dearbonne, taken the 9th of October, 1812, states that J. B. Tessier resided on and cultivated the land eighteen years ago, and has continued to inhabit and cultivate the same until he sold to the claimant."⁷⁹

Class 6: "No. 338–1006. Paul Prudhomme claims six hundred and forty superficial acres of land, situated on both sides of Red river, county of Natchitoches, bounded below by land of Louis Courtesse, and above on the right bank by James Poetres's [Porter's] land, and on the left by **Dorothy Monet's** land, as is represented in a plat of survey filed; dated the 24th November 1818 [*apparently a typo for 1813*] by K. McCrummin, an authorized deputy surveyor. The evidence of **Etienne Rachal**, taken the 9th December 1813, states that the claimant, aged thirty-six years, has inhabited and cultivated the land for sixteen consecutive years preceding said date. This land is the same in quality as that of Louis Courtesse. The claimant should be limited to so much of the land as lies on the side he *inhabits.*"

COMMENT:

This land lay at Les Écores, Township 6N Range 4 West.

The immediately preceding entry addresses Louis Courtesse's land this way:

"No. 337–1005. **Louis Courtesse** claims five hundred and sixty-eight superficial acres of land on both sides of Red river, in the county of Natchitoches, bounded above by land of Paul Prudhomme, and below by land of **Maes** and **Dartigaux**, as is represented per plat of surveyor by K. McCrummin, an authorized deputy surveyor, dated the 26th February, 1813. [*Note this reads "1813," not 1818 as in the reference to Dorothée Monet*.] The evidence of **Etienne Rachal**, taken the 9th December, 1813, states that the claimant, upwards of forty years of age, has inhabited and cultivated the lands for fourteen consecutive years preceding this date. The claimant resides on and cultivates the left bank, using the right as a pastorage, and that *there is not more than three or four arpents of arable land in depth on each side of the river; the rest is swampy, and subject to inundation, and unfit for culture*. The confirmation is recommended only for that part of the claim lying on the left bank."

The evidence of Joseph Procelle, taken the 14th December, 1813, states that the claimant, widow of Baptiste (Staleau)_[,] has inhabited and cultivated the land for sixteen consecutive years preceding this date."⁸⁰

COMMENT:

"Baptiste (Staleau)" was Baptiste Valery. Apparently, the "V" at the start of his surname was misread as "St," while the ending ry was read as au.

Class 7: "No. 395–250. **Alexis Cloutier** claims three hundred and twenty superficial arpents of land, viz: four arpents front on each side of Red river, by the depth of forty, in the county of Natchitoches, bounded below by land of **Porter**, and above by that of **Jean Baltazar**. The notice is accompanied by a private deed of gift from **Louis Monet** to **Nicholas Bodin**, dated the 23d September, 1804; a deed of sale from said Bodin to claimant, dated the 4th August, 1812, for the land as claimed; and a plat of survey by D. Coleman, the 29th December, 1806, in favor of **Cola Bodin** for 52.8 acres on the right bank and 88 acres on the left. The evidence of Louis Derbanne, taken the 19th October, 1812, states that the wife of

Nicholas Bodin has inhabited and cultivated the land from 1798 until Bodin sold to the claimant. **Marie Anne Bodin** has an order of survey in her own name, on which a certificate, No. 1,730, has issued."⁸¹

COMMENT:

This land lay in the Hidden Hill neighborhood, where Louis LeCourt's consort Marie Jeanne LeRoy had received a grant.

This Nicolas "Cola" Bodin should not be confused with the French-Gypsy Nicholas Baudoin (*var*. Beaudoin) of upper Rivière aux Cannes who was married to Marie DesNeiges Malbert.⁸²

Cola Bodin, son of Jean Laurens (*var.* Juan Lorenzo) Bodin of Canada and Miguela Rosalia Cruz of Adaïs,⁸³ was married to Clemence, daughter of the Natives Pierre *dit* Capitaine and Magdeleine who had been enslaved by LeCourt. Cola's brother Juan Lorenzo Bodin was married to Capitaine and Madeleine's daughter Modeste.⁸⁴

"Jean Baltazar" of this document was Jean Baptiste Balthasar, who was freed by the 1781 will of Jean Baptiste Dupré wherein he is identified as the *griffe* son of the *Indien* Catherine.

Class 7: "No. 479.—1007. James F. Porter claims six hundred and forty superficial acres of land, on both sides of Red river, county of Natchitoches, bounded below by land of **Dorothy Monet** on the left, and P. Prudhomme on the right bank, and above by land of **widow Monet**. The notice is accompanied by a private deed of sale, dated the 26th November, 1813, from **José Mari Leando** to the claimant. The evidence of **Etienne Rachal**, taken the 9th December, 1813, states that J. M. Leando, of whom the claimant purchased, still resides on the land, and has inhabited and cultivated the same for fifteen consecutive years preceding this date. The claimant has inhabited the land for eight years past.⁸⁵

COMMENT:

The lawyer and justice of the peace, James F. Porter, was the estranged husband of "widow Monet."

Note the date given for the sale from Leando to Porter, November 181<u>3</u>. *Cf.* the recorded deed, below, dated November 181<u>6</u>.

The day given for the deed, $\underline{26}$ November, was the day that Porter filed his claim that was "accompanied by" the deed. Note that the recorded copy of the deed at the courthouse is dated $\underline{13}$ November.

"No. 481—1030. **Rosalie Rachal** [Mme. Louis Guillory] claims six hundred and forty superficial acres of land, situated on the left bank of Red river, about three leagues above the mouth of Rigolet de Bon Dieu, in the county of Natchitoches. The evidence of Joseph Procelle, taken the 14th December, 1814, states that the claimant has inhabited and cultivated the land for twelve consecutive years preceding this date."⁸⁶

Class 9: "No. 114—836. "**Louis Gillory** (a free man of color) claims six hundred and forty superficial acres of land situated on the left bank of **Rigolet de Bon Dieu**, county of Natchitoches. The evidence of Athanase Dupré, taken the 20th September, 1813, establishes the occupancy and cultivation of the land by the claimant, for thirteen consecutive years preceding this date, as a vacherie."⁸⁷

5 JULY 1816

Baptism of child of four months, natural daughter of Maria, slave of **Mda. Marie Louise LeComte.** Godparents: Louis and Marie Louis Deline **[Marie Louise Adeline,** both children of Dorothée].⁸⁸

9 NOVEMBER 1816

Paul Prudhomme sells to "Atchene Rashall" [Étienne Rachal], 640 acres on both sides of Red River "as a plat or survey represents." Witnesses Jas. F. Porter, Robert McAlpin. [The deed cites no neighbors or section-township-range numbers.]⁸⁹

10 NOVEMBER 1816

Baptism of Pierre, aged 4 months, natural son of Susanne, slave of **Dorothée Monet**. Godparents: Athanas and Pelagie, colored.⁹⁰

COMMENT:

Susanne and her children, Pierre and Louise, are inventoried as part of the estate of the *métive* Dorothée.

13 NOVEMBER 1816

Joseph Maria Leando (x) to James F. Porter. Sell of land "improved" by Leando since 1798, on both sides of river, bounded on lower by land belonging to **Doroty Monett** on left and Paul Prudhomme on right bank. On upper, it is bounded by **Mary Louis Porter, widow of Monett.** Witnesses: Robert McAlpin and "Atchen Rachal" (x).⁹¹

COMMENT:

In 1813, when Porter filed his claim for the land, as evidence of ownership he submitted this deed bearing a date in November 181<u>3.</u>

The above deed, as transcribed into the record book by Judge P D. Cailleau Lafontaine, dates the sale at 1<u>3</u> November 181<u>6</u>. The document was recorded consecutively with (and immediately after) the 9 November 1816 Prudhomme document, above, that also involved Étienne Rachal,

James F. Porter, and Robert McAlpin. Both documents apparently were brought into the courthouse for "proving" and filing by the witnesses on 18 November 1816. While transcribing into his record book, Lafontaine seems to have inattentively copied the 1813 date as 1816. He made a similar error in recording (as 1816) an 1813 deed of sale by Marie Thérèse Coincoin to Ailhaud Ste. Anne.⁹²

25 APRIL 1817

"Account. Succession of deceased Jn Ls Hopoke by Alexis Cloutier, administrator:

- 1 Note of Pierre Charrau for \$110.6
- 1 Do. of **Dorothé Monet** for \$129.00

Sums paid to

- Thérèse *Sauvagess*\$7.00
- Nicolas Gracia......19.30⁹³

COMMENT:

This "Thérèse *Sauvagess*" may be Dorothée's mother, living with her. No other full-Native Thérèse has been placed at Rivière aux Cannes.

8 AUGUST 1818

Étienne Rachal to J. B. Simon Goills, sale of 5 arpents frontage at Rivière aux Cannes, bounded on the upper by **Dorothée Monet** and on the lower by Rachal himself. \$425. Land acquired from said Dorothée Monet.⁹⁴

COMMENT:

Étienne is selling half of the land that he bought from Dorothée during their relationship. He has chose to sell the upper half—putting Goills between him and Dorothée.

"Goills" (var. Goye, Goué, and Goy) was the brother-in-law of the Bodin brothers who married Native sisters from the LeCourt plantation, Modeste and Clémence, daughters of Pierre *dit* Captaine and Magdeleine.⁹⁵

25 JUNE 1820

Baptism of **Marie Loyse**, infant aged 18 months, natural daughter of Dorothée [should be Susanne], slave of **Dorothée Monet**. Godparents: Pier and Proudans [Prudence].⁹⁶

COMMENT:

Note that the baptism occurred the same day as the baptism of the French-Indian Dorothée's first grandchild. The succession inventory of Dorothée *métive*, just one month after this, names "Louise" as the daughter of her enslaved woman *Susanne*.

Baptism of **François Ursin Rachal**, free infant born 30 December 1820, natural son of Francisco Rachal and **Marie Louise Adelle**, a free woman of color. Godparents: Etienne Rachal and Marie Louise Adeline.⁹⁷

COMMENT:

Four candidates exist for this "Francisco" (var. François) Rachal:

- François Barthelemy, who witnessed Martineau-LaBerry marriage, 178798
- François Dorcien, b. 1790 to Barthelemy and Françoise Laberry of lower Rivière aux Cannes⁹⁹
- François Celestin, b. 1800 to Barthelemy and Françoise Laberry of lower Rivière aux Cannes¹⁰⁰
- François Isaac, b. 1801 to J. B. Bmy. and Marie Pelagie Brevel of the Grand Coast¹⁰¹

The 1820 census cites "Dorcino Rachal" adjacent to the Dorothée Monet household, strongly suggesting that the male baptized as "François Dorcien," aged 30 in 1820, was the "Francisco" Rachal who was in a relationship with Dorothée's daughter.

13 JULY 1820

"Last Will & Testament of **Dorothé Monet**." (French language)

"Before me Jean Pierre Marie Dubois, inhabitant of Rivière aux Cannes, parish of Natchitoches, at the request of Dorothé Monet, I have gone to her domicile, situated at the place called *Les ecords*, parish of Natchitoches" where I found her bedridden but of sound mind, as can be observed from the certificate of Sieur Jean André Zepherin Ca[r]les, Doctor of Medicine, which certificate is attached. The testament that she made on 9 June of the current year is to be annulled. After her death, her habitation—situated at the place called *Les ecords*, is not to be sold but is to be divided in equal portions between her children. She constitutes Alexis Cloutier to be her executor and in case of his death Monsieur Antoine Condet. In case of both of their deaths, then Monsieur Pierre Cloutier. To "her **sister Rosalie, Widow Guillori,** <u>five?</u> arpents frontage, land on Red River, with the depth it is to carry ... at the place called *Les ecords*. ... [signed] Dorothi Monette (x her mark). Witnesses: Antoine Rachal, Pierre Michel, Jas. F. Porter, Jn P. M. Dubois, François Rachal (x) his mark. Alexis Moreau, Bte. Adley Junr.

"I the undersigned Jean André Zépherin Carles, Doctor of Medicine legally practicing in this state of Louisiana, declare and certify that Dorothé Monet who made this attached testament, is sound of mind. At Ecores, 13 July 1820. [Signed] Carles, D.M."

4 August 1820, will probated, on oaths of witnesses Pierre Michel, James Porter, and **Francois Rachall**. Alexis Cloutier, named by the will as executor, is confirmed.

4 August 1820, inventory of Dorothe Monet who died 22 July 1820.

• A tract of land in parish of Natchitoches on left bank of Red river **ascending**, "quantity not precisely known, being the balance remaining of a tract of land granted to the said Dorothe Monet by an order of survey issued under the Spanish government" 4 July 1798, "deducting therefrom twenty five arpens frontage now held by Dr. James F. Porter & 10 arpents frontage now held by Étienne Rachal. Estimated at \$2000.

- A negro woman slave named **Suzanne**, aged about 27 years, with her child **Pierre**, about 5, & her child **Louise**, about 3. Estimated at \$1200.
- A negro man named **Christmas** aged about 27 years. Estimated at \$900.
- A negro man named **Tom**, aged about 80 years, unserviceable.
- Articles of household furniture. Estimated at \$6.
- 1 Pair of oxen. Estimated at \$50.
- The crop of corn now growing on her plantation, containing about 10 arpents of corn. Estimated at \$100.

"There being nothing further to estimate, I have caused the inventory & estimation to be closed." [Signed] Jas. F. Porter, John Carnahan. Witnesses: Wm. Murray, François Rachal (x). Alexis Cloutier (x)

4 August 1820. Charles Slocum, parish judge, called a "meeting of the family of **Narcisse Monet**, a minor child under the age of puberty of the late **Dorothe Monette** a free woman of colour. There being but one of the relations of the said minor in the immediate neighbourhood, I served her to be called, to wit **Rosalie Louis Guillori** a free woman of colour [also] James F. Porter, John Carnahan, **François Rachal** & William Murray, neighbors." They are of the opinion that Alexis Cloutier be appointed tutor [guardian of the financial interests and assets] of the said minor, with James F. Porter as under tutor. The estate is to be disposed of according to the will. The balance of the property would be sold "on credit the one half until the month of March 1821 and the balance until the month of March 1822." [Signed]: James F. Porter, John Carnahan, Wm. Murray, François Rachal (his X mark), Rosalie Louis Guilorie (her X mark), Charles Slocum.¹⁰²

COMMENT:

The church registers of St. François variously identify Rosalie as a "metive," a "mestizo," and a "Canneci Indian."¹⁰³

4 August 1820. Appointment of tutor and undertutor. "The said Dorothe Monet left the following children (to wit) **Marie Louise Adelle Monet, Marie Louise Adeline Monet, Louis Monet, Marie Theresa Monet & Marie Celine Monet** of the age of puberty & **Narcisse Monet** under the age of puberty.

5 August 1820. Sale of succession on following terms: "the present crop of corn, cattle & house furniture payable in March next. The slaves on a credit one half payable in March next & the balance in March 1822 (to wit):

- Two Dutch ovens adjudged to François Rachal for \$5.50
- One pair of oxen to Fr. Rachal [for] \$56.00
- One field of Corn to A. Cloutier [for] \$37.00
- One man slave named Christmas to Jn Bte Rachal Pierre Rach [sic] \$1260.00
- One Negro woman slave named **Suzan** & her two children named **Pierre** & **Louise** to **John Louis Delouche** [for] \$1250

The heirs, who divided the land among them, were left with a balance of \$1840.76^{1/106}

14 JULY 1824

"Monsieur Louis Monette," free man of color, gives his quittance [release] to "Monsieur Alexis Cloutier," acknowledging that he has received his share of the estate of his deceased mother, "Mademoiselle Dorothée Monette," before Cloutierville notary, Jean Pierre Marie Dubois. Both parties X'd their names on the release.¹⁰⁷

COMMENT:

Louis Monet appears to have had an informal union with a woman named Orezitte Jacques, by whom they had four or possibly five children, baptized as follows:

"No. 109. Louis Constantin Monète, natural son of Louis Monète and Orézitte Jacque, b. 28 ay 1825, bt. 24 Nov. 1831, by Blanc. Sponsors: Simeon Rachal and Marie Thérèse."

"No. 110. Marie Eléonore Monete, natural daughter of Louis Monete and Orezitte Jacque, b. 15 Mar. 1828, bt. 24 Nov. 1831, by Blanc. Sponsors: Joseph Derbanne and Marie Elizabette Derbanne, all inhabitants of Natchitoches Parish."

"No. 111. Marie Zoé Monète, natural daughter of Louis Monète and Orezitte Jacque, b. 3 June 1829, bt. 24 Nov. 1831, by Blanc. Sponsors: Jean Pierre Cloutier and Marie Tranquilline LaCourt, all inhabitants of Natchitoches Parish.

"No. 112. Marie Théotis Monete, natural daughter of Louis Monete and Orezitte Jacque, b. 3 June 1830, bt. 24 Nov. 1831, by Blanc. Sponsors: Emanuel Hernandes and Marie Adéline Gallien, all inhabitants of Natchitoches Parish."

"No. 117. Marie Joseph Orezitte, natural daughter of Marie Orezitte, b. 19 Mar. 1830, bt. 24 Nov. 1831 by Blanc. Sponsors: Emanuel Hernandes and Marie Adélayde, all residing in Natchitoches Parish."¹⁰⁸

Note that all were baptized on the same day. On the preceding day, Fr. Blanc baptized a child of Silvester Rachal and another of André St. André, residents of lower Rivière aux Cannes (T6N R4W). On 16 November, Fr. Blanc had been a few miles below, in Rapides parish, where he baptized An Apalache Indian child, an Opelousas Indian child, and several children for the intermarried Gillard and LaCour families.

The location of this Louis Monette and Orezitte Jacques suggests they are on Dorothée Monet's land, adjacent to the St. Andrés. The records of their neighbor Jacques St. André should be studied for possible origins of Orezitte.

The Marie Adelayde of entry 117 *might* be Louis Monet's sister Marie Louise Adelaïde, aka Adelle.

The same volume of baptisms offers one other item of interest—a baptism occurring on the same day as baptisms for several of the families above:

"No. 29. Philbert Robles, legitimate son of José Marie Robles and Marie Oresille Jacques, b. 15 Apr. 1835, bt. 13 Apr. 1836, by E. D'Hauw. Sponsors: Joseph Derbanne and Marie Arsène Derbanne."¹⁰⁹

25 AUGUST 1830

ST. FRANÇOIS

Baptism of **Florentine** born October 1822, natural daughter of **Adel Dorothé** and a father unknown. Godparents: Joseph Fçois. Martines and Marie Florentine de Porcuna, all residents of the parish of Natchitoches.¹¹⁰

2 OCTOBER 1834

ST. FRANÇOIS

Baptism of Josse Mauritio Vasquez, aged 2 years, son of Manuel Vasquez and Marie Louise Moneta. Godparents: Ventura Guerra and Maria Andrea Flores.¹¹¹

COMMENT:

This Marie Louise "Moneta" would appear to be either Marie Louise Adele or her twin Marie Louise Adeline.

ST. FRANÇOIS

Baptism of child born 20 February 1838, daughter of Jean Bte. Clemente Cide and Adele Rachal, his wife. Godparents: Benigne Martina and his wife Josephine Couti.¹¹²

COMMENT:

This "Adele Rachal" would be Dorothée's eldest daughter, a twin to Adaline. Note that no color is applied to her in this document.

SHARING POLICY
