SUBJECT: Parentage of **Solomon D. Sessums** (c1819–aft.1870), Son of Jacob Sessums (c1777–c1856)

& Penny Fisher (c1780–c1845): A Proof Summary

No known document provides direct evidence (an explicit statement of fact) regarding Solomon Sessums's parentage. That connection is proved beyond reasonable doubt by a body of indirect evidence placing Solomon in the middle of one Sessums family cluster in both Mississippi and Texas—specifically, the family of Jacob Sessums and wife Penny Fisher. The most-relevant points are these:

- 1840 U.S. census, Newton County, MS: Jacob "Sessions" household consisted of 1
 - o 1 white male 60–69 [Jacob]
 - 1 white female 50–59 [Penny]
 - o 1 white male 20–29 [Solomon's age]
 - 1 white male 15–19 [Jacob Jr.'s age]
 - 1 white male 10–14 [the age of Reuben Fisher Sessums, for whom direct evidence identifies him as son of Jacob Sessums and Penny Fisher]²
- 1840 tax roll, Newton Co., MS., assessed the unmarried Solomon "Sessoms" a poll, consecutive with Thomas "Sessoms" [his older, landowning brother.]³ Direct evidence exists to identify Thomas as the son of Jacob Sessums and Penny Fisher.⁴
- 1847 Panola Co., TX, tax roll, Solomon Sessoms is taxed one poll consecutive with Jacob Sessums.

- 1849 Panola Co., Tex., tax roll, Solomon was taxed for a poll and cattle, **consecutive with the landowning "R. F. Sessom."** Reuben Fisher Sessums, as son of Jacob and Penny (Fisher) Sessums, is proved with direct evidence.⁷
- 1850 U.S. census, Panola Co., Tex., Solomon "Sesom," 33, b. Mississippi, living adjacent to Reuben "Sessoms," 25, who made his home with their widowed sister Charity "Cortney."
