Note that Southey named his first son John (his grandfather's name) and his second son Thomas (his father's name), both New Testament names. By extrapolation, the third and fourth sons (who carried the Old Testament names Elijah and Reuben) may well be named for Phoebe's

- 2. THOMAS FISHER, b. *c*1776, was deeded land by his father in 1797;¹⁴ was still alive in December 1819 when brother John made his will.¹⁵
- REUBEN FISHER, b. c1778, received his first grant in 1799;¹⁶ moved to adjacent Bladen County by 1805;¹⁷ allegedly married c1801 Margaret Streety, daughter of William T. Streety and Elizabeth Jessup; died, allegedly in Bladen in 1828.¹⁸
- PENNY FISHER, b. *c*1780, Duplin County, North Carolina;¹⁹ married *c*1796, Sampson County, NC, Jacob Sessums;²⁰ moved 1808–10, Christian Co., KY; moved by 1818 to Lawrence Co., MS;²¹ died 1841–48, likely in Mississippi before Jacob's migration to Texas.²²
- 5. ELIJAH FISHER, b. c1785; first on record, 1807 settlement of Southey's estate.²³ Allegedly wed c1805 in Duplin, Elizabeth Dees, daughter of Sampson Dees and Elizabeth Williams.²⁴ By 1809 he moved to Christian Co., KY,²⁵ and by 1819 followed the Sessums-Williams clan to Lawrence Co., MS.²⁶ By 1828 he had relocated in Hinds Co., MS,²⁷ where his will was probated in 1839.²⁸

PARENTAGE & ORIGIN

No one document identifies a person. People are not born with a preassigned number, after which all pieces of information are keyed to each person's number. Identity and kinship are proved or disproved by the whole *body* of evidence we accumulate for a person, not by any single document. Identity and kinship are determined by a person's actions and associations, habits and haunts, occupations and ownerships.

Therefore, before we can reliably identify a person and their parentage, we must do three things:

- Identify, locate, and use all known records for the person's time and place.
- Gather all details from every document, with no detail being too trivial to use.
- Place our person into a web of associates whose records must also be mined for clues to origin and kin.

This paper documents the pursuit of these three goals for Southey Fisher. The body of evidence assembled here (and summarized under TIME LINE) tracks Southey through fifty records and points clearly to his origin and parentage.

Associates & Their Origin:

When Southey settled in Duplin (later Sampson) County, North Carolina, about 1770, he chose a neighborhood heavily populated by migrants from Virginia's Eastern Shore—specifically, Old Accomac and its offshoot, Northampton.³⁰ Those Duplin families (chiefly, Benthall, Grice, Hall, Hudson/Hutson, Lucas, Parker, Scarborough, and Turlington, had been in Accomack and Northampton since the 1600s—as had the Fishers. The immigrant John Fisher first appeared in a court deposition in 1634. After his death in the winter of 1639–40, his widow married Richard *Bailey*.³¹ Across the next century and a half, the Baileys, Benthalls, Grices, and Lucases in particular intermarried with the Fishers of Accomac and Northampton in numerous ways.³²

The name *Southey*, as a given name, is also rooted in Old Accomac. Henry Southey of Somerset, England, died in James City Shire in 1622, leaving considerable wealth. His daughter Anne wed Nathaniel Littleton, from an armorial family in Shropshire, and settled with him at Accomac where he served as chief magistrate, a member of the House of Burgesses, and a member of the governor's Executive Council. Their second-born son was the first there to carry the given name Southey.³³ The name then spread not only

among descendants but also among other settlers who curried favor with those in power by naming their children after them. The use of a family surname as a male's sole given name was, in fact, strikingly common in Accomack and Northampton; and the given name Southey, wherever found in early America, is usually traceable back to an Accomack-Northampton family

In addition to Southey, the contemporary records of Duplin and Sampson document the presence of two other contemporary Fishers:

- Solomon Fisher made his first appearance in Duplin on 17–18 April 1767, entering two tracts of land on the east and northeast side of Little Coharie; both tracts were surveyed on 2 March 1768.³⁴ He did not stay to complete the title. In 1779 and 1781, he entered two tracts of land in Surry County, North Carolina,³⁵ and never appeared thereafter in Duplin or Sampson.
- Bailey Fisher made his first appearance of record in Duplin on 25 November 1771 when land was patented to him on the Great Coharie³⁶ The surviving paperwork does not reveal when he applied for the land, but patents in this era usually were issued two to four years after the land was entered. When, soon after the patent, Bailey sold part of his land to Southey Fisher's neighbor Fleet Cooper, that deed identified him as "Baily Fisher, bricklayer."³⁷ That occupational label provides the link needed to identify Bailey's origins and parents—and points to the identity of Solomon Fisher as well.

Bailey & Solomon's Parents:

On 26 May 1747, in Accomack, an administrator's account was filed for the estate of the deceased planter **John Fisher**. The accounting named heirs and other kinsmen/neighbors who were paid from the estate:

Total: 53 pounds, [illegible shillings] 5½ pence. Household goods and livestockare itemized. No enslaved people or servants are mentioned. Son Solomon inherited the family Bible. Appraisers: William Beavans, William Andrews.³⁸

Thomas Fisher, the eldest son, inherited the land of his father John Fisher, under the prevailing law of primogeniture (all land to eldest son). Over the next two decades, he sold off parts of it and bought other

neighboring pieces as his fortunes ebbed and flowed, leaving a trail of records.³⁹ His two youngest brothers, still minors, were apprenticed: Spencer, on 31 August 1756, was bound to their neighbor James Johnson to learn the trade of *bricklayer*. The following month, **"Bayly" Fisher (orphan of John) was also bound to Johnson to also learn the bricklaying trade**.⁴⁰

The indenture was problematic. Shortly before the widowed Elizabeth died in 1757, she and her daughter Elizabeth Jr., along with Solomon Fisher, were indicted on a charge of "rescuing" two runaway indentured servants belonging to James Johnson. Those servants were not named; by implication they were Elizabeth's two sons Bailey and Spencer. To guarantee both women's "good behavior" and their appearance at the next court session, Thomas Fisher appeared before the magistrates on 26 April 1757 and posted a bond of £5; Solomon posted the same for himself. At the May term, the Fishers were discharged from their behavior bonds, with Thomas Fisher serving as security. ⁴¹

By August, the children of John and Elizabeth Fisher were in court again, opening their mother's estate:

30 August 1757 **"Spencer Fisher** Orphan to **Elizth Fisher** his Guardⁿ. Dr. To [debited for the sum he owed for] 10 years Board & finding him Cloaths £03.15.11 Cr. By his part of John Fishers Est. £03.15.11

"Baily Fisher Orphan to Elizth his Guardⁿ
Dr. To 10 years Board & finding him Cloaths £03.15.11
Cr. By his part of John Fishers Est. £03.15.11

"Solomon Fisher Orphan to Elizth Fisher his Guardn Dr. To 10 years Board & finding him Cloaths £03.15.11 Cr. By his part of **John Fishers Est**. £03.15.11

"We the Subscribers have Audited and Settled the Acco^t of the Guardianship of **Solomon Fisher** Orphan as above stated. **William Beavans, Solomon Bird**."

"At a Court held for Accomack County July 30th 1759 The above Audit & Settlement of Elizth Fishers Guardianship of **Spencer Fisher, Baily Fisher** and **Solomon Fisher** being return^d by William Beavans & Solomon Bird Pursuant to an Order of Court are Admitted to Record."⁴²

That December, Thomas Fisher, as administrator of his mother's estate, attested the appraisal made by Wiliam Beavens, Solomon Bird, and Nathaniel Bird of his mother's meager belongings: *1 feather bed [mattress], 1 bedstead matt & cord, 1 old blanket & "sheat," 1 candlestick, 1 glass tumbler, 1 pewter dish & spoon, 1 wooden bowl, 1 old chest, 3 chairs, " 1 old lot of books," and a small amount of animals, etc.⁴³ Elizabeth's young-adult children were left in desperate straits. In February 1760, Elizabeth Jr. and Solomon were charged with stealing a hog from their neighbor George Johnson; and Elizabeth was also accused of illegally trading with a Negro enslaved by William Mason. Charges would be dropped against Elizabeth; Solomon shouldered the blame. In July 1760, he was found guilty and fined £10. Because he could not pay it, he "immeditely received 25 lashes well laid on [and] was committed to the sheriff's custody (at 9 lbs.*

tobacco [per] day) till paying the costs of his prosecution: 2027 lbs. tobacco." A court note of 30 September 1760 reported that Solomon was still in custody.⁴⁴ Neither Solomon Fisher nor his younger brother Bailey have been found in Accomack records past that point.

Thomas Fisher, the eldest brother of Solomon and Bailey, remained in Accomack with his **wife Susannah Armitrader**,⁴⁵ and left a trail of records by which his life can be reconstructed. The T mark he used to sign his documents also helps to distinguish him from other Thomas Fishers—as does the location of his lands and his cluster of friends and neighbors.⁴⁶ Thomas served as witnesses to wills and deeds and as executor for other estates,⁴⁷ bought and sold additional lands,⁴⁸ sued individuals who owed him money and was sued for his own debts,⁴⁹ bought goods at the estate sales of his kinsmen and neighbors,⁵⁰ served as road overseer and did jury duty. He is last found on record 27 July 1779, when (as "Thomas Fisher Senr.") he purchased "the acre of Land where the old warehouse stood on Gilford Creek" from William Andrews and his wife Susanah."⁵¹ Five years later, part of his land was sold by his son Thomas Jr., with the widowed Susanna witnessing the document.⁵² Susannah would survive at least another decade; the last reference found to her is her aged father's will, drawn in 1794.⁵³

Amid the litany of activities that form the framework of Thomas's life, one additional document places Southey Fisher in this family. On 30 January 1769 (see that date under "RESEARCH NOTES") the Accomack justices approved a settlement of the estate of Thomas Lucas, neighbor and first cousin of Thomas Fisher. Fifteen payments were made to individuals who were not heirs. The first four payments were

This payment, made to Southy himself, rather than to his father, indicates that he was legally an adult. Apparently he had not held that status long. A page-by-page reading of Accomack's surviving records for that era reveals no earlier reference to him and no subsequent reference. Within months he would be in Duplin County, NC, taking out land between the Little and Big Coharie, where his uncles Solomon and Bailey had already entered tracts.

Typically, surveys of this place and time seem to have occurred 12 to 18 months after the entry—in which case late 1780 would be a likely time for the entry.

COMMENT:

As Southey's first neighbor, a man he chose to settle next door to, Gabriel Homes deserves special consideration—especially as a potential relative of Southey's . Gabriels's point of origin has not been determined. He is first found on record in **Edgecombe**, from which he settled **New Hanover** > Duplin in 1750. The following provides an overview:

- Halifax Co. Deed Book 3 (1746–1750): 399–400, Hardy Homes of Edgecombe sold 150 acres to Gabriel Homes of **Edgecombe**, 150 acres on Swift Creek, 16 August 174<u>9</u>.
- Halifax Co. Deed Book 3 (1746–1750): 447–48, Gabriel Homes of New Hanover sold 150 acres on N side of swift Creek to Robert Knight of Edgecombe County. Said to be 1 January 1749, in presence of Hardy Homes, and presented to February 1749 court.
- Deed Book 2, 1752–1758 [recopied]: 118–19, "Gabriel Homes of Duplin, planter" bought land from Sampson on 26 May 1750, land said to lie on "Gabriel's Branch".
- Sampson [Duplin] Co. Deed Book 4 (1762–1771): 4–7. "Gabriel Homes, planter" bought 260 acres from John Sampson, for 65£ on 2 August 1762. On 7 August, Sampson sold 507? acres to Richard Clinton, with Gabriel Homes as witness. Homes' tract was said to begin "at a Black Jack Gum in Gabriels Branch, his old [line], Beginning Corner, Standing near his own House, running with his own line N 80 E 90 poles to a pine, his old corner, thence with his line S 10 E 184 poles to a hickory, his other corner, thence S 80 W 140 poles to a lightwood Stake, in the Marsh in Gabriel's Branch, thence ... part of a larger tract of [12,000] acres to James Hewith ... 14 January 1735, by him sold to "George Vaugn of the Kingdom of Ireland, Esquire," part of which was sold to Sampson at Sheriff's sale in 1761.

A generation earlier (1718), one Gabriel Holmes was supposedly in Norfolk County, Virginia across the bay from Northampton:

"This indenture made ye Eighteenth day of June one thousand seven hundred and eighteen between James Holmes of ye Kingdom of Ireland, brother & next heire to Gabriell Holmes, Late of ye Said Kingdom deced. [to] Moses Prescott of Norfolk County in Virginia" ... sale of 100 acres on E side of Indian Creek, adj. Thomas Davis, James Warden, etc. Witnesses: Lem Wilson, Katherine Wilson."⁵⁹

COMMENT:

"The **Battle of Moore's Creek Bridge** was a minor conflict of the American Revolutionary War fought near Wilmington (present-day Pender County), North Carolina, on February 27, 1776. The victory of the North Carolina Provincial Congress' militia force over British governor Josiah Martin's and Tristan Worsley's reinforcements at Moore's was a turning point in the war; American independence was declared less than five months later.

"Loyalist recruitment efforts in the interior of North Carolina began in earnest with news of the Battles of Lexington and Concord, and patriots in the province also began organizing for the Continental Army and militia. When word arrived in January 1776 of a planned British

Army expedition to the area, Martin ordered his militia to muster in anticipation of their arrival. Revolutionary militia and Continental units mobilized to prevent the junction, blockading several routes until the poorly armed loyalists were forced to confront them at Moore's Creek Bridge, about 18 miles (29 km) north of Wilmington.

"In a brief early-morning engagement, a charge across the bridge by sword-wielding loyalists was met by a barrage of musket and artillery fire. Two loyalist leaders were killed, another captured, and the whole force was scattered. In the following days, many loyalists were arrested, damaging further recruiting efforts. North Carolina was not militarily threatened again until 1780, and memories of the battle and its aftermath negated efforts by Charles Cornwallis to recruit loyalists in the area in 1781."⁶³

Various online trees assert that Lewis was born in Northampton or Accomack County and married **Tabitha Benthall** (Fisher kin from Accomack). The universal tree at *FamilySearch FamilyTree* presents Tabitha Benthall as the wife of Barnabas Hall of Duplin (who appears frequently in these notes as Fisher associates) and asserts that he had an alternate identity as "John Lewis Lucas."⁸⁴ *The conflicts need resolving.*

The Lucas connection is significant because (a) Southey's great-grandmother Elizabeth [—?—], as a widow of Philip³ Fisher in 1709, married William Lucas Jr., some years younger than she; and (b) Southey's grandmother Elizabeth (wife of John⁴ Fisher) appears to have been née Lucas, the younger sister of William Jr.⁸⁵





COMMENT:

Southey Fisher was exempted three years before Bailey Fisher was exempted. North Carolina tax law from 1772–1804 set the poll age for white males at "21 and over," with no maximum age stated. In 1804, the maximum age was set at 50.¹¹⁷ Prior to 1804, men usually requested exemption when they were no longer physically productive.

This Elijah Fisher would be the Elijah who first appeared on the 1782 tax roll with Bailey Fisher. I am including his records here to distinguish his activities from those of Southey's youngest son.

One Richard Clinton, in August 1762, bought land adjacent to Gabriel Homes; in 1772, Southey Fisher patented his first tract, also adjacent to Gabriel Homes.¹²²

COMMENT:

These two Williams documents were brought into court together, both were held for a year, and then someone paid to have them registered on the same day—suggesting they are all part of the same family. I am noting this because of the pairing of the names Elijah and Reuben in the same family. John Williams of Sampson Co. NC and Lawrence Co., MS, who named sons *Isaac* and *Nathan*, was the nephew of Neal Culbertson who bought land from Reuben and Elijah Fisher's mother Phoebe. John's eldest son Neal married the daughter of Elijah and Reuben Fisher's sister Penny Fisher.



Full guarantee, etc. Signed: **Elijah Fisher** his X mark; R. Crumpler, Jesse Nelms his X mark. Proved in open court May Term 1801.¹⁴⁵

COMMENT:

Cumberland adjoins Sampson on Sampson's W & NW bounds. It was created in 1754 from Bladen County.

- Reuben's Tract 1, whose origin was not stated, was granted to Reuben Fisher on 9 March 1799.
- Despite the reference to a will, none has been found and the estate was opened as an administration, rather than an executorship.

COMMENT:

The enslaved mother and child almost certainly were inherited from Penny's father.

16 [OCTOBER?] 1807

Quitclaim deed

"This indenture made this 16th Day of Dec^r 1807" from **Phoebe Wallis** to **Neill Colbreth**, for \$125 "do hereby assign all my right and title of a certain tract or parcel of land lying on the *upper side of the road* leading to Fayetteville and **Little Coharie**, by estimation 150 acres, it being in part of my right of Dower lying within the lines of **Reubin Fisher**, **my son**, which tract or parcel of land I warrant and defend," etc. Signed: Phebe Wall<u>ace</u> her x mark. Witnesses: Gabriel Holmes, Jess Parker. Proved in court November Term 1807 [*sic*]. Registered 20 December 1807.¹⁶⁶

COMMENT:

Clearly, the deed was not proved in court before it was executed by the parties. In the clerk's recorded copy, all three dates are very clearly written. "The November Term 1807" should not be in error; there was no December term of court for the deed to be presented. All things considered, the deed was likely executed in October 1807 along with the other documents below that relate to the settlement of Southey Fisher's estate between his widow and children.

In witness whereunto we have set our hands and Seals this 26th day of Oct^r 1807."

[Signed] John Fisher his mark, Thomas Fisher, Reuben Fisher, Elijah Fisher, Jacob Sessums his mark. Witness: Tho^s Owens.

November Term 1807. Then was the within Bill of Sale proven in open Court by Thomas Owens for registration. H. Holmes, CC. Registered Dec 20th 1807, Owen Holmes Regr."¹⁶⁷

COMMENT:

See the 10 June 1805 deed, above, by Reuben Fisher to Neil Culbreath, selling five tracts of land—including a tract "willed to him ... by Southey Fisher Dec'd."

In that document, Reuben excluded from the sale of the inherited land the portion on which "Phebe Wallace" was to live for the rest of her life.

Clearly, Thomas, John, and Elijah Fisher, as well as Jacob Sessum's wife Penelope, were—like Reuben—heirs of Southey Fisher whose wife and widow was Phebe.

COMMENT:

- The "writing" that appears in the column for males 45+ is indiscernible. It appears to be a "2" that is overwritten with "0" or else scratched out.
- Bailey Fisher is not enumerated as a head-of-household on this census. The data for this household is compatible with known data for Bailey and compatible with similar situations in which an aging couple has relinquished the reins of the property to an adult son.
- In 1822, when "Thomas Jr." was no longer in the county, the aged Bailey Fisher transferred property to his unmarried daughter Anna Fisher, reserving the use of the property for himself and wife until death.

COMMENT:

Griffith Crumpler's household is also missing from the 1810 census, suggesting that a neighborhood might have been missed or that pages of the return might be lost.

Thomas Wallis to **John Fisher**, for 100£, sale of 150 acres on *west side* of **Bearskin Swamp**:

Beginning at a poplar standing in the edge of Bearskin Swamp at the *mouth* of a **Juniper Branch**, then N 70 W 150 poles to a pine, thence N 20 E 160 poles to two junipers in **Shades Branch**, thence down the branch as it meanders to Bearskin Swamp, then down said swamp as it meanders to the beginning.

Signed: Thomas Wallis. Witnesses: Owen Butler his X mark, Lewis Roy, A.L.S. [or Lewis Royals]. Proved February Term 1813. Registered 22 March 1813.¹⁷⁷

COMMENT:

While Wallis' wife Phoebe is not party to this deed, she does appear in a document supposedly executed five days later, by which she appears to have given son John everything she owned. (See

Witnesses: Jared Peck, Sander Fisher, Josiah Hall.

"Sampson County, November Term 1812, Then was the within Deed of Gift proven for Registration. H. Holmes CC. Registered January 1st 1813, Owen? Holmes, Regr.¹⁷⁸

26 OCTOBER 1812

At this point I stopped reading the Sampson County court minutes. Jacob and Penny (Fisher) Sessums have been gone for six years. Penny's mother, the wife of Thomas Wallace, appears to be dead. The deeds are showing no further interaction between Wallace and her Fisher sons.

Beginning at a pine *east side* of the **Juniper**, thence N 85 E 116 poles to a black jack, thence N 5 W 240 poles to a pine, thence S 85 W 134 poles to a small pine, thence S 5 E 240 poles, thence N 85 E 18 poles to the beginning.

Said 200 acres conveyed from John Dickson to John Fisher in 1812. Full guarantee, etc. Signed John Fisher his X mark. Witnesses: Solomon Sessums, John Sessums. Proved in court November Term 117. Registered 17th December 1817. Signed: Richard Sessions. Witnesses: John Herring, James Peterson.¹⁸³

Thomas Wallis/Wallace has found not only a new wife, but also another heiress.

[In this research segment, I'm not copying metes and bounds for land transactions past 1822]. Signed: John Fisher his X mark; **Sanders Fisher**, Solomon Faircloth his X mark. Proved in open court by oath of Sanders Fisher, November Term 1829.¹⁸⁶

COMMENT:

Book 14 contained deeds from the 1805 period. Book 15 has now jumped to 1828.

Pension

Solomon "Sessoms or Sessums" and Obedience W19330¹⁸⁷

COMMENT:

Solomon serviced under "Capt. Southy Fisher," There are 71 pages in this pension file. Here, I've only pulled details to identify the file and provide the context for Southey.

Solomon Sessums was entered on the U.S. pension roll on 4 March 1831, as a Revolutionary war private for 10 months and a lieutenant for 3 months. He died 13 August 1832. (image 15489790)

COMMENT:

The affidavits in the file identify him as private, corporal, and sergeant, but not lieutenant.

Obedience Sessums, his widow, was entered on the roll on 24 March 1853, to commence 13 August 1832 and ending 17 January 1846. "Certificate of Pension issued the 24th day of March 1824." [*sic*] (image 15489797)

February Term 1837

Court of Pleas & Quarter Sessions

Before George W. Robinson, Peyton R. Parker, and Joab Johnston, Justices of the Peace, personally appeared **Obedience Sessoms**, a Sampson Co. resident, aged 74, who applies for a pension under the Act of Congress passed July 4th 1836. She is the widow of **Solomon Sessom** who was a "private & sargeant" in the militia of NC during the war. He served as follows:

- 1. "In a company of Duplin militia Infantry in the first of the year 1776 as a private and served three months, was in the battle of Moore's Creek Bridge." She knows no further detail and has no proof but "expects that she can prove that her husband was seen in the army towards the close of the war by Lot Riche Senr. of this County."
- 2. "Three months in a company of Duplin militia infantry in the Fall of 1780 as a sargeant." She does not know the other officers "as it has been so long ago that most of the Revolutionary Soldiers of her acquaintance have deceased."
- 3. "In a company of Duplin militia Infantry under *Captain Clinton* in May 1781 and served three months as a sargeant, marched to Wilmington in this tour or the ______ she thinks she understood from her husband and that he was under Col. Hen___?

"In the 2nd tour of his service he marched into South Carolina on Peedee and was there she thinks under Genl. Hanington as she has heard her Husband mention his name. And in his first tour of service when he was in the battle at Moore's Creek bridge she thinks **his Captain was Southy Fisher.** She knows that her husband was absent from home after their marriage and served two terms of three-months each and from his account suffered a great deal and was no doubt the cause of a great deal of the afflictions which he endured towards the close of his life."

"She further declares that she was married to the said **Solomon Sessoms** on the **27th January** a. d. (**1780**) ... that her husband ... died on the 16th day of August 1832 and that she has remained a widow ever since." [Signed] Obedience Sessoms her X mark.

"Sworn to and subscribed in open Court the 23rd February A. D. 1837. Thos. J. Faison Clk." (images 15489803 and 15489807).
