SUBJECT Mills-White-Witt: Montgomery County, Virginia, Tax Roll Data, 1782–1807

BACKGROUND: **Frances “Frankey” Mills** was alleged in November 1788 to be “a widow of this county” [Montgomery] when *John Abram Glymph* of Doe Creek took out a bond to marry her. His bondsman was *Milliton Atkins*, a prominent member of nearby Walker Creek Baptist Church. The marriage did not occur. In August 1792, she wed “**John White Sr.**,” with Rev. Alexander Ross of Walker Creek officiating. *Thomas Copley Jr.* served as bondsman. White family researchers, online and in print, have given various identifications for Frankey’s John White. My prior work suggests the coexistence of three John Whites in Montgomery in the 1790s:¹

- **John White**, who signed with his “S” mark, owned land on Sugar Run of Walker’s Creek, obtained from *Patrick Napier* of Amherst County. *Obediah Byas* of Amherst was also a neighbor. John used that “S” mark when he sold his three tracts of lands in October and December 1793.² He again made the “S” mark, crudely, when he posted bond to marry *Susanna Marcum*, daughter of *John Marcum* in July 1796, with Major Marcum as bondsman.³ To distinguish him from the other John Whites, I am referencing him as John “S” White.
- “**John White Sr.**,” as named on the bond he posted to marry Frankey. With Frankey, he moved to Big Springs at East River Mountain, on land surveyed in 1797 jointly for “William Preston and John White.”⁴ (See below for William Preston.) John and his apparent son Benjamin White were long-time associates of *John Toney* of Toney’s Ferry at the juncture of East and New Rivers. John’s last known appearance is the 1820 census.
- “**John White Jr.**,” who married *Nancy Copley* (sister of John Sr.’s bondsman) in January 1793. Across the years, he was also called “John White, hunter,” “John White (Hunter),” John Hunter White, John H. White, and “Jack” White. His landholdings and wife’s identity provide the data to link the various versions of his

name. An 1821 deed elevates him to “John White Seigner,” suggesting that the previous John White Sr. had died or left the county.⁵ In 1847, he drafted his will in Giles County, naming his widow Nancy and some but not all of his children.⁶

Two children have been proved for Frankey Mills, prior to her marriage to John White Sr.:

1. RACHEL MILLS, b. c1785–86.⁷ On 7 September 1790, the Montgomery County Court ordered that “a daughter of Frankey Mills” be bound out by John Preston, one of the overseers of the poor.⁸ On 3 August 1803, “Rachel Mills” appeared before the county clerk to choose **William Preston** as her guardian,⁹ a legality required because **John Bowen** was requesting a license to marry her and she was still a minor. After Preston was appointed her guardian, swearing that she was “the orphan of Francis Mills,” he gave his consent to the marriage and then served as surety for the marriage bond.¹⁰ By 1810 Rachel and John moved to Warren County, OH.¹¹
2. SAMUEL MILLS, born c1788, took out a Giles Co. bond on 29 April 1807 to marry Rachel Prince, daughter of John and Rachel Prince. That file includes the 23 April 1807 permission of his parents: “**John & Franky White**” who “both and each of us” gave permission for “our sun” to marry.¹²

Sarah “Sallie” Mills, also a lone female, surfaced in Montgomery County 30 months after Frankey’s first appearance. On 7 April 1791, **Elijah Sartain** (*var. Certain, Sartin*) of Stoney Creek—whose land was a mile or so from John Abram Glymph—took out a marriage bond to marry Sarah. The marriage return, citing 26 April 1791 as the date of marriage, was filed by the same Rev. Alexander Ross of Walker Creek Baptist Church who would wed the widow Frankey Mills to John White Sr. in 1792. In 1806, both Sarah’s and Frankey’s families were cut away into Giles. However, no interaction has been documented between the two couples. In 1815, Elijah and Sarah sold the land that Elijah inherited from his father Joel and moved to Gallia County, Ohio.

This Sarah Mills appears to have had one daughter born in the late 1780s, an Elizabeth for whom Elijah Sartain acted as bondsman when she married Archibald Chapman of Giles in 1811. That couple also settled in Gallia.¹³

A subsequent daughter born to Sarah and Elijah points to Sarah's birth family: When that daughter married in Gallia in 1816, the justice of the peace identified her as "**Lucy Tilman Sartain**" in the recorded marriage return. Most descendants believe, though direct evidence has not been found, that Lucy's mother Sarah was the daughter of **Jesse Mills of Amherst County** whose well-documented wife was **Lucy Tilman**. This Jesse Mills had a sister Sarah "Sallie" who married Thomas Watts (my ancestors) and another sister Anne who married Lewis **Witt**, cousin of Rev. Richard Whitt of Montgomery.¹⁴

TASK: Tax rolls of Montgomery and Giles are being combed in order to provide year-by-year identifications of all Millses and all Whites in Montgomery and Giles. This is an essential first step to determining the identities of Sarah, Frankey, John White, and the father(s) of Frankey's children. Known associates of all John Whites, and those of Frankey, Samuel, and Sarah Mills are included in this data extraction.

EXECUTIVE SUMMARY

The Research Notes section of this paper presents each year's tax data in its original context, with descriptive or analytical details as needed. It also adds context from other sources to help identify individuals whose names were shared by other men.

Only one male Mills can be placed in Montgomery County during the period Frankey conceived her children. No other male can be placed into Montgomery or Giles until Samuel himself emerged on the tax rolls in 1810, three years after his marriage.

Thomas Mills

This man was not taxed on the rolls believed to be dated 1782 and 1785. In 1787, he appears with a note that he had moved to North Carolina. This places him in Montgomery at the time Frankey conceived Samuel, but Frankey would not be his widow. This Thomas moved to Stokes (later Surry County, NC) where he appears to be part of a family that settled in the region several decades earlier. There he was married and had offspring.¹⁵

Their closest Y-matches, at genetic distances of 1 and 2 on a 111-marker test, are descendants of Lewis Whitt (whose father Benjamin of Albemarle was first cousin to Rev. Richard Whitt) and John Witt of Halifax Co. (another first cousin of Rev. Richard and Benjamin).

The most comprehensive Witt genealogy is David F. Whitt, *Ancestors and Descendants of William Whitt, 1775–1850* (Westminster, MD: Heritage Books, 2004). A beginning point would be the chart on p. 51.

A Miles family appears regularly on the tax rolls of the 1780s, but they were clearly not *Millses* and did not live in the New River area where the families of this study were clustered. Included among the Miles males was a John who appears to be the Revolutionary War militiaman service in Osborn’s District in 1783, whose name is written by various data extractors as Miles and Mills.

Court order

“4 April 1788. It appearing to the Court that there was no list of Tithables delivered to the Sheriff for the year 1782, 83, & 84 as the law directs so the Levies were collected from some while others were clear, whereby an Executive County Levee was found necessary to discharge the existing Claims against the County for the year 1787 which were running on Interest. It is therefore ordered that the Clerk shall make of an account Specifying the amount of the Claims against the County for the several years before mentioned & the returns of the money Collected by the Sheriff & that the Capt. of each Company should make up a List of the receipts given by the sheriffs for the Different years & present the Same to the July Court when a further order may be made.”¹⁶

COMMENT:

This court order seems to say that the so-called “enumerated articles” list attributed to “1782” Montgomery County may be a composite list retroactively compiled.

Schreiner-Yantis, working from Montgomery Co.’s Survey Book D, places the following Adkins lands:

- William Adkins, “67 acres on Grassy Creek, Carolina line. 25 Oct 1788.”¹⁷
- Champ, Hezekiah, Jacob, John, Joseph, Moses, **Parker Atkins** at “**Sinking Creek** & south side **Johns Creek Mt.** and **Salt Pond Mt.**, New River”; all on 1789 list dated 16 May.¹⁸

Sinking Creek & Salt Pond Mountain bracket the Doe, on which John Abram Glymph had land surveyed in January 1788. All are clustered near the juncture of Walkers Creek with New River, but across New River from Walkers.



Map 1


Tax District A—Montgomery County, c1787–1790²⁰

Tax District B—Montgomery County, c1787–1790²¹



Two John Whites held a legal claim for land in Montgomery County by this time:

- On 22 July 1788, one John White received a patent to 500 acres Cole River in Montgomery County, soon to be Kanawha. The land had been surveyed for John Smith on 1 August 1787 and then rights assigned to White.²³ (On 20 August 1794, John Toney patented 344 acres on Cole River, also as an assignee of John Smith.²⁴)
- On 10 November 1790, Gordon Cloyd had a tract of land surveyed, for whom one tract of adjacent land was said to be “John White’s Survey.”²⁵ White’s survey has not been found but various documents for adjacent neighbors, as well as his own sales of the land in 1793, places the land on Little Sugar Run of Walker’s Creek.

Menefees also resided in Franklin County, where John Ferguson—a landowner in Franklin, Bedford, Montgomery, and Patrick Henry—died 1789 (see that date below) leaving a Menefee tract to his grandson Samuel McCarrell (earliest known associate of William Mills-Witt of Franklin). Samuel McCarrell’s wife was a Menefee.³⁰

Considering that there are no other Glymphs taxed in the county, the parenthetical A appears to be the assessor’s manner of indicating this is the person previously taxed as “Abra^m Glimp.” This conclusion is compatible with the name of the Continental line soldier “J. Abram Glymph.”



COMMENT:

- This would seem to be John 'S' White, considering that he submitted his list on the same day as Low Brown and the day before John Markham.
- John White "Sr.," who would marry Frankey Mills in 1792, does not appear to be in the county.
- Benjamin White and John White Jr. who were frequently clustered with John Sr. also are not taxed.
- John Toney, who would be a frequent associate of John Sr. and Benjamin, is not taxed this year. (He reappears in in 1791.)
- One John White patented land on distant Cole River in the mid-1780s—part of land surveyed for John Smith. John Toney also patented a part of that John Smith land on Cole River in the same time frame. The more prosperous Toney, whose activities are chronicled in regional histories, is said to have operated one of the region's ginseng camps that were abandoned in after an Indian raid that slaughtered wives and children while the men were off at work.

Schreiner-Yantis's annotated version of this tax list tells us that

- Thomas Copley Sr.'s land, on 5 March 1787, lay on Meadow Creek of New River, with Jacob Straihley [Straley] and William Elley as adjacent neighbors.
- Thomas Copley on 2 March 1790 was in a community bounded by "Back & Neck Creeks, Sinking Run, head of Bear Spring, Walkers Creek, White Glade [and] New River."
- The land of "John White" lay adjacent to **Gordon Cloyd** on Walkers Creek, at the head of Little Sugar Run.³⁷

Note that Booker Mullins turned in his list to the assessor on the same day as the Copleys and John White. Given that the assessor "made the rounds of the county" to collect the lists, this suggests that the Copley- White-Mullins families were in the same neighborhood.

This is the first **Frame** reference I have found in the county since the 1781 marriage of David Frame's daughter to Henry Holstein.

Also in this small district:

- **White, Obediah**—who operated a stage stop in Franklin County, in close proximity to the **Mullinses, Stanleys, Prillemons, Ferguson-McCarrell, Standifers** and other associates of William Mills-Witt. White's Stage Stop in Franklin was about three miles from Booker Mullins' alleged father William. It was about four miles from Standifer's Stage Stop, the locus of Stephen Standifer who served as surety on William Mills-Witt's marriage bond in 1815.³⁸
- In 1809, White's in-law Elizabeth Pratt bore an illegitimate son, Henry Pratt, who left an account of his life saying that his father was a “De Witt.” Henry's Y-line descendants carry the same Witt Y as descendants of William Mills-Witt, with a genetic distance (GD) of 1 on the 67-marker test and a GD2 on the 111-marker test.³⁹
- **Idings and Lights**—interrelated families that were immediate neighbors of William Mills-Witt on the 1850 Floyd Co. census.

Hannah has not been identified. Several pieces of indirect evidence are relevant:

- Jeremiah Williams, who turned in his list the same day as Hannah, is later clustered with other Whites, as follows:
 - 1797, he turned in his list on the same day as **Robert White**, whose 1797 land was said to be adjacent to Randall Lucas at Salt Pond Mountain.⁴¹ In 1806, a survey of Randall Lucas's

land said that it adjoined **John White [Jr.]**. In 1812, Giles’ land entry book stated that Randall Lucas’s land adjoined **James White**.⁴² Name-coupling on both tax rolls and petitions suggests that John Jr. and James (like Benjamin) were sons of John Sr.

- 1806, Jeremiah Williams turned in his list on the same day as Benjamin, John Sr., and John Jr. White.
- The name Hannah White has been found in only one other instance—twenty-four years later. In April 1822, John White Jr. transferred 80 acres at Bear Springs to “Hannah White” for \$21.50½.⁴³ He was at that time seriously in debt. In an effort to save his property from creditors, he—on the same day that he transferred the 80 acres to Hannah—conveyed 65 acres on waters of Bear Spring and Buckeye Mountain to William White “for the good will and affection he bears toward **his son**.”⁴⁴ Unlike the deed to William, the deed to Hannah does not state a relationship. The 1810 census does not attribute a female child to his household. One possibility is that she was an unmarried sister for whom he was providing.
- A possibility also exists that “Hannah” of 1798 might be the “Susannah” who married John ‘S’ White in 1796. In 1796, John ‘S’ White appeared on the tax roll. In 1797, he was dropped (as though he had died or moved off), though his land continued to be taxed in his name. This year 1798 he is also gone and this is the only year that Hannah appears on the tax rolls of either Montgomery or Giles. *Note that she has two males 16–21 in her charge.* This suggests that John ‘S’ may have died shortly after marriage, leaving her to share their 35 acres with two sons by his first wife.

On the next year’s tax roll (1799), Hannah is dropped and two new males appear on the Montgomery tax roll: John and Arthur. If Hannah is Susannah, then the John of 1799 should not be John ‘S’ White because Montgomery County would not tax her if he were still the family head.

Weighing against this possibility (that Hannah is Susannah) is the neighborhood in which Hannah submitted her list. Others who turned in their lists that day were of the John Jr./John Sr. cluster, not John ‘S’ White.

- If Hannah is not Susannah, then the presence of two males 16–21 in her household suggests that she was a widow or unmarried mother, in her mid-30s. If she were married to a brother of Benjamin, John Jr., Robert, and James, then that brother has not been identified. If she were their unmarried sister with two teenagers, then age-wise she should be older than Benjamin who married in 1787.

On the December 1803 partition by Montgomery County men requesting a new county, we find this cluster of signers: **William Aldrige**, John Hall, Benjamin Hall, Zachariah Purdue, Larken Stowers, Thomas Hammans, **John White Jr**, George Drake, John Burgess, **William Wilburn**. By implication, the John above—like the John who was frequently coupled with John Sr.—considered himself "John Jr." The neighbors who submitted their tax rolls the same day, from 1799 through 1806, suggest that he and Arter were sons and heirs of the landowning John 'S' White. John 'S' appears to have died between 1796 (when he married Susannah Marcum) and early 1798 when "Hannah White" made a one-time appearance on the tax rolls charged with two young male tithes. When she was dropped, in 1799, Arter and the above John were added to the roll in their own names. However, the evidence that Hannah and Susannah were the same woman is ambiguous.
